Edo 2024: We stand by our report, Yiaga Africa insists

iaga Africa, a civil organization, on Thursday said it stands by its reports on the just-concluded off-cycle governorship election in Edo State, stating that the election failed integrity tests and standards.

Yiaga Africa's gramme officer, Mr Paul James, made the remarks at a one-day post-election meeting with leaders of Edo Civil Society Organizations (CSOs) and media partners in Benin City.

al process was largely peaceful, noted that the inflation of results in some local governments, as against the results INEC posted on IREV, rendered the outcome of the process not credible.

The Yiaga Africa pro-

gramme officer, who spoke on the topic "Agenda Setting and Methodology", alleged that results in Egor, Oredo, Esan West, and Etsako West local government areas were manipulated at the collation centers.

"Our position on the election, after reviewing what transpired, especially as a result of the results collation and the process, is that it fails to meet the election integrity standards for obvious reasons," James said.

"While largely we would say the election process went well, what we observed at the collation centres showed that the

results of some parties were inflated. Without casting aspersions on any party, we said any party could have benefitted from the process.

Atiku blames Nigeria's hardship on Tinubu's subsidy mismanagement

as calls for reversal of latest petrol price hike resound

The presidential candidate of the Peoples Democratic Party (PDP) in the 2023 election, Atiku Abubakar, on Thursday blamed Nigeria's current economic crisis on the haphazard approach of President Bola Tinubu's administration to fuel subsidy management.

Atiku, in a post on X (formerly Twitter), said President Tinubu is unperturbed by the hardship confronting Nigerians.

Atiku's comment comes on the heels of the latest hike in the pump price of petrol by the National Petroleum Company Limited (NN-PCL), which pushed the price of the product from N897 per litre to N1,030 in Abuja, and from N855 to N998 in Lagos.

This makes it the fourth petrol

sumed office as Nigeria's President.

When Tinubu became President, the pump price of petrol was N195 per litre, but the President's announcement, on the day of his inauguration on May 29, 2023, that "subsidy is gone" immediately shot up the price to between N448 and N557 per litre.

Subsequently, in June 2023, petrol prices inched up from N557 to N617 following an announcement by the NNPCL about market forc-

In September 2024, the PMS prices rose again to N897 per litre after the NNPCL announced that it was facing severe financial constraints, including high debt to petrol suppliers.

On October 9, the NNPCL again raised the pump price of fuel from N897 per litre to N1,030 in Abuja and from N855 to N998 in Lagos. In other South-West states, the price increase since Tinubu as- product will now sell at N1,025 per

litre while customers in the South-East will pay N1,045 per litre.

"The haphazard and disingenuous approach of the current administration to fuel subsidy management has been the reason we are in this current economic crisis in the country," Atiku wrote on Thursday.

"As things stand, there will be no let up in the escalating inflation rate, which is drowning the material well-being of Nigerians.

"It is even more worrying that T-pain is undisturbed by the hardship in the country," he wrote.

On Wednesday, the Nigeria Labour Congress (NLC) condemned the hike in petrol price, demanding an immediate reversal of the hike while accusing the government of only focusing on fuel price incre-

"By this directive, the Pension Bureau and 2011 retired Local Government Pensioners should take note," he said.

FG commences zero VAT on pharmaceuticals, medical devices

The Federal Ministry of Health and Social Welfare has announced that government has commenced the implementation of zero Value Added Tax (VAT) and excise duties on pharmaceutical products and medical devices.

The measure is expected to open the doors for local pharmaceutical and medical device manufacturers to benefit from the relief measures outlined by President Bola Tinubu via an Executive Order.

In a statement signed by the head, Information and Public Relations, Alaba Balogun, the ministry expressed hope that the measure will lead to reduction in the prices of essential pharmaceutical products and medical consumables.

"The ministry is pleased to announce the finalisation of the Executive Order Harmonized Implementation Framework, which has now been cleared for

"This critical step ensures that the Federal Inland Revenue Service (FIRS) and the Nigeria Customs Service can proceed with the implementation of zero VAT and excise duties on pharmaceutical products and medical

"This is a significant milestone, as it opens the door for our local pharmaceutical and medical device manufacturers to begin fully benefiting from

the relief measures outlined by President Bola Tinubu, in the Executive Order.

"With the implementation of this Executive Order, we anticipate a notable reduction in the prices of essential pharmaceutical products and medical consumables," it said

According to the statement, the development aligned with the ministry's commitment to reducing both the physical and financial pain faced by millions of Nigerians who depend on these critical health supplies.

It said the gazetting of the harmonised implementation framework represented the realisation of the third pillar of the ministry's four-point agenda, which focuses on unlocking the healthcare value chain.

"By creating an environment that supports local manufacturers, we are fostering a healthier, more self-reliant nation, and ensuring that quality healthcare becomes more accessible and affordable for all.

"The gazetted copies of the Harmonised Implementation Framework will be distributed to the relevant government agencies for immediate action," Balogun said.

results in Egor, Oredo, and Esan West Local Government Areas were tampered with.

"Our reasoning was that when observers sent in reports from the polling unit levels, we compared that against what INEC had submitted on their IREV.

To a large extent, what was in the IREV matched what we had, but when the results started coming in, maybe as a result of issues that happened at some of those collation levels, like Egor LGA, where the collation was moved to the INEC office.

"Oredo LGA was also moved. At Ikpoba Okha LGA, canisters of teargas were thrown at many people; the collation was also disrupted and moved. In Etsako West, there were gunshots around the vicinity, and the collation was also disrupted.

"So, that was why we paid attention to those specific locations, and we thought that if the results were not hampered with, it was very likely that the election might not even have been concluded on Saturday because there wouldn't have been a clear winner. It would have gone into a runoff.

That was based on what we saw, and we thought that it was as a result of these manipulations that these events happened," he said.

James, however, called on INEC to invoke Section 65 of the Electoral Act to review the results that have allegedly been declared under questionable circumstances.

According to him, the people are aggrieved and have reasons to question the outcome; INEC can go back and look at what had happened.

"The people are aggrieved, and they have reasons to question the outcome. INEC can go back and look at what had happened. There are places where, for instance, the ward collation started, and some of the wards were skipped.

"So, if those reports are out there and the people don't feel comfortable with the reports of some of those wards, INEC can simply go and audit it and see if whatever is there is reflective. Don't forget that at different layers, you are supposed to have party agents, and in fact, party agents have called into question some of those results.

"I think, in the interest of transparency, the commission can kindly go back and do that. Sadly, the seven-day window for INEC to do that has expired.

"The only body that can do any of those things at the moment is the court, and so we wait to see what the court could do going forward," he added.

He opined that the outcome of the election was assessed based on three principles: resilience, integrity, and impartiality tests.

He noted that the governorship election failed the integrity test due to the lack of transparency in the results collation processes, which led to the manipulation of results.

"While key processes such as accreditation, voting, counting, and recording of results at the polling unit substantially complied with procedures, the results collation process was compromised by the actions of some biased INEC officials in connivance with other actors. This manipulation severely undermines the overall integrity of the election," he added.

He posited that the cases of disruption in Ikpoba Okha, Etsako West, Egor, and Oredo local government areas during the course of collation created opportunities for election manipulation, raising significant concerns about the credibility and integrity of the results collation process.

by its president, Joe Ajaero, described the decision of the NN-PCL as an aberration.

"Even following the logic of market forces, we find it an aberration that a private company (NNPCL) is the one fixing prices and projecting itself as a hegemonic monopoly," Ajaero

"We challenge the government to go to the drawing board and present us with a blueprint for inclusive economic growth and national development instead of this spasmodic ad holism and palliative policy.

"It needs no stating the fact vance the destination it wants that the latest wave of increase has grossly altered the calculations of Nigerians once again at a time they were reluctantly coming to terms with their new realities.

"It will further deepen poverty as production capacities dip, more jobs lost with multidimensional negative effects. In light of this, we urge the government to immediately reverse this rate hike as previous increases did not produce any good results. People only got poorer.

"But more fundamentally, the government should be bold enough to tell Nigerians in adto take the country," he said.

The Organised Private Sector also condemned the development. The Director-General of the Manufacturers Association of Nigeria, Segun Ajayi-Kadir, said the hike would further drive up the cost of production for manufacturers.

"The second increase in one month will send high costs across the value chain for the manufacturer. In terms of the distribution of our products, it means that we are going to pay much higher for it and this will of course impact the prices at which our locally produced items will go," he said.

Meanwhile, senior officials at Dangote Refinery have debunked reports that the new petrol price hike must have been triggered by an increase in the ex-depot price of the product at the refinery.

This comes amid online reports on Wednesday indicating that Dangote Refinery had raised the price of petrol to N977/litre, prompting NNPC to also push up its rate.

"The NNPC should be in a position to tell you why it increased the price of petrol, go and ask them. I don't know where you got N977 from," a Dangote Refinery official told the Punch.

FG asks Nigerians to move to higher ground in fresh flood alert

The Federal Government has alerted Nigerians in vulnerable areas to embrace flood preparedness protocols including moving to higher ground as it issued a fresh flood warning stating that the 3,900 million cubic meter capacity Jebba Dam which is located between Niger and Kwara states is currently spilling excess water.

Flood preparedness protocols include designating places on higher ground to quickly move to, planning to move to higher ground before flooding begins and reviewing evacuation plans so as to be able to evacuate quickly.

Others include gathering supplies including non-perish-

able foods and water for several days and keeping important documents in waterproof containers

A statement by the Director General Nigeria Hydrological Services Agency (NIHSA), Umar Ibrahim Mohammed, circulating on Tuesday, informed that Jebba Dam is currently spilling excess water as regulated by Kainji Dam operators, who had kept 53cm buffer until now to allow for any change in inflow.

The spilling of excess waters from the Kainji and Jebba dams typically puts up to 13 states under flood threat according to the National Emergency Management Agency (NEMA).

These include Adamawa, Taraba, Benue states. Other states to experience heavy floods due to heavy rainfall coupled with the combined water of rivers Niger and Benue include Niger, Nasarawa, Kebbi, Kogi, Edo, Delta, Anambra, Cross River, Rivers and Bayelsa.

The statement from NIH-SA DG further read, "NIHSA through the Director Operational Hydrology Pastor Femi Bejide, is working in close contact with the operators of Kainji and Jebba Dams on the management of the reservoirs

"The rain is gradually shifting to the south, however, there is still some amount of water coming into Nigeria as monitored from our station at Jidere Bode and Kende."

Highlighting the agency's synergy with the authorities

of dams both nationally and internationally, he maintained that NIHSA is committed to managing great river flooding incidences to foster socio-economic growth in Nigeria.

Mohammed also revealed that the water level in the River Niger Basin has slowly receded since the beginning of October.

He called on Nigerians to continue to adhere to flood preparedness protocols, reaffirming the agency's commitment to the overall flood management in Nigeria.

The warning comes following recent reports on the worst flooding incidents in the history of Nigeria, with the capital of Borno State, Maiduguri taking the lead.

Climate change in Nigeria has been responsible for flood-

ing, droughts, decreased air quality, and the loss of habitat. A climate modeling study by the World Weather Attribution project estimated that the floods were rendered far more likely and much more intense by climate change.

On 9 September 2024, heavy rain and structural damage caused the Alau Dam in Konduga local government area (LGA), Borno state, to collapse. The dam collapse caused flash flooding in neighbouring Maiduguri and Jere LGAs. By 10 September, the floods had affected an estimated 240,000 people across both LGAs. Though, the number of affected people varies according to different sources, it is estimated that more than 122,750 people affected as of 18 September.

GTBANK announces weekend shutdown for core system upgrade

"As part of our commitment to bringing meaningful improvements to the lives of our customers, we will begin the transition from our current core banking applications to a new and robust suite of Finacle Core Banking Applications system on Friday, 11th of October 2024," the statement read in part.

GTB has also announced that there will be disruptions to its digital banking system for 11 hours between 10:00pm, Sunday, October 13th and 9:00am, Monday, October 14th. This will help to enhance good customer service and achieve better interactions.

"Additionally, there will be service disruptions on our digital banking channels for 11 hours, specifically between 10:00 pm on Sunday, October 13th and 9:00 am on Monday, October 14th. This transition will allow us to drive digital transformation to achieve insights-driven and frictionless interactions with all our customers," the bank said.

The bank also stated that although the digital service will be made available during system upgrading, it will only be limited to transfers, bill payments, airtime and data purchases.

The bank thanked customers for their understanding and cooperation as it strives to offer a more robust banking experience with the new system in place.

Speaking at the opening ceremony, which started on Tuesday at the Aliko Dangote Auditorium, the Acting Vice Chancellor of the institution, Professor Dawood Egbefo, said it was imperative for academic staff to acquire and apply new teaching techniques for academic development.

He said no amount of time spent in colleges or universities will be enough to complete the preparation of a teacher for classroom tasks, saying teachers must continually be trained and retrained as well as armed with the requisite modern knowledge acquired for the 21st Century engagement.

According to the Acting VC, the training is to lay a solid foundation for a sound academic session as it is aimed at enabling us to get acquainted with the challenges ahead of us as we prepare for the first semester.

Prof. Egbefo said the twoday training workshop would allow the academic staff to acquire new teaching techniques for their academic development and learn more ways on how to structure and deliver their teaching in more practical, impactful and effective methods.

"As we set necessary machinery in motion for an effective take-off of this academic session, it is therefore expected of us to discharge our professional responsibility to meet the challenges in academic and research development", he said. A guest speaker, Professor

Patrick Oviasuyi, who spoke on the topic 'Work Ethics in the University Environment for Academic Staff', described work ethics as morals and norms observed in workplaces, saying it is crucial to the development of any institution.

He said the major issues affecting tertiary education are gross under funding, which affects teaching, learning and research.

According to him, tertiary education is grossly underfunded and the government needs to inject enough money into the system as under-funding is one of the banes of education development, which has contributed to the low standard of education in Nigeria.

Dr. Makinde said teaching

Danesi's claim to Aidonogie of South Ibie stool false —HRH Umoru

The Aidonogie of South Ibie, Etsako West Local Government Area, Edo State, HRH Umoru Inusa Umoru, has debunked the claim by Mr. Aliyu Kelvin Danesi as the authentic Aidonogie of South Ibie land, as false.

In a press statement by HRH Umoru Inusa Umoru seen by the Nigerian Observer, Mr. Danesi had claimed, community should disregard his removal as the Aidonogie of South Ibie as he is still the Aidonogie of South Ibie; No law or court has ever removed him as the Aidonogie of South Ibie; The new chieftaincy law enacted on 2006 qualified him to occupy the stool of Aidonogie of South Ibie.

Furthermore, that his removal by the Edo State government was politically motivated

among others things, that the and the action of the government amounted to "executive lawlessness", and he obtained ex parte orders restraining the government from disturbing him as the Aidonogie of South

According to HRH Umoru, in the press statement, "My attention has been drawn to the press conference granted by Mr Aliyu Kelvin Danesi, which was widely published on different print and electronic media,

where in summary, Mr Danesi stated...

'The entirety of Mr Aliyu Kelvin Danesi's contentions above is deliberately false and misleading. As I shall show below, Mr Danesi was never the Aidonogie of South Ibie; he merely usurped the stool of the Aidonogie of South Ibie and forcefully and illegally imposed himself on the people for over 25 years.

"Mr Danesi has always been

rejected by the custom, the law and the people. My appointment and recognition by the Government is merely the liberation of the good people of South Ibie from Mr. Danesi shenanigans, the enthronement of rule of law and the enforcement of multiple decisions of the different hierarchies of courts as explained in the succeeding subheadings and paragraphs."

HRH Umoru showed court decisions nullifying Mr. Danesi's appointment, saying that Danesi's claim is specifically untrue and manipulative, as "the courts did not just merely remove Mr. Danesi as the Aidonogie of South Ibie, the courts nullified his appointment as the Aidonogie of South Ibie."

By the nullification, in the eyes of the law, Mr. Danesi in fact was never appointed or installed as the Aidonogie of South Ibie, the numerous court decisions are considered below, he said (Judgement of Justice Sadoh of the High Court of Edo State in consolidated Suit Nos: B/226/1998 and B/227/1998).

"In the instant case, having duly considered the evidence adduced by the parties and their witnesses, I hold that the selection of Alhaji Aliyu kelvin Danesi does not comply with the registered Declaration regulating the succession to the clan head Aidonogie of South Ibie. See exhibit B2. I therefore declare his selection, appointment as well as the approval by the Edo State government invalid, null and void."

Also see, judgement of Muntaka-Coomassie JCA in Appeal Number CA/B/9/2001 - Mr. Danesi appealed the decision of Justice Sadoh to the Court of Appeal. On 7 April 2003, the Court of Appeal, in the main, rejected the appeal and Justice Muntaka-Coomassie JCA while delivering the unanimous decision of the Court of Appeal, at page 16 of the judgement, specifically declared and ordered as follows:

"That the selection, presentation, appointment and/ or production of Alhaji Inusa kelvin Danesi as the Clan Head or Aidonogie of IYAK-PI, South Ibie by the Danesi branch of Okhokho Ruling House is hereby declared null, void unconstitutional and of no effect".

On the claim of ex parte orders, "As shown above, all the hierarchies of the Courts (from the High Court to the Supreme Court), at least, 6 different courts have held that Mr. Danesi is not the Aidonogie of South Ibie.

"In fact as described by Justice Omonua, Mr. Danesi's appointment as the Aidonogie of South Ibie is deeded in the eyes of the law "never took place". Yet, in 2024, Mr. Danesi commenced yet another case, concealed the above different decisions of various courts which declared his appointment as a nullity, and got the court to issue ex parte interim orders in his favour even before the Government and I were aware of the case and before any defendant were served with the documents of that suit."

In all, the general public is advised to disregard Mr. Danesi lawless and ill-advised press conference as he is not, and had never been, the Aidonogie of South Ibie, according to HRH Umoru.

vbuotubu, a communi-**◄** ty tucked away in Oredo Local Government do Local Government Area of Edo State, Nigeria, can be compared to a faded cloak of neglect and despair. The sprawling neighbourhood that houses many is a vivid reminder of the inadequacies of the community. From the narrow streets lined with crumbling buildings to the bad roads, lack of drainage system, absence of streetlights, broken pipes and insufficient access to clean water and electricity, you can just imagine it.

Irrespective of the various government attention, Evbuotubu is a blurry vision of development. The major areas are far from being developed and the infrastructural constraints are very glaring.

A major constraint faced by the community is the lack of electricity. Power outages are the order of the day, and this makes it a bad site for business. The few business owners that reside there are compelled to run their businesses with generators, which automatically leads to an increase in running costs and may likely affect their profit from sales made because a great percentage will be spent on fuel. Do we say it is the reality of present day Nigeria?

The issue of power outage has been a major concern to many as it is a major determinant for most businesses to thrive, and with the current hike in fuel price, business owners will find it more and very discouraging. A few residents have stated that these issues have been reported to the appropriate authorities and promises have been made to tackle these issues. However, a good number of these issues have been left unattended till date.

Also, the issue of hygiene in Evbuotubu is alarming and has raised serious concerns; the poor sanitation and lack of waste management are notable. It is well known that poor sanitation and lack of waste management not only litter the surroundings but also have severe health implications. The presence of such waste makes the environment unhealthy, makes room for germs, bacteria and viruses to exist, causing diseases. This is where the residents should come in and take ownership.

The roads are bare and untarred, littered with waste of different kinds, making a total mess of the environment, thereby creating an eyesore. This is an even worse sight to

behold in the rainy season because the roads are covered in puddles and most times overtaken by floods as a result of inadequate drainage systems. One thing that has drawn the attention of many residents is that the roads are usually submerged in water even with little rainfall, which puts the roads in a very bad state, paving way for accidents and vehicle damage. This is where the local government should show responsibility.

Unemployment is rampant with few job opportunities and local businesses struggle to maintain stability due to inadequate infrastructure and lack of support. Government officials seem to recently be attending to the issue regarding drainage systems. Currently, gutters are being constructed to channel the flow of water and arrest the issue of flooding. Residents have constantly complained about the slow construction and the damages that have been made on the roads as a result of the drainage construction.

This project has been on for a while now and not much has changed since the construction commenced. The roads are still covered in puddles whenever it rains leading to an increase in transport fare, as the major routes will become not motorable", Miss Faith, a resident of the community, stated. "In fact, the state of the roads has gone from bad to worse with the commencement of this drainage construction. The roads have become narrower and more inconvenient for both drivers and pedestrians, but we trust that the government will take care of the roads after attending to the drainage construction", she further stated. It is obvious that the residents are dissatisfied with the state of the community.

In spite of all these challenges, Evbuotubu residents have remained resilient and their struggle for survival surpasses all these challenges. It is this drive and determination that keeps its residents going in the hope that one day, their community will achieve vibrancy.

These numerous problems have made Evbuotubu very dull as it lacks the criteria for livelihood. Residents however admit that there is peace and quiet in the community without any form of unrest. Despite its underdevelopment, the crime rate is near zero. Irrespective of the challenges encountered by its residents, their struggles will continue, undaunted.

Gov. Diri says it's time to rethink Nigeria's federalism

overnor of Bayelsa State, Senator Douye Diri, on Wednesday, faulted Nigeria's brand of federalism, saying a situation where only the Federal Government can create local government is an aberration.

Governor Diri also said Nigeria was on the wrong path to development and needed to

Delivering a lecture titled: "Rethinking Our Future: The Need For True Federalism and Economic Renaissance," at the 64th Founders' Day Lecture of the University of Nigeria, Nsukka, Enugu State, the Bayelsa governor averred that states should constitutionally have the right to create and legislate on local governments in a truly federal structure.

He reaffirmed his belief in the unity of Nigeria, which he said can only be sustained on the basis of equity, justice and fairness, describing federalism as a very touchy subject that concerns Nigeria's corporate existence.

He said the fact that true federalism has become a lexicon that reverberates across the socio-political landscape of Nigeria underscores the defective nature of the governance structure operational in the country, a situation which has led to constant agitations.

The guest lecturer expressed concern that the misgivings of ethnic nationalities and minority interests about the inequities and disequilibrium that defined the political paradigm at the time of independence in 1960 still persist and stressed the need for a paradigm shift where the dreams and aspirations of Nigerians will not be deferred perpetually.

According to Governor Diri,

ture in Nigeria cannot deliver the future the vast majority of Nigerians desire and deserve.

The Bayelsa helmsman remarked that Nigeria had reached a pivotal point, a crossroads that demands wise decision-making to determine the nation's destiny and secure a prosperous future, stressing that Nigerians must engage in frank conversations about how to create a more perfect union that embraces diversity while pursuing common goals.

Diri queried Nigeria's current federalism, saying it was meant to serve the interest of the colonial masters as against the ideal pattern of forming a federation where states willingly come together to form a nation, as it is in the United States of America.

He recalled how a son of the Niger Delta and of the Ijaw nation, Isaac Jasper Adaka Boro, pioneered minority rights activism in the country, beginning his revolutionary journey during his days at the University of Nigeria where he was president of the students union government during the 1964/65 session.

He also argued that the current governance structure in Nigeria has left oil-producing communities impoverished despite being the backbone of the country's economy and advocated the reconsideration of the Land Use Act of 1978, which he described as a paradox and that no meaningful development can take place in a situation where states cannot control their resources.

The governor further noted that every state in Nigeria was blessed with natural resources as well as peculiar needs and should be allowed to harness

and develop at their own pace while contributing a percentage to the government at the

He also stressed the need for state police, citing recent developments in Rivers State during the local government election and the Bayelsa situation in Bassambiri community during the 2023 governorship election where police was used against the people, saying states must have the power to take charge of their security.

His words: "We are all aware of the ongoing conversation around the issue of autonomy of local governments. My concern over this sensitive subject is beyond the question of autonomy and more about the rationale for their creation. The current system, which allocates funds based on the number of local governments, puts some states, especially Bayelsa with just eight, at a disadvantage. This disparity arises because states with more local governments receive a larger chunk of resources, regardless of their specific requirements or financial strength.

"Since the Constitution exclusively recognises states and the federal government as federating units, the federal government's creation of local governments constitutes an aberration, undermining the principles of federalism and state autonomy. The Constitution's clear delineation of federal and state powers renders the federal government's creation of local governments incongruous, as local governance falls within the purview of state authority. My take to addressing this issue is enforcing states' autonomy to create local government areas tailored to their unique needs and financial capacity to do so.

"In the context of Nigeria, the term "true federalism" has become a rallying cry for those seeking autonomy, resource control, addressing issues of marginalisation and good governance. It is about moving away from a system that can properly be described as "unitary federalism" or a "federation without federalism."

"For the avoidance of doubt, I wholeheartedly support the Nigerian state and its continuous unity and existence. However, I recognise that, like any

nation, we strive for a more perfect union. A union where diversity is celebrated, equity ensured and opportunities are accessible to all.

"Consequently, we must rethink our future and build a political culture where the promise of federalism is not a mere illusion of unity, but a powerful catalyst that drives our passion for success and unlocks untapped potential."

Earlier, the UNN Acting Vice Chancellor, Prof. Polycarp Chigbu, said the event is to celebrate the founding fathers of the institution led by the late Dr. Nnamdi Azikiwe, whose vision led to its establishment on October 7, 1960, according to a press statement by Daniel Alabrah, Chief Press Secretary to Governor of Bayelsa State.

The member representing Oron/Mbo/Okobo/Udung Uko/Urueoffong Oruko Federal Constituency, in the Federal House of Representatives, Martins Esin, has moved a motion urging the Federal Government to commence academic activities at the University of Maritime Studies, Oron, Akwa Ibom State.

In the session, recently, Esin emphasised the strategic importance of the institution to the maritime industry and the host community.

You're jinx breaker, Gov. Diri commends Eruani, Azikel Refinery president

overnor Douye Diri of Bayelsa State has said President of the Azikel Group, Dr. Azibapu Eruani, broke the jinx in establishing the Azikel Modular Refinery, which is the first crude oil-related industry in the state.

Senator Diri gave the commendation on Tuesday when he visited the refinery complex located at Obunagha in Yenagoa Local Government Area for the first time.

The governor commended Eruani's business acumen, noting that the abundance of crude in the state would eliminate losses and other impediments to smooth operations of the refinery.

He also stated that the refinery had changed the status of the state in its industrialisation drive and that it met the dreams of its founding fathers.

In a press statement by Daniel Alabrah, Chief Press Secretary to Governor of Bayelsa State, the Bayelsa helmsman said the refinery would improve the internally generated revenue of the state and create job opportunities for the youths.

He expressed delight that the project was nearing completion and that he would be part of the history of inaugurating the first modular refinery in the state.

According to him, it was an aberration for the state to have abundant crude oil and gas without industries or 24-hour electricity.

He restated his administration's determination to tackle the electricity challenge and that it was ready to engage investors to revive the state's gas turbines.

He also advised that development of the state should not be left only in the hands of politicians or government and urged privileged Bayelsans to partner his administration to build the state.

He said: "Dr. Eruani has established a modular refinery here in Bayelsa State and not in any other state. Let me on behalf of the government and people of Bayelsa State congratulate you and thank you for this bold step to make our dreams come to pass.

"This is what our state's founding fathers and all of us have been talking about. We cannot have crude oil and gas on our soil and not have electricity or industry in the state.

"You have broken the jinx and I am sure the younger generation will follow your footsteps. Development is not done by the government alone. It is done in partnership with the private sector. That is why we are very glad that you are partnering with the state government in developing Bayelsa State. Like you rightly said, this will bring job opportunities here and taxes will be paid to the state government.

"I have often said that you do not need to lay pipes too far away from where you have the raw materials. Elementary economics taught us about the nearness to source of raw materials. This is the knowledge and benefit in siting the refinery just a stone's throw from the crude. Eruani knows where the problem was because he is from Bayelsa. He understands that by siting his industry close to where the raw material is, it is going to be cost-effective and will not face a lot of challenges.

"Now if they call businessmen in Nigeria, I will say I also have Dr Eruani in my state. I invite our businessmen from Bayelsa that are doing well outside the state to also come home to affect lives, create jobs and join hands with the government to develop the state".

Earlier, Dr. Eruani said the refinery is worth over \$850 million and currently has about 400 foreign and local employees at the site.

The Azikel Group president explained that one of the reasons he established the refinery was to add value to the Nigerian crude oil, create employment and to industrialise the state.

Eruani said the refinery was unique as it is the only one in Sub-Saharan Africa to refine condensate apart from petrol, diesel and aviation fuel, saying it has equally placed Bayelsa among the critical states that would contribute to the industrial base for petroleum sufficiency in the country.

He assured that the state would not have product scarcity when the refinery commences operation.

The group's president, who took the governor and his entourage on a tour of the facility, appealed for partnership with the state government to dualise the road leading to the complex for easy transportation of refined products.

Women groups empower 105, enjoy collaboration with N'Ass, CRBDA

o fewer than 105 young women have received start-up kits after undergoing several months of skills acquisition training in Cross River State.

The kits, including sewing machines, hairdressing equipment, liquid soap making equipment and assorted financial sums, were handed over by a group known as Universal Women's Fellowship through minister of women's affairs, Barrister Uju Kennedy, represented by Mrs. Angeleen Nkwocha of Child Welfare Department.

The women earlier empowered 17 through long-term training, and another 35 sisters were empowered with funds to startup mini businesses.

The minister said her ministry was very happy that a group of women was very committed in pulling their resources together to achieve such a laudable initiative.

Transparency and the price of petrol

The Petroleum Products Retail Outlets Owners Association of Nigeria (PETROAN), spoke the minds of Nigerians when they expressed regret over the nondisclosure of the exact price of the Premium Motor Spirit by the Dangote Refinery.

This is just as there is a rush of outrage flowing across the nation in response to the unannounced 15 percent hike in the price of petrol by the state owned Nigerian National Petroleum Corporation (NNPC) Ltd, from N855 per litre to N998 in the Lagos area and a mark up from N897 per litre to N1,030 in the Federal Capital Territory (FCT) Abuja area.

Expectations were high that the roll out of PMS by the Dangote Refinery would to an extent reduce the rising price of the product in Nigeria, even though experts called for caution, explaining that market forces and not national sentiment determine prices.

Speaking on Channels Television's breakfast programme The Morning Brief on Thursday, PETROAN president, Billy Gillis-Harris, said it is high time Dangote opened communication with retailers and other stakeholders.

Gillis-Harris said his association which is a core industry stakeholder was in the dark as to the dynamics of petrol prices and pricing between Dangote Refinery and the NNPC as middlemen

He asserts that Dangote needs to open up communication with all the stakeholders, get valuable inputs from everybody because it is a business that involves Nigerians, retail outlet owners, marketers and different consumers.

This fresh petrol price increase follows a September 2, 2024 increase by the NNP-CL. The retail company had hiked the price per litre of petrol from №568 to №855.

Since the presidential announcement removing fuel subsidy in May 2023, the NNPCL has gradually increased the pump price of petrol from N184 in Lagos to N998.

Mid-September, the NNPCL began loading its first batch of petrol from the Dangote Refinery, saying it got petrol at \text{\text{\text{898}}} per litre from the private refinery.

The NNPCL immediately hinted at a fresh price increase when it said a litre of Dangote petrol would now sell for ₹950 per litre in Lagos and ₹1,019 in Borno.

This increase in Nigeria's processing capacity with the coming onstream of the Dangote Refinery could have


substantial implications for both the refinery's operations and the local oil industry, transforming the region's import and export markets.

Economists say one of the fall outs of this development will be a strengthening of the local currency, the naira, as it will be relieved of the drag of the pursuit of scarce dollars to buy refined products.

It is said that the pricing of petrol and other refined products will depend on international crude market dynamics and that the main advantage that Nigerians would derive in the immediate is that there will be an assured stream of refined products which will cancel out former frequent shortages.

All of this is well and good. However, as Harris says, Nigerians do have a right to know the nitty gritty of things that affect their daily lives.

At the end of the war, he was one of those that were brought back - not all came back. John remembered his surname and the name of his town.

Back home, he enrolled in school, but didn't go too far. While in secondary school, he visited his elder brother during a long vacation and decided to join him in trading.

By 1984, he had finished his apprenticeship and was 'settled' by his brother and master. Within one year of being on his own, he had become a success. He bought himself a brand new Volkswagen Passat before age 20.

He wasn't a show-off. He needed a

vehicle for his trade and decided on one that gave him both pleasure and utility. John was hard work personified. About three times in a week, he would make trips from Lagos to Ado-Ekiti to buy stationary, which was his item of trade. Nigeria was relatively industrialized, and Omolayo manufactured stationary at Ado. John was one of his main customers.

There were also the government-owned giant paper mill at Jebba, and the Oku Iboku newsprint mill was to join in 1986. Of course, the Passat that my cousin bought was made in Nigeria by Volkswagen at Badagry Expressway. There was also a Peugeot at Kaduna, and the cars made by these two companies were booked ahead. The military government of Olusegun Obasanjo made them Nigerian cars, also used by the head of state.

Though corruption was high in the management of these state firms, they provided jobs for Nigerians, at least, and the import substitution philosophy on which the idea was hinged was a limited success.

After President Shehu Shagari's Aus-

terity Programme, following massive corruption which ended with his overthrow on the last day of 1983, the Buhari/ Idiagbon military government restored hope. It took out the food shortages and rampaging inflation through its trademark counter trade midwifed by General Ike Nwachukwu. They succeeded in staunching the bleeding underbelly of Nigeria without exacting great pain. It was within this period that John bought his Passat, at a sum of about N13,000! Yes, this very naira had value. For a sum that can't buy 10 litres of fuel today, one bought a trending posh car.

General Ibrahim Babangida overthrew Buhari in 1985, introduced the World Bank's Structural Adjustment Programme in 1986, and Nigeria's unrelenting descent started, till date.

Under Babangida, the naira moved from a near par with the dollar, to double digits. It meant that industrial spare parts and raw materials required multiples of their original naira costs to import. And the consumer public, whose purchasing power moved in the opposite direction, couldn't buy. Overnight, the local industries died out. The badly managed government industries died first. But they were quickly followed by the better-run private ones. Omolayo stationery manufacturers died too. No amount of microeconomic management can cover macroeconomic gaps. That was how Nigeria underwent industrial denudation.

The only benefit of SAP was that it

replaced the opaque import-licensing regime for access to foreign exchange with the more transparent bidding system. Under the import licensing regime, those that wanted to import would apply to the Central Bank for an import licence as well as foreign exchange for the import. The process of getting both was mired in deep corruption. But under SAP, those who need foreign exchange simply had to apply to the CBN through the deposit money banks and make bids for available foreign exchange.

This SAP foreign exchange system has run for 38 years and what do we have to show for it?

Yes, it has a seemingly more transparent allocation method by open bidding. But in reality, what have we got? In place of CBN staff milking the system under the import license regime, we have had a 38-year long bazaar of deposit money bank managers doing the same under the SAP regime till today.

The SAP regime has promoted speculation against the naira by the deposit money banks through sundry means, particularly round tripping. It doesn't require intelligence to do, and mediocre money managers have become super rich by this singular act.

Now, isn't it like replacing stomach ache with stomach cancer?

The Passat was the only brand new car that John bought. When it dawned on him that the Passat may be the best car he would buy, he tried to extend its life.

He bought a Volkswagen bus with which he did the shuttles to Ado. It cost him close to a million naira to buy this fairly-used bus, whereas he had bought his brand new Passat for less than N13,000! The governments of Nigeria have practically buried this man in whom they had invested next to nothing.

John is 60 now, and though his strength and enterprise remain constant, the output has been moving in an almost reverse direction. Nigeria wasted much of his youth and energy and he is not likely to retire, for he has no pension. His only chance at rest is if his children whom he trained through the university make good and put him on a family pension. Otherwise, this strong man who followed the straight and narrow path since his youth will struggle at his shop till his last day. Nigeria happened to him, as we say these days.

For his children, their only chance is for them to find a way out of Nigeria - join the japa train. But even if the visa were free, how would they pay for the flight ticket? Their father's shop can't buy a single flight ticket now. Forty years ago, their father could have bought return tickets for all five of them at the same time without a jolt to his capital. Ah Nigeria!

Is a revolution possible in Nigeria?

n the words of Prince Niccolo Machiavelli, a 16th-century Italian diplomat and philosopher, "All well-governed states and wise princes have taken care not to reduce the nobility to despair, nor the people to discontent." Put differently, society must be run in a manner that ensures fairness to both the rulers and the masses. This is because where the leadership is insensitive to the suffering of the masses, there will be general discontent which may result in social uprising; and when the leaders are dispirited, there will be general hopelessness. But as it stands today in this country, citizens have lost interest not just in government but in our brand of democracy because the sacred ballot box that embodies the people's aspirations has been broken into pieces.

With the general feeling of discontent in Nigeria today, resulting from hunger and poverty, fuel and energy crisis, insecurity, corruption, youth unemployment, violence particularly during elections, and despair even within the so-called leadership elite, there have been suggestions that Nigeria is ripe for a revolution. But is a revolution possible in Nigeria, and what type of revolution is it going to be? Is it even necessary in the first place?

From recorded history, not a few revolutions have taken place across the globe at different times and in different nations with some resulting in positive social transformation and others in outright disintegration of the nations involved.

The Third Agricultural Revolution, or what was commonly referred to as the Green Revolution, took place during the 1950s and 60s which resulted in unprecedented improvements in technologies and innovative tools for growing plants, leading to much greater crop yields and food stability across most of Europe and other parts of the world. Ultimately, this led to a dramatic upsurge in livestock because these plants were also utilized for grazing, thereby boosting livestock production and agro-allied industrial activities. Here in Nigeria, a number of policies were initiated, aimed at achieving something close to an agricultural revolution. There was Operation Feed the Nation (OFN) programme which kicked off



on 21st May 1976 under the military regime of General Olusegun Obasanjo. The programme was launched in order to bring about increased food production in the entire nation through the active involvement and participation of every citizen. The idea was that everybody should own a farm. In other words, farming should become a national culture. There was also Green Revolution (GR), a programme inaugurated by President Shehu Shagari in April 1980. The programme was aimed at increasing production of food and raw materials in order to ensure food security and self-sufficiency in basic staples. It was geared towards boosting production of crops, livestock and fish in order to meet home and export needs and to expand and diversify the nation's foreign exchange earnings. It was envisaged that through production and processing of export crops to compliment huge oil earnings at that time, the country would gradually derobe itself from the so-called third world toga. These programmes may have recorded some level of impact, but they never were able to evolve into anything in the semblance of an agricultural revolution that could, for instance, match that of the Chinese or the French whose revolution of 1789 was largely agricultural, or the British agricultural revolution of the 1930s through to the 60s. The gross value of agricultural output in China doubled from 1978 to 1985, and from the 1980s up to 2010 the output value of Chinese agriculture skyrocketed sixfold. As a matter of fact, by the time the People's Republic of China was established in 1949, virtually all arable land was under cultivation, irrigation and drainage systems. If all arable land in Nigeria is cultivated with modern technology, when Nigeria coughs, the entire world will freeze. It has been said that the technocrats in Abuja are working on it. That is good enough. Textile production which formed a dominant industry during the 18th-century Industrial Revolution, providing employment for millions of unemployed persons across Europe, is a shadow of itself today in Nigeria. The technocrats are also working on it in Aso Rock. That is also good enough.

Some countries have witnessed a violent kind of revolution which is mostly political. Political revolutions have significant effects on the nation in which they occur, but it is on record that they are not always successful. The main purpose of a political revolution is to drastically recreate the government of a nation to a form that will easily create desired policies for the benefit of citizens. Such revolutions are fought against rulers or government officials, and they often end in the death of these individuals. It typically begins among the common people, the lower classes of society who feel oppressed and discontented with the ruling class. The danger here is that the revolution more often throws up greater demons than the demons that were meant to be overthrown. The military coups in Nigeria, though revolutionary in nature, never produced any meaningful progress mainly because the citizens were naïve and initially supportive of the juntas only to be disillusioned after each regime. At the end, they rose up and chased the soldiers back to the barracks. The French Revolution from 1789 to 1799 has similar elements, but because it was people-oriented it was characterized by much more violent uprisings and demonstrations. The royalty and nobility of France were reckless with public treasury, and the burden of their recklessness fell upon the poor citizens. Eventually, the people revolted and established their own form of government known as the National Assembly. It was recorded that in one of its National Conventions, the assembly members arrested King Louis XVI and beheaded him in the French public guillotine. The revolution produced major political and social changes, but ultimately led to much instability due to its failure to address economic issues. It serves as an example of how revolutions must take into account all aspects of society in order to be successful. You cannot dig a second pit in order to get sand to cover the first one; otherwise you will end up digging pits for the rest of your life.

From our understanding of the Nigerian character, this kind of violent revolution is certainly not desirable and even if it is contemplated at all, it will fail woefully. At any rate, such an adventure - or misadventure - would definitely assume tribal and ethno-religious dimensions as was evident in the 1966 military coup which some commentators have often likened to a revolution. We know who we are despite our affectations of western culture. Africans are hardly rebellious except when pushed to the wall. The cat and rat idea where the leadership sees the citizens as their obstacle and the citizens in turn see their leaders as demons is simply pedestal and foolish. You can't love eggs and hate chickens.

The Chinese Revolution of 1949 saw the establishment of a communist party which replaced feudalism with socialism. But even today, the Chinese society still shows relics of its communist past. The point here is that revolution or no revolution, it is only when people are united towards one common objective that true power and social change can emerge from collective action. So, the Nigerian activists calling for a revolution may do well to understand that they themselves may not be as wise and as righteous as they think, and they may not actually have the capacity to bring about the social change that they desire. The way forward therefore is to repair the broken ballot box or build a new one in a manner that ensures that both the rulers and the citizens are protected.

Appeal Court sets aside Rivers 2024 budget passed by Edison Ehie group

asks Fubara to re-present it to Amaewhule-led lawmakers

The Court of Appeal in Abuja has affirmed the judgement of the Federal High Court that set aside the N800 billion budget passed by five members of the Rivers State House of Assembly led by Edison Ehie.

The appellate court on Thursday dismissed the appeal filed by the Governor of Rivers State Siminalayi Fubara on grounds that it lacked merit.

The court held that Governor Fubara ernor and a joke taken too far. withdrew his counter-affidavit at the lower court in the matter and as such cannot commence an appeal in a matter he did not challenge at the trial stage.

In the unanimous judgement, the court said that Governor Fubara is expected to apply the rule of law and not the rule of might.

The court further says that the situation in Rivers State House of Assembly is an executive dictatorship by the gov-

Justice Omotosho had nullified the 2024 Rivers budget passed by pro-Fubara lawmakers and set aside the presentation and passage of the Rivers State 2024 budget.

In the judgment delivered Omotoso ordered Siminalayi Fubara, Rivers governor, to re-present the budget to the legally constituted House of Assembly under Martin Amaewhule.

Fubara had presented the budget

titled: 'Budget of Renewed Hope, Consolidation and Continuity' of N800 billion to five out of the over 30 lawmakers of the state house of assembly in De-

In the judgement, Justice Omotoso ordered Fubara to release all funds accruable to the Rivers House of Assembly and barred the governor from interfering with the activities of the assembly.

The court also nullified the redeployment of the clerk and deputy clerk of the state assembly by the state's head of civil service.

The judge held that the appointment of a clerk and deputy clerk is the responsibility of the speaker, as contained in the Rivers State Assembly Service Commission law.

The court further ruled that the inspector-general of police and the Nigeria Police Force were duty-bound to continue to provide security for all Rivers citizens, including members of the state assembly.

The Bello Turji dilemma: Can dialogue end Nigeria's banditry crisis?

igeria's northwest region is grappling with a debilitating banditry crisis, leaving thousands displaced, kidnapped, or killed. The region's instability has dire consequences for national, economic growth, and human rights. Amidst this chaos, Bello Turji, a notorious bandit leader, has surprisingly called for dialogue with the government. Turji's plea for peace has ignited intense debate, raising questions about the legitimacy of engaging with a group responsible for violence and harm. Can dialogue with Turji bring an end to the crisis, or will it perpetuate a cycle of violence and undermine the rule of law?

According to Daily Trust report on Thursday 3, October 2024, "The wanted bandit kingpin, Bello Turji, has dared the security forces, saying he is not afraid to be killed. He, however, called for dialogue with the Federal Government to end armed violence in Zamfara State.

"Turji, who is among the 43 terrorists in the North West declared wanted by the Defence Headquarters, made the call in a five-minute and forty-second video.

"In the video, Turji confirmed the killing of his boss, Halilu Sububu, saying that Sububu's killing would not silence him. Turji said that he was willing to lay down his arms if the government would dialogue with him."

BELLO TURJI: A NOTORIOUS BANDIT

Turji, born in the 1980s in Zamfara State, began his life as a Fulani herdsman. However, his transition to banditry allegedly started in the early 2010s, driven by land disputes with local farming communities; economic hardship and lack of opportunities, and perceived marginalization of Fulani herdsmen.

Turji's group initially focused on cattle rustling and highway robberies but escalated to kidnappings, village attacks, and extortion.

ALLEGED CRIMES AND CONTROVERSIES

Turji's notorious reputation stems from mass kidnappings, including schoolchildren and villagers; deadly attacks on villages, markets, and security personnel, and alleged links to terrorist groups and transnational organized crime.

In rare interviews, Turji claims his actions are a response to government

neglect of Fulani herdsmen's interests; persecution by local farming communities, and economic hardship and lack of opportunities.

Therefore, the poor leadership, unemployment, poverty, corruption, and the proliferation of arms are the underlying factors contributing to banditry in Nigeria. The country's governance system has been criticized for its failure to address these issues, creating an environment conducive to banditry.

Cabinet reshuffle alone may not make any significant difference

President Bola Ahmed Tinubu is expected to reshuffle his cabinet soon and some portfolios may be reassigned and some ministers be relieved of their duties. According to the Special Adviser to the President on Information and Strategy, Bayo Onanuga, "When the reshuffle happens, it is expected to align with the President's broader strategy to enhance governance and better communicate the administration's successes."

To achieve the desired results, the performance review of ministers should be holistic, as various factors affect performance, some of which may be beyond their control. The lag between policy announcements and implementation has contributed to

the perceived poor performance of this administration.

The workload of the ministers should be reviewed to identify those who may be overwhelmed. No matter how capable a person is, being overloaded with tasks will lead to longer turnaround times and delays in policy implementation. Some ministerial portfolios may need to be split, or Ministers of State appointed in some ministries where they do not exist. Some people think the Minister of Finance, who also doubles as the Coordinating Minister of the Economy, should have a Minister of State.

The problem of bureaucracy in Nigerian governance has always existed. Tasks that can be completed in two days in a private setting take much longer in government. The gov-

ernment should conduct a process review and streamline its operations for greater efficiency. This should be done without losing sight of the need for control and supervision. This will speed up policy formation and implementation thereby making the government more responsive. Beyond bureaucracy, another factor causing delays in policy implementation is the lack of, or delays in, funding. In such scenarios, there is little a minister can do.

One may ask if the roles, responsibilities, and deliverables with timelines expected of the ministers were clearly communicated to them. For example, just recently, Bayo Onanuga said, "The President has instructed ministers to actively communicate what their ministries are achieving.

Some have been hesitant to engage with the media, but the President wants them to change that." While some ministers have been very vocal, though it may seem implied, it is possible that others did not know they were expected to be, given that the government has other means of promoting its successes.

There are factors beyond a minister's control that can affect their perceived performance, apart from funding. For instance, whilst not celebrating or defending the performance of the Minister of Agriculture, without addressing insecurity, which has led to incessant attacks on farmers, farmlands, and livestock, domestic food production will remain impaired. The Ministry of Solid Minerals is faced with a similar circum-

stance with many mining sites under the control by non-state actors.

As Mr President prepares to reshuffle his cabinet, it is imperative that issues like workload, funding, bureaucracy, communication of deliverables, and other factors beyond the control of ministers are properly addressed. Changing ministers or reassigning portfolios without dealing with all the issues impairing performance may not lead to significant improvement. Performance review is holistic and goes beyond just evaluating the individual responsible for certain tasks. Nigerians deserve a more responsive government.

WIKE VS FUBARA:

Unending crisis and search for peace in Rivers

he power tussle between the Minister of the Federal Capital Territory (FCT), Nyesom Wike, and Rivers State Governor Siminalayi Fubara does not seem like it is about to end. If anything, it has become a typical case of one week, one trouble as no week passes without something new popping up in the Garden City.

In the latest turn of events, the state was thrown into turmoil following the local government elections that took place on 5th October 2024, where the Action Peoples Party (APP) won 22 out of the 23 LGAs. The widespread violence involved shootings, arson and protests by persons suspected to be Wike's supporters across several local government secretariats aimed at preventing the newly-elected chairmen of local governments from taking over the council secretariats.

While a faction of the PDP in the state accepted the result, another faction alleged to be members of Wike's camp rejected the outcome of election, saying they are heading to court to contest the result.

Speaking to the Punch, the PDP Publicity Secretary in the state, Kenneth Yowika, "We are a law-abiding party, we are not going to come out physically to fight.... We are pressing further through the court."

ORGY OF VIOLENCE

Five people were feared dead while properties running into millions of naira were destroyed during attacks on six council secretariats as several thugs invaded Eleme, Ahoada East, Obior Akpor, Emohua, Khana and Ikwere LGAs protesting the recently conducted local elections in the state. In Ahoada East, gunmen reportedly killed a man who was said to be the brother of the Chief of Staff to the Government House, Edison Ehie. Also, three individuals were allegedly killed during sporadic shooting in Oyigbo local council. The hometown of the deputy governor, Prof Ngozi Ordu, was not spared as protesters used sticks and iron to destroy plastic chairs outside the complex of the local council.

The violence broke out on Monday after the Inspector General of Police (IGP), Kayode Egbetokun, ordered that the secretariats of the 23 LGAs of the state be unsealed as a group loyal to some political actors laid siege to the councils and prevented the newly elected LG chairmen from entering their offices.


RIVERS GOVT BLAMES POLICE

On Wednesday, the Rivers State Government, through the state Commissioner for Information and Communications, Joseph Johnson, blamed the police for the violence that rocked the various local government areas of the state.

local government areas of the state.

Johnson accused the police of reneging on its responsibility of protecting the lives and property of the citizens, as he described the decision of the police to withdraw from providing security during last Saturday's election in the state as a conspiracy.

"It is to tell you that there is a conspiracy by the Nigerian Police and I put every blame on the Nigerian police for leaving a whole state unpoliced on Saturday," Johnson said.





"It tells you that anything could have happened; it meant 'To your tent, O Israel,' to every resident of the state."

Johnson said that by the constitution, the least job of the police is to protect lives and property of the state but they ignored it.

"I think that the police, who ought to be at the centre of the blame, was not there. And they also know that there are other unseen hands.

"No man can destroy his own house. There is no way the Governor could set any of the councils ablaze, and watch three councils being burnt while there was even an attempt on the Ohio/Akoor council," he said.

POLICE COMMENCE INVESTIGATION

On Wednesday, the Rivers State Police Command announced that it has commenced a full-scale investigation into the post-election violence which rocked some local government areas of the state leading to the loss of lives and burning of three local government secretariats on Monday.

The newly deployed Commissioner of Police, Mustapha Mohammed, disclosed this during an on-the-spot assessment of the three affected LGAs.

Mohammed also disclosed that a high-powered investigation team of seasoned police officers led by the Deputy Commissioner of Police, State Criminal Investigation Department, had been assigned the task, and said the report of the investigation would be submitted to the Inspector General of Police upon completion.

Mohammed said police operatives had begun intensive patrols to build confidence of the residents and reassure them of their safety.

He added that a series of measures had been put in place aimed at ensuring adequate security in the state.

CP Mohammed sued for peace among stakeholders in the state and urged members of the public to collaborate with the police to ensure peace is fully restored in the state.

"I am preaching the gospel of peace to everybody. I am a peacemaker. I am an ambassador of peace. My message to everybody is to let us collaborate to maintain law and order.

"The state is not volatile. There is relative peace and we will continue to ensure public safety. We will collaborate with all critical stakeholders both state and non-state actors, to ensure the safety and security of the entire state," he stated.

LONG-DRAWN BATTLE

The ongoing clash between Wike, the immediate past governor of Rivers State, and his successor, Fubara, has been a subject of interest for a long time with many wondering what is fuelling the conflict. People have argued that Fubara's refusal to be loyal to Wike has caused the rift. Wike has, however, come out to debunk the news. According to Wike, the issue isn't about power struggle, but rather, Fubara's alleged plan to remove the Speaker of the House of Assembly, Hon. Martin Amaewhule, which ultimately backfired. The FCT Minister made this revelation on Channels Television, stating that Fubara's coup attempt "boomeranged" against him. He denied ever demanding money from his successor or interfering with Fubara's governance.

WIKE IS TO BLAME, SAY FRANK, OKPARA

Reactions have, however, trailed the recent turn of events in the state. Former Deputy National Publicity Secretary of the ruling All Progressive Congress (APC), Frank Timi, has accused IGP Egbetokun and FCT Minister Wike of collusion in the recent burning of some local council secretariats in Rivers State.

Frank, in a statement in Abuja, condemned the attacks, saying that the IGP and Wike should resign and be held accountable for violence.

Similarly, former Deputy Speaker of the House of Representatives, Austin Okpara, has also blasted Nyesom Wike for trying to control the structures of the PDP and the APC in the state.

"A man wants to control the APC structure but he wants to be in control of the PDP structure in a state? How do you explain that?" he said during an interview on Channels Television's Sunday Politics.

Okpara, who is a former political associate of the minister, said they are no longer allies.

"We were political associates but now, we are no longer. The point of our disagreement was when he supported APC in the 2023 presidential election at the expense of PDP," he said.

SEARCH FOR PEACE

In the midst of the crisis, political leaders have sued for peace. PDP chieftain, Bode George, called for justice, equity and fairness in the politics of Rivers State, saying he was not interested in taking sides.

Despite the call for peace by the chieftain, a lasting resolution remains almost impossible as both parties have refused to relinquish their grip on the struggle. Genuine reconciliation demands a willingness to compromise and resolve differences, but with neither side willing to budge, peace remains a distant prospect.

Fubara has, however, expressed his desire for peace. He said that he wants peace and he has knelt down to beg many times so that the issue can go.

"There is nothing I have not done on earth for peace to reign. I can tell you the number of times I have knelt down to beg that let us allow this issue to go. I have done everything," he said.

The Rivers State APC governorship candidate in the 2023 election, Tonye Cole, has said that for peace to reign in the state, four persons must sit down to resolve the crisis.

Addressing the political violence that erupted in Rivers State as a result of the recently concluded local government elections, Cole said in an interview with ARISE NEWS on Tuesday that the ongoing unrest stems from deep-rooted internal conflicts dating back to the tenure of former Governor Peter Odili and continuing through the administrations of Amaechi, Wike, and the current governor, Siminalayi Fubara.

"What you're talking about is one internal battle that has started a long time ago, and it's not in isolation. And so, to actually believe that moving forward from now is actually going to bring peace moving forward, I think it's a fallacy. There's no peace that can happen under the present circumstances. And you have to go back to Odili into Amaechi, Amaechi into Wike, Wike into Sim, and you will see that there is a trend that must end, because everybody that is being mentioned here comes from the same nuclear family, splitting up and fighting to the death," Cole said.

"There are four actors here that must be called together to sit down, and until all of them sit at a table and decide that Rivers State is more important than personal agenda or interests, till then, we're not going to have peace. His Excellency Peter Odili, who is the father of everybody in this political dynamic must sit at the table. Rotimi Amaechi His Excellency must sit at that table. Nyesom Wike must sit at that table, and Sim Fubara must sit at that table.

"And the President can superintend this if he really wants peace in Rivers State, and a decision must be made that this is how we are going to be moving forward. Until that is done, as soon as Fubara's time is about to end, you will see another all-out war," he said.

Intercession is for others

herefore he is able also to save them to the uttermost that come unto God by him, seeing he ever liveth to make intercession for them (Hebrews 7:25).

Intercession involves standing in the gap between two parties or more. It is about pleading a case on behalf of someone else, often without their awareness of their predicament or their need for help. For instance, when you intercede for someone who isn't born again, they may not be conscious of their spiritual state or their need for salvation.

In such cases, you are presenting reasons to God on their behalf. You are bringing their ignorance and lack of understanding about their spiritual standing before the Lord. Consider how God described the Ninevites to Jonah—they didn't know right from wrong. But God sent Jonah to them to preach and get them to repent from their wickedness.

Remarkably, the Ninevites, from the king to the common people, took Jonah's message to heart and repented sincerely, fasting and wearing sackcloth as a sign of mourning and penitence. Their collective repentance moved God. In Jonah 4:11 (NIV), after sparing Nineveh, God explained His compassion to Jonah: "And should I not have concern for the great city of Nineveh, in which there are more than a hundred and twenty thousand people who cannot tell their right hand from their left—and also many animals?"

Similarly, when we pray for sinners, we are telling God that they don't understand their situation and their need for salvation. We acknowledge that they deserve God's judgment due to sin, but we plead our case on Jesus' sacrifice for them. We are not persuading God to save them because salvation is already available through Jesus. Instead, we're asking that the Lord will arrange circumstances that will lead them to accept this salvation.

This type of intercession extends beyond the lost to those who, even though are already Christians, may still be ignorant or struggling with their faith. It is about selflessly praying for others; advocating for them in prayer before God, whether they are aware of their need or not.

Dear Father, I pray for those in my world who are yet to receive salvation, that their eyes and hearts be open to receive the Gospel of Jesus Christ. I pray that you'll orchestrate circumstances, situations, materials, and people that'll cause the radiant light of your glorious Gospel to shine brightlv in their hearts, dispelling darkness, and ushering them into the glorious liberty of the sons of God, in Jesus' Name. Amen.

EMEGG calls for Muslims representation in Edo State government

The Edo Muslim for Equity and Good Governance (EMEGG) has made a bold demand for increased Muslims representation in the newly elected Edo State government.

In a recent statement made available to newsmen in Benin City, the state capital, the group emphasized that it is time for Muslims who represent 40-percent population of the state to be recognized for their active participation and contributions during the last election cycle. The group's leadership pointed out that Muslims have been consistent in their calls for fair representation, yet these demands have often been overlooked by previous administrations.

The General Coordinator of EMEGG, Shiekh Sirajudeen Muhammad, noted that Muslims in Edo State played a significant role in ensuring the victory of the All Progressives Congress (APC) in the recent election. He highlighted that while both the positions of Governor and Deputy Governor have already been assigned to Christian candidates, it is now crucial to honour promises of inclusivity made by the Governor-Elect, Senator Monday Okpebholo.

EMEGG is advocating for Muslims to be appointed to key positions, specifically the Secretary to the State Government (SSG) and the Chief of Staff. They argue that these positions are critical to ensuring a balanced and inclusive government that reflects the diverse religious makeup of Edo State.

"Edo Muslims have qualified, experienced, dedicated, committed, and loyal APC faithful who have made significant contributions to the party's success," the group stated.

By appointing Muslims to these roles, the group believes that the Edo State government can foster unity, build trust within the Muslim community, and enhance the state's governance.

The statement concluded with EMEGG's continued support for the Governor-Elect and a commitment to the development of a better Edo State.

According to the statement, "Considering the Muslims will change the narrative of governance in Edo state, build confidence In His Excellency, Senator Monday Okpebholo and APC as a party above all consideration will take Edo state to the promise land"

This call for representation underscores a broader national conversation about the inclusion of religious and ethnic minorities in Nigeria's political processes. The group's demands will likely fuel further discussions about equitable power-sharing as the new Edo administration prepares to take office.

Health workers issue 15-day strike notice effective today to FG over unresolved demands

The Nigerian health workers under the um- brella of Joint Health Sector Unions (JOHESU) have issued a 15-day strike notice to the federal government due to some unmet demands which include pending welfare issues.

This was released in a memo titled "Notice of 15 days ultimatum and resumption of suspended strike action" by the unions to the Coordinating Minister of Health and Social Welfare, Prof. Mohammed Pate on Wednesday.

JOHESU involves the Medical and Health Workers Union of Nigeria, the Nigerian Union of Allied Health Professionals, the Senior Staff Association of Universities, Teaching Hospitals, Research Institutions, and Associated Institutions, and the Non-Academic Staff Union of Educational and Associated Institutions.

The memo which was signed by the National Chairman of JO-HESU, Kabiru Minjibir, and its National Secretary, Martin Egbanubi noted the issue led to the strike that took place from May 19 to June 6, 2023. Following President Bola Ahmed Tinubu's intervention, the suspension was subsequently dropped.

According to INTEL RE-GION, the issues listed by the unions include the adjustment

of the Consolidated Health Salary Structure as was done with the Consolidated Medical Salary Structure since January 2, 2014, the implementation of a consultant cadre for pharmacists in Federal Health Institutions, the upward review in the retirement age from 60-65 years for health workers and 70 years for Consultants, the payment of JO-HESU members in professional regulatory councils.

Others are the payment of arrears of CONHESS review, the tax waiver on healthcare workers' allowances, the immediate payment of COVID-19 inducement hazard allowances to omitted health workers, the immediate suspension of planned establishment and activities of National Health Facility Regulatory Agency, and the withdrawal of the Drug Revolving Fund Standard Operating Procedures.

Nevertheless, the unions demand the immediate implementation of CONHESS adjustment, immediate payment of 25 percent CONHESS review arrears, immediate payment of nine months (January - September 2024) salary to staff of Regulatory Agencies, and immediate restoration of funding to Environmental Health Regulatory Council, immediate reconstitution of Boards/Governing Councils of FHIs, the commencement of the process to upwardly review retirement

age of health workers through Federal Ministry of Health and Social Welfare to the Federal Executive Council.

Other demands include tax waiver on healthcare workers' allowances, immediate payment of COVID-19 inducement hazard allowances to omitted health workers, immediate suspension of planned establishment and activities of NHFRA, withdrawal of the DRF SOP by the Federal Ministry of Health and Social Welfare, and the implementation of approved entry point, call duty and other allowances for holders of Doctor of Pharmacy.

The memo reads, "Consequently, arising from the unanimous resolution of JOHESU Expanded National Executive Council at a hybrid meeting held on 2nd October 2024, and in compliance with the provisions of Section 41 of the Trade Disputes Act Cap.T8 LFN, 2004, JOHESU is constrained to give the Federal Government of Nigeria 15 days ultimatum with effect from Thursday, 10th October 2024, and to inform you that with effect from midnight of Friday, October 25, 2024, all our members in the Federal Health Institutions shall embark on seven days strike action.

"However, if at the end of the seven-day warning strike, the Federal government fails to meet our demands, JOHESU has no other option than to embark on an indefinite strike action.

"Honourable Minister Sir, you

will agree with us that JOHESU has always exhibited maturity, selflessness, and patriotism even in the face of extreme provocations and the government's long delay in meeting these demands of workers under JOHESU and we think that our maturity and patriotism have been taken for granted."

"This 15-day ultimatum is necessitated by the non-response of the Federal Government to the plight of our members, despite our benevolence".

Asthma in Nigeria: The unseen enemy of public health

sthma is a significant health concern Lin Nigeria, affecting approximately 5-10% of the population, which translates to around 10-20 million people.

This chronic respiratory disease poses a substantial threat to the health and well-being of Nigerians, particularly in urban areas where prevalence rates are higher, reaching 13.4% compared to 6.3% in rural areas.

The causes of asthma in Nigeria are multifaceted. Air pollution from vehicle emissions, industrial activities, and biomass burning contributes significantly to asthma development. Indoor air pollution from cooking fuels and tobacco smoke, allergens like dust mites, mold, and pet dander, respiratory infections, and genetic predisposition further exacerbate the condition.

Symptoms of asthma include wheezing, coughing, shortness of breath, and chest tightness.

Effective management involves medication, such as inhaled corticosteroids and bronchodilators, and lifestyle modifications like avoiding triggers and regular exercise.

Despite its prevalence, asthma management faces numerous challenges in Nigeria. Limited access to healthcare services, especially in rural areas, inadequate diagnosis and treatment, high costs of medications and healthcare services, and low awareness and education about asthma hinders effective management. Asthma's impact on Nigeria is staggering, with approximately 1,500 deaths annually, higher hospitalization rates compared to other African countries, and estimated productivity losses of ₹144 billion (approximately \$400 million USD) annually.

To combat asthma's burden, Nigeria requires improved access to healthcare services, especially in rural areas, enhanced diagnosis and treatment capabilities, and increased awareness and education through public health campaigns. Environmental interventions, such as reducing air pollution and improving indoor air quality, are also crucial. Developing national asthma guidelines and policies will help address the challenges and ensure effective management.

The Global Initiative for Asthma (GINA) publishes an annually updated evidence-based strategy for asthma management. However, its implementation in Nigeria is limited due to factors like complexity, unavailability, and unaffordability of asthma medicines, and poor patient adherence to medications 3.

Asthma's impact on Nigeria's health and economy necessitates urgent attention. Addressing the challenges and implementing targeted initiatives can significantly improve asthma management and reduce its burden. By prioritizing asthma care and education, Nigeria can mitigate this growing health concern.

EDSPHCDA sets to improve a culture of positive behaviour change in healthcare delivery

In its commitment to improving a culture of positive behaviour change in healthcare delivery within the primary healthcare sector in Edo State, the Edo State Primary Healthcare Development Agency (EDSPHCDA) has hosted the Primary Healthcare Leadership Challenge Health Retreat in Benin City.

The retreat which aims at reinforcing a sense of ownership of programs and services to drive effective results, took place from Monday, September 30 to Friday, October 4.

The event was supported by the Nigerian Governors Forum (NGF), the United Nations Children's Fund (UNICEF), and the National Primary Healthcare Development Agency (NPHCDA).

Key activities during the retreat included the review of the development of the 2025 Annual Operational Plan (AOP) at both the Local Government Area (LGA) and facility.

Participants were trained on how to effectively fill out essen-

tial templates and present reports on health programs covering the period from January to October (Present). These reports spanned crucial areas such as immunization, nutrition, maternal and child health, reproductive health, and other critical health services. The review provided a platform to harmonize progress, address challenges, and propose actionable solutions moving forward.

Another crucial aspect of the retreat was a mandatory leader-ship course for Medical Officers of Health (MOH) and Directors of Nursing Services (DNS). This course was important to equip them with leadership skills to support their roles in the primary healthcare system.

During the retreat, the Executive Secretary, EDSPHCDA, Dr. Omosigho Izedonmwen, expressed his gratitude to all attendees and emphasized the need to strengthen the primary healthcare system in Edo State. He highlighted the importance of rebranding primary healthcare services, noting that while the buildings are called "Neighborhood Clinics," they offer comprehensive primary

healthcare services.

Dr. Izedonmwen explained that shifting public perception from viewing these services as primarily for the underprivileged is important, a task already underway through the Government's rebranding efforts.

Throughout the retreat, the Acting Director of Planning, Research, and Statistics, Mrs. Esther Ajayi-David and her team, played a key role in moderating the training sessions. She provided technical support and guided participants in data template population and proper reporting techniques.

Seasoned Facilitators from NPHCDA, EDSPHCDA, EDO DIDA, NHIA, and Edo State Ministry of Health led various training sessions. Topics ranged from Data Reporting and Sustainability, Quality Health Service Delivery, Basic Healthcare Provision Fund (BHCPF), Health Insurance, and the Role of Stakeholders in Improving Primary Healthcare among several other lectures. A key session led by the Ministry of Health focused on developing a sector-wide approach (SWAP) to streamline healthcare processes, ensuring that all programs operate under a unified plan and budget to reduce waste and eliminate duplication.

Remembering Nigeria's reggae greats

The reggae revolution in Nigeria wasn't just about the music; it became a powerful voice for the people during a time of great struggle. In the 1980s and 1990s, Nigeria was in the throes of military dictatorships with the consequent human rights abuses, fear, intimidation, and lack of freedom that made life incredibly difficult for many citizens. The absence of democratic rule left the population frustrated and angry over rampant corruption, poverty, and abuse of power. In the face of these challenges, reggae music emerged as a way for ordinary people to express their struggles and dreams for a better future.

Reggae in Nigeria became a form of protest, a musical outlet where the everyday person could voice their frustrations and hopes. Renowned Nigerian reggae musicians of that era include Majek Fashek, Ras Kimono, Sonny Okosun, Orits Wiliki, The Mandators, Maxwell Udoh, Andy Shoreman, Evi Edna Ogholi, Wale Man, Isaac Black, Daniel Wilson, among others. These artists were instrumental in shaping Nigeria's reggae scene with their socially conscious and uplifting messages.

MAJEK FASHEK

Majekodunmi Fasheke, popularly known as Majek Fashek, was one of the most iconic reggae musicians to emerge from Africa. Born in Benin City, Edo State, Nigeria, Majek Fashek's career took off in the 1980s with the release of his groundbreaking hit "Send Down the Rain". This song became a cultural phenomenon, earning him the nickname "The Rainmaker" after it seemed to cause rain whenever he performed it. His music had a deep connection to African spirituality and Rastafarianism. His hit song "Send Down the Rain" was seen by many as a prayer for blessings and relief, carrying a powerful spiritual message about the need for renewal and healing in both the land and the people. Majek often talked about his connection to God and how his music was inspired by the divine, using his songs to call for spiritual awakening and justice.

Majek's 1989 album "Prisoner of Conscience" was both a critical and commercial success, coming at a time many Nigerians were facing political oppression and social difficulties. He gained international recognition by signing with Interscope Records. His other songs include "Spirit of Love" (1991), "Religion Na Politics" (1991), "Love and Affection" (2008), and "Kpangolo" (1997).

However, despite his early success, Majek Fashek struggled with personal

RAS KIMONO

EVI EDNA OGHOLI

Oseloke Augustine Onwubuya, popularly known as Ras Kimono, was a native of Onicha Olona, Delta State. Born on May 9, 1958 in Ekeleke Elumelu, Delta State, Ras Kimono began his career as a student at Gbenoba Secondary School in Agbor before joining the Jastix Reggae Ital band, alongside Majek Fashek, Amos McRoy Jegg, and Black Rice Osagie. His music was deeply shaped by the poverty, inequality, and hardship he experienced during his early years.

Ras Kimono gained significant fame in the late 1980s with his debut album, "Under Pressure", in which he addressed issues like corruption, inequality, and oppression in Nigeria and Africa at large. His songs, such as "Under Pressure", "Rumba Style", and "What's Gwan", were entertaining and enlightening. He was seen as a voice for the oppressed,

using reggae to advocate for justice and peace. He believed that through faith and unity, the people could overcome the oppression they were facing.

For Ras Kimono, reggae was a tool for not only protesting injustice but also for calling people back to their spiritual roots, emphasizing a connection to God and African identity. His influence helped shape the reggae music setting in Nigeria and secured his legacy as one of the pioneers of the genre in the country. His other songs include "Rastafari Chant", "Natty Get Jail", and "Slavery Days".

Kimono was both a voice and a champion for the people, in word and action. Despite the fame he achieved, he never distanced himself from the struggles of the oppressed, choosing to stay close to them to understand their tribulations firsthand. In many interviews, he said Jehovah and the suffering of the common man were his primary musical inspirations.

"I live where the people live so I can witness their tribulations—the suffering and humiliation—so we can put it into our music and reveal it," he once said.

Kimono wasn't just a conscious reg-

gae artist who talked the talk; he genuinely believed in and lived by what he preached. He once remarked, "If I don't expose hardship and injustice, who will do it for the people?"

Ras Kimono who passed on in 2018, now resting among Jah's soldiers in Zion, was a passionate advocate for the masses, using reggae music as a weapon in his lifelong fight for equal rights and justice. His music and impact remain a strong part of Nigeria's cultural and musical history.

SONNY OKOSUN

Another legend was Sonny Okosun, a Nigerian musician who became famous for his unique blend of reggae, Afrobeat, and highlife. Born in 1947 in Enugu, but hailing from Edo State, he was the leader of the band "Ozzidi". Okosun used his music as a platform for activism, addressing issues of oppression, African unity, and the fight against apartheid.

In the 1970s and 1980s, Okosun emerged as one of the leading voices in African music. His hit song "Fire in Soweto" (1977) was a rallying cry against apartheid in South Africa and gained international recognition. Through songs like "Papa's Land" and

"Which Way Nigeria?", Okosun not only celebrated Africa but also called for social justice, peace, and progress across the continent. His other songs include "Mother and Child", "Holy War", and "No More War".

Though he wasn't exclusively a reggae artist, Okosun's music was heavily influenced by reggae's political and spiritual themes. Okosun was also a devout Christian, and in the later years of his career, he shifted towards gospel music.

Sonny Okosun passed on in 2008, but his music continues to inspire, particularly his work that championed the fight for African liberation and unity.

EVI EDNA OGHOLI

Evi Edna Ogholi, known as the "Queen of Nigerian Reggae", was born July 6, 1966. She made her mark onto the music scene in the late 1980s and became one of the first female reggae artists to gain popularity in Nigeria. Her unique sound combined reggae beats with her beautiful voice which made her a standout artist.

Evi Edna's songs spread messages of love, peace, and hope. One of her biggest hits, "Happy Birthday", is still a favourite birthday song for many Nigerians today. Other songs, like "Ririovara" and "Oghene Me", also touched on important social issues, promoting unity and togetherness.

As a devout Christian, Evi Edna Ogholi's faith inspired her music, though her style was different from some reggae artists who followed Rastafarian beliefs. Instead, her songs carried gentle messages about love and kindness, which connected with people during a time when Nigeria was facing many challenges in the 1980s and 1990s.

Even though she took a break from the spotlight for a while, Evi Edna's contributions to Nigerian reggae are still remembered and celebrated. Today, her music continues to inspire fans and reminds people of the power of love and unity.

ORITS WILIKI

Orits Wiliki is one of Nigeria's reggae pioneers known for using his music to speak out against social injustice and inequality. Born in the Niger Delta, Orits Wiliki, who is still very much alive, grew up seeing the struggles of everyday Nigerians, which deeply influenced his music. Songs like "Heart of Stone" tackled issues like corruption and oppression while spreading messages of hope and unity, along with a strong belief in one God (referred to as Jah in Rastafarian culture). Similarly, songs like "Tribulation" and "Fire in the Wire" reflect his belief in the spiritual struggle between good and evil and the need for moral righteousness. Other songs include "10 Commandments", "Wha' Dis Wha' Dat", and "Mubalamumbe".

Throughout the 1980s and 1990s, Wiliki was a key figure in the Nigerian reggae scene. He not only created powerful music but also mentored younger artists, ensuring that reggae's legacy lives on. Even as music trends shifts, Orits Wiliki stays true to his roots, remaining a respected voice in the industry for his commitment to social change and his timeless sound.

'Sex for tracks', Diddy, and the music industry

he music industry, known for its glamour and excitement, conceals a sinister reality. "Sex for tracks", a pervasive scandal, exploits aspiring artists, mostly women, coercing them into trading sexual favours for music opportunities. This exploitative practice has been normalized, leaving victims traumatized and silenced.

Sex for tracks refers to the exchange of sexual favours for music collaborations, recording deals, industry connections, and career advancement. This perpetuates a culture of coercion, manipulation, and silence, resulting in emotional trauma and psychological distress, as well as limited career opportunities.

This syndrome, which just came undone in Nigeria's music industry, speaks volumes about systemic sexual exploitation, where artists are forced to yield to opportune circumstances that demand sex in exchange for tracks. It is staggering how no accountability exists and little support for victims.

It is similar to what artists are said to go through in the American music industry, recently highlighted by the alarming allegations against music mogul Diddy. A closer look at the parallel scandals reveals a systemic problem that is more pervasive and demands urgent attention.

and demands urgent attention.

Three commonalities arise in comparing the "sex for tracks" scandal and the Diddy situation. First, there is a clear power imbalance between someone well established in the industry and new talent; second, that this power is to be nurtured through sexual coercion, meaning the victim is forced to grant sexual favours because of the career opportunities offered; and third, great

silence arising thereafter, for victims might face repercussions of the results and may not speak up.

The Diddy situation has exposed decades-long patterns of exploitation, manipulation, and coercion with industry-wide complicity. But this scandal is just a symptom of a greater problem facing the industry, where sexual exploitation appears to have been normalized, while women and other groups have limited opportunities; gender-based violence at the same time is being condoned and continued in the music industry. Accordingly, there will be several serious implications. These include distrust of the industry, lifelong psychological trauma of victims, reduced creative potential, reinforcement of negative gender stereotypes, and a blow to the industry's reputation

This scourge demands an intervention that is as immediate

as it is concerted. For these reasons, it must involve education and consent workshops, strict policies and codes of conduct, avenues for reporting, support structures, industrywide accountability, and transparency in all ways.

There is the need for a full range of support for the organizations fighting against this sexual exploitation, demanding accountability from industry leaders, and empowering victims to share their stories. It's time to change.

The "sex for tracks" scandal serves as an eye-opener, exposing the dark underbelly of the entertainment business, amidst all the glitz and glamour. It is thus everyone's responsibility to try and ensure that such a systemic problem is dealt with, along with the provision of space for artists that is safe and inclusive, and ultimately restores integrity to the music industry.

Despite the visual flair, the film struggles with its script which at times feels uneven. Certain scenes and dialogue lack the depth to fully capture the characters' emotions and motivations. For example, Funmi's shift from a passive bride to a rebellious woman feels rushed and Femi's decision to abandon his education for a supposed love of sculpting is not well fleshed out. His character is mostly seen using the workshop as a hideaway for secret trysts rather than pursuing any real passion for art.

For Jackenneth Opukeme, "Farmer's Bride" marks an important milestone in his growing career as a director. As the film garners attention and attracts audiences, it raises curiosity about what he'll create next. With only a few projects under his belt, Opukeme shows promise and his future in Nollywood is one to watch.

Nollywood's dirty secret: Sexual exploitation of up-and-coming actresses

he glamour of the entertainment industry often conceals a sinister reality. Sexual exploitation of actresses is a pervasive problem that transcends geographical boundaries, affecting women in Nollywood, Hollywood, Bollywood, and beyond.

According to New York Times, over 38 women have accused writer-director James Toback of sexual harassment.

In 2004, Bollywood filmmaker Madhur Bhandarkar was accused of rape by actress Preeti Jain, who alleged that the filmmaker raped her 16 times for a role in his film.

This corrupt culture, popularly known as casting-couch syndrome, isn't just a Hollywood or Bollywood problem. No-

llywood, Nigeria's thriving film industry, has a dark underbelly: the exploitation of female actors. This shocking reality was highlighted by veteran actress Blessing Egbe, known for hits like "The Women" and "Lekki Wives", in 2019.

In an exclusive interview with Pulse Nigeria, Egbe shared her harrowing experience with a prominent producer/marketer.

"He walked in, looked at me for a while, and said, 'Nna, this girl will be very good for epic film ooo..." Egbe recounted. "I returned his words with a polite smile, which he mistook for softness. Next thing, he came to me and started to caress me."

Egbe's response was swift and decisive: "The push slap that followed shocked the other producer, who exclaimed, 'Ah, Blessing, that is big mar-

keter o!' And my reply? 'And so what?'"

This disturbing incident is not an isolated case. Many up-and-coming actresses face similar exploitation, often under the guise of "discussions" or "meetings" in secluded locations.

A typical scenario plays out like this: an older actor or industry figure asks a young actress to meet for a "discussion". When she expresses hesitation or asks why the meeting can't take place in a more public setting, she's often met with resistance or even intimidation.

For instance, a young actress may receive a message like: "Come to this hotel to discuss your next project." When she seeks advice from a trusted friend or mentor, the response is often: "Why must it be in a hotel? And why must you go alone?"



Despite the absence of star striker Victor Osimhen, Eguavoen expressed confidence in the other forwards available to him.

Meanwhile, the Honourable Minister of Sports Development, Senator John Owan Enoh, has warned the Super Eagles not to underestimate their North African opponents. Speaking ahead of the match, which will take place at the Godswill Akpabio Stadium in Uyo today at 4:00 pm, Enoh stressed the need for caution in a statement released by his spokesperson, Diana-Mary Nsan saying, "The Mediterranean Knights will be

coming with the intent to at least secure a draw in Uyo.

As the Super Eagles prepare to take the field, both Eguavoen and Enoh have urged the team to stav focused, with the nation rallying behind them in their quest for early AFCON qualification.

Notably, Eguavoen now has all

AFCON 2025: NFF dismisses alleged poor treatment of Libya players, officials

→he Nigeria Football Federation (NFF) has rejected claims of poor treatment by Libya captain Faisal Al-Badri.

The NFF insisted that the Libyan Football Federation (LFF) created chaos for its team, the Mediterranean Knights.

NFF's Assistant Director (Protocol), Emmanuel Ayanbunmi, said the Libya Federation only informed the NFF that its team was landing in Port Harcourt, and not Uyo, only three hours before the team's arrival on Tuesday.

Ayanbunmi added that the Libyan delegation jettisoned road transportation arrangements made for them by the NFF and instead hired buses

on their own.

"If they travelled on buses that were not air-conditioned, that had nothing to do with the NFF as they hired their own buses," he stated.

"We provided security for them, with men and vehicles in front and behind their buses, so we are unmoved about their complaints and threats."

Top 5 contenders for 2024 Ballon d'Or: Ceremony date, time announced

The Ballon d'Or, an annual football award presented by France Football, is widely regarded as one of the most prestigious individual accolades in the sport.

First awarded in 1956, with Stanley Matthews of England and Blackpool as its inaugural recipient, the honor recognizes the best footballer each year.

Lionel Messi is the most recent winner, having secured the award ahead of top contenders like Erling Haaland, Kylian Mbappe, Kevin De Bruvne and Rodri Since 2008 Messi and Cristiano Ronaldo have

largely dominated the Ballon d'Or, winning 13 titles between them-Messi with a record 8 wins, including last year, and Ronaldo with 5. However, for the 2024 edition, both players are considered unlikely to feature prominently in the race.



Based on a recent fan poll conducted on the Ballon d'Or's official website, here are the top five players currently leading the race for the 2024 award:

1. Vinicius Jr. (Real Madrid): The Brazilian winger leads the poll with 64.6% of the fan votes, largely thanks to his stellar form last season. He scored 15 goals in 26 La Liga matches and 24 goals in 36 games across all competitions, contributing to Real Madrid's triumphs in La Liga, the UEFA Champions League, and the UEFA Super Cup.

2. Lautaro Martinez (Inter Milan): The Argentine striker ranks second with 8.2% of the vote. Martinez had a prolific season, scoring 27 goals in 44 appearances for Inter Milan, including 24 goals in Serie A. He also netted 8 goals for Argentina in 2024 and won numerous accolades, such as the Copa America Golden Boot, Serie A MVP, and Serie A top scorer.

Former Barcelona and Spain legend Injesta retires at 40

Former Barcelona midfielder Andrés Iniesta, a key figure in Spain's illustrious football history with two European Championships and a 2010 World Cup title, announced his retirement from football on Tuesday at the age of 40.

"Being on the pitch is over.
"I can't stay away from football; it's my life and will continue to be my life. Now, I need to continue my education.

I'm currently working on my coaching diploma, and that's my next step," Iniesta said, visibly emotional, during a news conference in Barcelona.

He added, "I will try to come back and do a great job, but it won't be by running after the ball; it will be from a different perspective."

Iniesta rose through the ranks at Barcelona's prestigious La Masia academy, making his firstteam debut in 2002 at just 18 years old. He became a pivotal figure in the midfield, remaining with the club for 16 years. During his time at Barcelona, he secured nine La Liga titles and four Champions League trophies.

However, his most memorable moment came in the 2010 World Cup final when he scored the decisive goal against the Netherlands in extra time.

After leaving Barcelona in 2018, Iniesta played for five years with Japanese club Vissel Kobe before concluding his career with a final season at Emirates in the UAE.

African Nations Championship: Ghana to clash with Nigeria for spot in 2024

hana to clash with Nigeria for a place at the 2024 African Nations Championship (CHAN) after the West African rivals were paired together at the Wednesday's qualifying draw.

Recall that the teams previously met before the 2022 finals, with Ghana emerging victorious via a penalty shootout following a 2-2 aggregate draw.

A total of 42 teams are competing for spots in the 2024 tournament, which focuses on domestic-based players across Africa. The entrants have been divided into six regional zones.

Five of these zones will produce three qualifiers each, however, the Cecafa region has been allocated a fourth qualifying spot, as Kenya, Tanzania, and Uganda will participate in the preliminaries despite having qualified automatically as joint hosts. According to the Confederation of African Football (CAF), the team with the

"best result in the Cecafa qualifiers" will secure advancement

As a result the finals, which will be held from February 1 to 28, 2025, will feature 19 teams - an increase on the 18-team 2022 edition.

The regional qualifiers will be conducted over two rounds, with home-and-away matches, concluding with the second round set for December 27-29. Notably, two-time champions Morocco, 2011 titleholders Tunisia, and 2014 winners Libya are the only representatives from North Africa and are guaranteed places in the finals.

Defending champions Senegal will meet either Sierra Leone or Liberia in the second round of qualifiers. Additionally, CAF has increased the prize money for the 2024 finals by 60%, with the winning team set to receive \$2 million (£1.53 million).

The 2024 CHAN finals will be hosted in Kenya, Tanzania, and Uganda, serving as a preparatory event before these East African nations host the 2027 Africa Cup of Nations



Greece international, George Baldock dies at 31

Ingland-born Greece international George Baldock was found dead in the swimming pool of his house in Glyfada, Southern Athens on Wednesday

According to reports Baldock signed for Panathinaikos this summer after a seven-year spell at Bramall Lane, making his debut in August.


The Greek club posted a tribute on Instagram, writing: "We are shocked, we are shocked by the loss of our George. Pana-

Petrol price hike, tithe-mongering and allied matters

The biggest news in Nigeria this week was the hike in the pump price of Premium Motor Spirit (PMS), otherwise known as petrol. What this means is that within a space of about 18 months Nigerians have moved from buying petrol at about N195 to above N1,000 currently.

The pump price of petrol jumped to between N448 and N557 per litre on May 29, 2023 when Tinubu, in his inaugural speech, uttered the now damning verdict: "Subsidy is gone!" The petrol price would eventually edge up to N617, N897, and now N998 in Lagos, N1,030 in Abuja, N1,025 in other South-West states, and N1,045 per litre in the states of the South-East.

I don't intend to go into the economics of it all or even the wrangling between Dangote Refinery and the Nigerian National Petroleum Company Limited (NNPCL) over crude sales and pricing. Up until Wednesday officials of Dangote Refinery were still debunking reports that the latest petrol price hike was triggered by an increase in the ex-depot price of the product at the refinery. This came after online reports claimed that Dangote Refinery had raised the price of petrol to N977/litre, prompting NNPC to also push up its rate.

Whatever the case, the reality is that for every time the price of petrol goes up, more Nigerians are thrown into poverty. Somehow, petrol is at the centre of virtually every economic activity in Nigeria. Whether you are moving from place to place or you're powering your generators so as to provide electricity for yourself where the government has failed to do so, petrol is at the centre of it all. So, it is not surprising that whatever happens to petrol affects transportation cost, prices of goods and services and everything in-between. The market woman selling fish or vegetables or pepper and tomatoes will factor in transportation cost in fixing the price of her commodity. So, get ready to pay more for that plate of nkwobi or isiewu as you go to indulge yourself this weekend.

What is even more troubling, and that is the irony, is that this is coming from a government that ran its campaign on the promise of Renewed Hope. A look at the faces you see on the streets every day will tell you that there is no one person whose hope has been renewed by this government. If anything, even the faintest iota of hope that Nigerians were hanging on during the eight harrowing years of Baba Go-Slow has been completely wiped by the government of T-Pain. Indeed, as some people have observed, this is an era of renewed shege. And the shege is not raining, it's pouring.

For so long, the Tinubu administration has been promising to cush-



ion the impact of petrol subsidy removal by introducing Compressed Natural Gas-powered vehicles as an alternative. So far, it appears that it's more talk and less action. True, we have seen pictures and read reports of CNG-powered vehicles being launched. The reality on ground, however, is that the surface has yet to be scratched.

Questions have been asked about why this administration is so focused on petrol. If it is not talking subsidy removal today, it is talking petrol price the next day. But in case the President and those around him do not know, Nigerians are going through the toughest times ever. Nigerians have been pushed to the wall by the policies of this government. It has gone beyond breaking point. Someday soon, something may give. What will that be, I don't know.

I have heard some people talk about a revolution, and my response has been that it will not happen. Even those talking about revolution know that it won't happen. My reason is simple: those calling for a revolution always find a way to remove themselves from it, to push it to others as if there are those whose heads are good for the bullet. We keep kicking the can down the road. We all understand that the cat needs to be belled for the rats to be safe, but the crux of the matter is, who will bell the

of petrol turns into an opportunity for some Nigerians to show others that they are bigger than everyone in the neighbourhood. In case you don't understand, in the coming days just watch out for those who would drive into the filling station and ask the attendant to "fill up my tank", shifting their shoulders from place to place so that others would see. AC is on. Some would challenge you to do the same if you say you're a big boy or big girl. Watch out for those in the neighbourhood who will run their generators through the night if even there is power supply from the national grid. These may become the new yardstick to measure the big boys and the big girls in the neighborhood.

The news of the petrol price hike has naturally drowned all other issues that were in the pubic domain in the recent weeks. Before now, there was the case of Very Dark Man versus Bobrisky versus the Falanas and other matters in-between.

And then there was the issue of one father in the Lord taking back his words on the controversial issue of tithing. Sometime in 2018, this same father in the Lord told his congregation that those who refused to pay their tithe will not go to heaven.
