Resolution coming for \$1.3bn Shell-Renaissance divestment, says Olu Verheijen

The special adviser to President Bola Tinubu on energy, Olu Verheijen, has indicated that regulatory issues surrounding Shell's proposed sale of its Nigerian onshore assets to the local concern, the Renaissance Consortium, should soon be resolved.

"I am sure that in short order it will be resolved with the regulator in a way that addresses our as Nigeria seeks to rev up crude production, boost economy own objectives to continue to ac-

celerate exits for international oil companies," Verheijen said during a call with the energy reporters' association on Wednesday, according to Bloomberg.

On January 16, Shell Petroleum Development Company of Nigeria Limited (SPDC) announced plans to sell its Nigerian onshore oil assets to a consortium of local

companies for over \$1.3 billion.

The consortium, known as Renaissance, is formed by local firms including ND Western, Aradel Energy, First Exploration & Production (E&P), Waltersmith, and Petrolin.

On October 21, Gbenga Komolafe, the chief executive officer (CEO) of the Nigerian Upstream Petroleum Regulatory Commission (NUPRC), had approved four divestment deals.

The four deals that received ministerial consent were Eni's divestment of Nigerian Agip Oil Company (NAOC) to Oando Plc, and Equinor Nigeria Energy Company Limited's divestment to Project Odinmin Investments Limited.

Others are the TotalEnergies-Telema Energies deal and

said the Federal Government ExxonMobil's sale of Mobil Producing Nigeria Unlimited

(MPNU) to Seplat Energy. However, Komolafe said the divestment of Shell's assets to Renaissance Africa Energy Company Limited could not scale regulatory test.

Speaking during the call, Verheijen told journalists that Nigeria's government wants to ensure that smaller companies that take over fields from major oil producers are able to invest adequately.

"For the independents who are coming in onshore, we want to make sure that they align with our objectives of rapidly growing production," she said.

The special adviser said there is a need "to ensure that there is a technical and financial capacity and that some of the obligations that need to be addressed are being addressed".

Court halts FG allocation to Rivers Govt

Federal High Court in Abuja presided over by Jus-Ltice Joyce Abdulmalik has stopped the Central Bank of Nigeria (CBN) from further releasing monthly financial allocations to the Rivers State Government.

Justice Abdulmalik held that the receipt and disbursement of monthly allocations since January this year by the Rivers State Governor, Siminalayi Fubara, was a breach of the Constitution and an aberration that must not be allowed to continue.

The judge held that the presentation of the 2024 budget by Fubara before a four-member Rivers House of Assembly was an affront to the constitutional provision.

She said that the governor's action was a gross violation of the 1999 Constitution.

The judge subsequently restrained the Central Bank of Nigeria, the Accountant General of the Federation, Zenith Bank

and Access Bank from further allowing Fubara to access money from the Consolidated Revenue and Federation Account.

Earlier in October, the Court of Appeal in Abuja affirmed the judgment of the Federal High Court which set aside the N800 billion budget passed by five members of the Rivers State House of Assembly which was led by Edison Ehie-led.

The appellate court dismissed the appeal filed by Fubara on grounds that it lacked merit.

The court held that Fubara withdrew his counter-affidavit at the lower court in the matter and as such cannot commence an appeal in a matter he did not challenge at the trial stage.

In the unanimous judgement, the court said that Governor Fubara is expected to apply the rule of law and not the rule of might.

The court further says that the situation in Rivers State House of Assembly is an executive dictatorship by the governor and a joke taken too far.

Two arrested over kidnap of Catholic priest in Edo State

wo suspects have been arrested in connection with the abduction of a Catholic church Priest, Rev. Fr. Thomas Ayode, in Edo State.

This was disclosed by the Edo State Commissioner of Police, Umoru Ozigi on Wednesday while parading seven suspects arrested for various crimes.

According to Ozigi, the suspects were arrested across the state for armed robbery kidnapping, cultism, and car snatching among others.

The Police Commissioner said, "The command has responded to the unfortunate incident of the kidnap of Rev. Fr. Thomas Ayode by rejigging the security architecture in the area in synergy with the Community through the deployment of a unit of the Police Mobile Force.

"Two suspects have been arrested in connection with the kidnapping of the Reverend Fa-

Ozigi said that efforts were ongoing to rescue the cleric, apprehend other suspects and bring them to justice.

He assured that all the arrested suspects would be charged in court as soon as the investigation is concluded.

Reverend Ayode, who is also the Rector, Immaculate Conception Minor Seminary School, Ivanokpodi, in Agenegbode, Etsako East Local Government Area of Edo State was kidnapped last Sunday by gunmen suspected to be kidnappers.

The kidnappers are demanding a N200 million ransom.

Court grants Reps member Ikwechegh ₩500,000 bail on assault charge

Magistrate Court sitting in Kuje has granted bail to a House of Representatives member for Aba North and South, Alex Ikwechegh, in the sum of N500,000 and two sureties in like sum.

In a brief ruling, the Presiding Judge, Abubakar Sai'id, said the sureties must reside within the court's jurisdiction and provide utility bills as proof of evidence.

The charges brought against him include abuse of office, as sault, and threat to life.

He pleaded not guilty when it was read to him.

His counsel, thereafter, made an oral application for bail which was granted by the court.

The case has been adjourned to November 8, 2024.

General Oluyede participated in several operations, including the Economic Community of West African States Monitoring Group (ECOMOG) Mission in Liberia, Operation HARMONY IV in Bakassi, and Operation HA-DIN KAI in the North East theatre of operations, where he commanded 27 Task Force Brigade.
