### Nigeria's 264 dams back in focus as nation pursues year-round farming

### as dry season knocks

Tigeria's dry season which typically lasts for five months (from November to March) is setting in, bringing with it concerns and prospects around food production, transportation and prices, in a year which has seen charges for both essentials rising astronomically and impacting cost of living.

The dry season also highlights the condition of Nigeria's 195,000-kilometre network of roads,(65 percent of which are unpaved) which are softened,

sometimes into disrepair by torrential rains, impacting transportation and the cost of goods and services, especially food.

The dry season also opens a window for reconstruction and repair of roads and for evaluation and impact of similar work done in the previous season.

Of particular concern as this year's dry season kicks off is the extent of the deployment of Nigeria's 264 dams for irrigation as the Federal Government undertakes to ramp up food production by boosting dry season farming under the National Agricultural Growth Scheme

Agro-Pocket (NAGS-AP) Pro-

The First Phase of the Dry Season Farming was launched in November 2023. It focuses on the cultivation of wheat across 15 wheat-producing states, covering 118,657 hectares and involving 107,429 farmers.

Phase 2 of the Dry Season Farming was tipped to cut across all 36 states of Nigeria and Federal Capital Territory (FCT) and cover staples including rice, maize, and cassava.

For rice, the target is 250,000

# Zenith, GTB, 4 others pay N537bn tax in 9 months amid N3.2trn windfall

### loans and advances hit N35trn

### personnel expenses surge by 85%

mid a profit windfall occasioned by the humongous gains realised from forex, six deposit money banks in Nigeria have paid a total of N537.45 billion as tax to the Federal Government in the first three quarters of 2024. Their income during the period was further boosted by the hawkish stance of the Central Bank of Nigeria (CBN) which raised the benchmark interest rate, the Monetary Policy Rate (MPR), to 27.25 percent in a bid to taper inflation.

The Nigerian Observer's analysis of the banks' nine months audited financial results for the period ended 30 September 2024 showed that the amount paid as tax represented an increase of 119 percent when compared to N245.39 billion the same banks paid as tax in the corresponding period of 2023.

The banks under coverage include the tier-one giants, Zenith Bank, First Bank, United Bank for Africa (UBA) and Guaranty Trust Holdings. The other tier-two banks are F ty Bank and Wema Bank.

The surge in banks' tax expenses came on the heels of the proposed windfall tax through which the Federal Government

seeks to tax bank's foreign exchange gains to the tune of about 50 percent. The floating of the Naira, which caused its value to depreciate from about N466 as of June 2023 to about N1600 as of September bolstered banks' earnings, especially those that have FX assets.

"It appears the FGN has looked to other countries that have also imposed a windfall tax i.e., a special tax imposed on specific industries where macroeconomic events have allowed players in the industry to recognise greater than average profits," Deloitte, one of the leading accounting and consulting firms in Nigeria, said in an assessment note of the policy.

"For instance, in May 2022, the United Kingdom introduced a windfall tax of 25% on energy profits. This was further increased to 35% in January 2023. Also, on 8 August 2023, Italy imposed a windfall tax on profits earned by banks from high interest rates to assist mortgage holders," Deloitte

Zenith Bank paid the highest amount of N1/5.56 billion as tax in Q3 2024, an increase of 147.8 percent when compared with N70.86 billion the same bank paid during the corresponding period of 2023.

Deeper dive analysis of its third quarter results showed that the bulk of the tax paid was corporate tax, N105 billion, followed by tertiary education tax, N29 billion. Others include inforbillion, and national fiscal stabilisation levy, N5.7 billion, among others.

Guaranty Trust Holdings (GTCo) paid the second high-

mation technology tax, N8.3 est tax of N134.46 billion in the nine-month period ended September 2024. This amounted to an increase of 104.4 percent when compared with N65.79 billion paid in the same period

hectares involving 500,000 farmers with the expected output of 1 million metric tons of paddy rice, according to information from Mr. Bayo Onanuga, Special Adviser to the President on Information and Strategy.

For maize, the target is 55,000 hectares with 110,000 farmers, thereby adding 165,000 metric tons to national maize production, while for cassava, the target is 35,000 hectares with 70,000 farmers to produce 525,000 metric tons of cassava.

However, industry watchers think government needs to ramp up action on the deployment of the nation's 264 dams for farm irrigation to facilitate year-round cultivation and harvests

The Federal Government had said last October that it had concluded arrangements to partially commercialise all the dams under the nation's 12 river basins to enable them effectively deliver their mandates.

Prof. Joseph Utsev, Minister of Water Resources and Sanitation, had disclosed this while addressing newsmen shortly after inspecting the Tiga Dam in Bebeji Local Government Area of Kano State, but little has been heard of the project since then.

The minister had said that the commercialisation of the basins would enable them to generate more revenues for the Federal Government.

He gave the assurance that the huge infrastructure available at the basins would guarantee a return on investments.

Utsev explained that the exercise would ensure sustainable operations and management of the infrastructure at the dams.

"The basins have huge infrastructure like water supply schemes, dams, and irrigation that require good funding to be able to keep them running and to provide dividends for Nigerians." he said.

He said the Federal Government was ready to partner with commercial farmers to pave the way for massive production of assorted food crops in an all-year farming system.

Meanwhile, industry groups

have said that better attention to the nation's 264 dams which are currently poorly applied to crop irrigation would open a window to increasing food production and lowering prices.

"Farmers in Nigeria have been impacted by the lack of access to water to the extent that there is no real enabling environment for sustainable all-year-round agricultural production in the entire country," said Ibrahim Kabiru, national president of the All Farmers Association of Nigeria.

Despite the push for increased local food production, most dams across the country are still dysfunctional and irrigation schemes are not working, Kabiru said.

Experts say Nigeria's several dams will boost food production, lower prices to table and reduce dependency on food imports if properly serviced and managed.

They add that food production would increase significantly, as cultivation and harvesting could be conducted twice a year for some crops and three times a year for others, especially as many crops grown in the country, including maize, beans, tomatoes and other fruits, vegetables and some varieties of legumes mature in three months.

They say that dams that provide irrigation year-round would further attract investment into mechanised farming and food processing from home and abroad, as well as create jobs and encourage foreign exchange earnings from food and other farm produce exports.

Furthermore, they say, there would then be opportunities and incentives for increased levels of fish farming.

"The farmers will be better served by improvement in the utilisation of existing dams than even building new ones," Kabiru said.

Nigeria has a total of 264 dams with a combined storage capacity of 33 billion cubic metres (BCM) of water for multipurpose uses, of which 210 are owned by the Federal Government, 34 by the states, and 20 are owned by private organisations, according to the Federal Ministry of Water Resources.

company of First Bank of Nigeria Limited, paid N84.58 billion as tax, an increase of 150 percent when compared with N33.83 billion paid as tax during the same period in 2023.

UBA paid N78.17 billion as tax, representing an increase of 48.1 percent when juxtaposed with N52.80 billion paid as of September 2023.

Fidelity Bank paid N56.81 billion just as Wema Bank paid N7.88 billion as of September 2024, amounting to an increase of 195.3 percent and 174 percent respectively when compared with N19.24 billion and N2.88 billion the two banks

made as of September 2023.

All the six banks cumulatively realised N3.24 trillion as profit after tax as of September 2024, an increase of 103.1 percent when compared with N1.59 trillion realised as of September 2023.

GTCo made the most profit of N1.09 trillion, which is higher by 195.3 percent than the N367.42 billion realised as of September 2023. Zenith Bank realised N827.28 billion in Q3 2024 as profit after tax, an increase of 90.5 percent over N434.17 billion profit made in similar period in 2023.

First Bank realised N526.28 billion profit in Q3 2024 as against N230.05 billion in Q3 2023; UBA made N525.31 in Q3 2024 as against N449.30 billion as of September 2023; Fidelity Bank made N224.60 billion profit as against N91.75 billion as of September 2023 while Wema Bank made N52.74 billion profit compared with N19.24 billion in Q3 2023.

Personnel expenses of the six banks under coverage rose by 84.6 percent from N397.68 billion in Q3 2023 to N734.09 billion as of Q3 2024. The highest increase in personnel expenses was at UBA whose employees received N225.42 billion as compensation compared with N111.11 billion in Q3 2023.

GTCo employees received N71.53 billion as against N37.58 billion in Q3 2023. Zenith Bank

paid its employees N150.67 billion in Q3 2024 as against N88.43 billion as of September 2023.

Fidelity Bank paid its employees N43.60 billion as against N30.31 billion in Q3 2023 while Wema Bank paid its employees N32.47 billion compared with N19.04 billion in the corresponding period of 2023.

Loans and advances administered by the six banks increased by 46.2 percent to N34.72 trillion as of September 2024 as against N23.74 trillion as of September 2023. This is against the deposits mobilised by the same banks which rose to N80.32 trillion compared with N52.22 trillion in the corresponding period of 2023.

### Tinubu, Akpabio, Uzodimma pour encomiums at Iwuanyanwu's funeral • as Imo govt names IICC after late Ohanaeze leader

resident Bola Tinubu, Imo State governor, Hope Uzodimma, and other prominent Nigerians at the weekend described the late President of Ohanaeze Ndigbo Worldwide, Chief Emmanuel Iwuanyanwu, as a colossus of no mean proportion who lived a life of service to humanity and God until his last day on earth.

funeral service of Chief Iwuanyanwu at the Cathedral Church of St. Matthew, Atta in Ikeduru Anglican Diocese, where torrents of remarks from the high and mighty who attended the event pointed to a man whose legacy of service in his community, state, region and country speaks volumes.

President Tinubu, represented by the Secretary to Governtor George Akume, described Iwuanyanwu as one who served the country in many official capacities, noting that "the nation mourns him as an illustrious son of Nigeria".

"Chief Emmanuel Iwuanyanwu was courageous, defiant of injustice, and uncompromising; he had the heart of a gladiator, resolute and indomitable," said

"Chief Emmanuel Iwuanyanwu was enterprising, believed in Nigeria's human and material abundance and fecundity and his investments cutting across sectors and the nation attest to this. He lived a life of service with his wealth, served his people and the nation at large," he said.

Tinubu commiserated with Iwuanyanwu's family, the government and people of Imo State, and Ndigbo at large over

In his address, Governor Uzodimma commended the late sage for his legacies in different aspects of life, saying Imo State owes Iwuanyanwu a lot for his contributions to the wellbeing of the people and the state.

To show gratitude to Chief Iwuanyanwu for his contributions to Imo State in particular, Governor Uzodimma named one of his ongoing ambitious projects, the Imo International Conference Centre (IICC) in Owerri, after the departed Ohanaeze leader.

He thanked his brother governors of the South East for coming together to provide leadership that made the funeral rites of Chief Iwuanyanwu seamless.

Uzodimma said that the gathering was not necessarily to mourn the late President General of Ohanaeze Ndigbo Worldwide, but to celebrate a man who gave his life and resources to the service of God and humanity, emphasizing that "his legacies live on".

Senate President Godswill Akpabio, represented by Senator Enyinnaya Abaribe, described Iwuanyanwu as "a trailblazer and friend of all who touched lives of people by being involved in different aspects of lives endeavour".

"Chief Emmanuel Iwuanyanwu was a patriot, a nationalist, a detribalised Nigerian who believed in the unity of the country encompassed in justice, equity and fair play," he said.

Akpabio condoled with the family and all those affected by the demise of the President General Ohanaeze Ndigbo Worldwide.

Earlier in his sermon, the Primate and Metropolitan of All Nigeria (Anglican Communion), the Most Revd. Dr. Henry Ndukauba, enjoined the congregation to serve the purpose of God in their lives.

He enjoined the Iwuanyanwu family to immortalize him by living as one united family even as he prayed that God will "raise another patriot who will lead Ndigbo honestly, sincerely, and selflessly".

Ndukauba advised President Tinubu to convoke a conference of the citizens of Nigeria to discuss issues concerning the welfare of the citizens.

He reminded the audience that there is God's purpose for every man and family, and that all humanity is created from one blood, enjoining all to endeavour to live a life of sacrifice "because after death there will be judgement before God".

### Cybercrimes, hacking: Police arrest 17 Nigerians, 113 foreigners

¶he Nigeria Police operatives have arrested 130 suspects for cybercrimes and hacking. The suspects include 17 Nigerians and 113 foreign nationals, Force spokesman, Olumuyiwa Adejobi, said yesterday in a statement, saying their activities threaten national security.

"This strategic operation was conducted through a coordinated raid on a building at the Next Cash and Carry area of Jahi, Abuja, where the suspects were reportedly using computers and other sophisticated devices to facilitate criminal activities," he said.

"The operation which was led by the Assistant Inspector-General of Police for Zone 7 Headquarters, Abuja, AIG Benneth Igweh, on Saturday, 3rd November 2024, comprised officers of the Nigeria Police Force Zone 7 Command Abuja and the National Cyber

Crime Centre (NPF-NCCC)."

He said the Force is still investigating the matter, adding that the exhibits recovered from the suspects were being analysed scientifically.

Force spokesman added that the suspects would be charged to court upon conclusion of investigations.

Other appointees are Dr. Jumoke Oduwole as Minister of Industry, Trade and Investment (Trade and Investment); Idi Mukhtar Maiha as Minister of Livestock Development; Yusuf Abdullahi Ata as Minister of State for Housing and Urban Development, and Dr. Suwaiba Said Ahmad as Minister of State for Education.

According to Onanuga, "President Bola Tinubu will swear in the new seven ministers tomorrow Monday. The Ministers are: Dr Nentawe Yilwatda - Minister of Humanitarian Affairs and Poverty Reduction; Muhammadu Maigari Dingyadi - Minister of Labour & Employment; Bianca Odinaka Odumegwu-Ojukwu -Minister of State Foreign Affairs.

"Others are Dr Jumoke Oduwole - Minister of Industry, Trade and Investment (Trade and Investment), Idi Mukhtar Maiha - Minister of Livestock Development; Yusuf Abdullahi Ata – Minister of State, Housing and Urban Development and Dr Suwaiba Said Ahmad Minister of State Education.

"The Senate cleared the ministers last week".

Last month's cabinet reshuffle by the President came after months of growing calls from Nigerians for change.

President Tinubu's administration has been working to address the country's challenges, and these new appointments are expected to bring fresh perspectives and expertise to their respective ministries.

### EDHIC trains volunteers to drive health insurance | Any end to cultism in Edo? enrollment through new canvasser model

he Edo State Health Insurance Commission (EDOHIC) has launched a training session for a team of volunteers, equipping them with essential knowledge and sales techniques to effectively promote the Edo State Health Insurance Scheme.

The training session held at the John Odigie Oyegun Public Service Academy (JOOP-SA) aims at boosting the health insurance enrollment scheme across the three senatorial districts of Edo State.

The event marks the first implementation of the Canvasser Model within the state's health insurance programme, with the sole focus on driving a more grassroots approach to healthcare access and awareness.

At the training, the volun-

teers received a comprehensive overview of the categories of health insurance available. along with the criteria and exemptions involved. The primary objective of the session was to prepare them to engage directly with residents, providing information on the scheme and encouraging enrollment.

The training began with a session focused on the distinctions within Edo State's health insurance infrastructure. Volunteers were introduced to the EDHIC and the Edo State Health Insurance Scheme (EDOHIS).

It was explained that EDHIC established by law in 2019 is the governing body overseeing EDOHIS, and it plays a regulatory role ensuring the programme operates smoothly and reaches the people who need it most. While EDHIC provides oversight, EDOHIS is responsible for delivering affordable healthcare to Edo residents.

The training also covered the main components of the scheme which include enrollment, capitation, and care provision. The session highlighted how these three pillars interact to ensure healthcare accessibility. Through the commission, care is delivered by health service providershospitals and primary healthcare facilities-while those enrolled as "enrollees" under the insurance scheme can access these services when needed.

The volunteers were trained specifically to promote the scheme's paying plans, as opposed to its equity plans. The paying plans require payment, which supports the scheme's long-term sustainability, while the equity plans offer free coverage for certain demographics.

According to a representative of the commission, the equity plans are allocated based on a checklist of criteria designed to identify and assist those who cannot afford healthcare services. However, volunteers will concentrate on encouraging residents to join one of the five paid categories: Student Plan; Gold Plan; Silver Plan; Bronze Plan, and Enhanced Plan.

Mr. Ekpen Odemwingie, the session's second trainer, provided insights into effective sales strategies. He emphasised the importance of building relationships with prospects as a first step, noting that health insurance is more readily accepted when a level of trust and familiarity has been established. He also stressed the need to understand specific audiences by knowing their demographics, buying habits, among relevant factors.

Dr. Owen Stephen Omorogbe, Director of Planning, Research and Statistics of the Edo State Health Commission, praised the new initiative and underscores the Edo government's commitment to expanding health insurance outreach.

ultism in Edo State has been a persistent issue but took a new dimension since after the September 21 election, with various groups perpetrating violence and crime. Owing to this fact, some people refer to Edo State as" the home of Cultism."

A lot of cult wars and clashes have taken place over the years, killing so many people, some of whom are innocent. Earlier this year, the Edo State Special Task Force on Anti-Cultism arrested 11 suspected cultists, including leaders of notorious groups, in a bid to curb the menace. This move is part of Governor Godwin Obaseki's efforts to restore peace and security in the state.

The task force has demonstrated unwavering commitment to ridding the state of cultism. Initial efforts focused on education and persuasion, engaging with communities and stakeholders to dissuade youths from joining cults. However, the task force has now shifted its focus to making arrests and prosecuting cult members.

Three suspected cultists were arrested within the Auchi Polytechnic community on August 7, 2024, massive show of force was conducted in Benin City on August 10, 2024, resulting in the arrest of two suspects and a key cult leader was arrested in the Ekosodin axis of Ovia North East Local Government Area on August 13, 2024

The Edo government said a total of 129 cases of homicide and cult related crises were recorded in the state within two months (June and July). This information was disclosed by Governor Obaseki. In an effort to curb this menace, Governor Obaseki banned cultism in the state, making it clear that his administration would not tolerate it.

More recently, six persons were reportedly killed in a renewed cult-related crisis in Auchi and South Ibie communities in Etsako West Local Government Area. It was also learned that the fight that was initially between Eiye and Vicky

confraternities later involved Black Axe, causing the clash among Eiye, Vikys and Black Axe confraternities. This clash left several persons injured.

According to reports, the involvement of Black Axe ensued when one of the Black Axe members was mistakenly shot at a hotel during a misunderstanding between the two rival cult groups.

Two of the victims were reportedly killed on the 6th while four were killed between 8th and 10th of October, bringing the total number of victims to six.

Meanwhile, the alleged war of supremacy between cult groups reportedly engulfed a university community in the state. The students were said to have been writing second semester examinations when the cult war started.

In the course of the fight, one of the victims who was said to be a driver was killed on October 10th in broad daylight in the area.

It was gathered that his assailants after shooting him severally without bullet penetration, tied him to their vehicle and dragged him on the tarred road till he gave up the ghost.

When contacted the Public Relations Officer of the Edo State Police Command, SP Moses Yamu, confirmed the incident but didn't state the numbers of casualties.

Yamu said the situation has been brought under control and that investigation is still ongoing.

Some of the notable cult groups in the state include the Neo-Black Movement of Africa, also known as Black Axe, which allegedly emerged from the University of Benin. Other groups such as the Supreme Vikings Confraternity and the Eternal Fraternal Order of the Legion Consortium have also been linked to violent activities. These violent activities and constant clashes that always lead to deaths should encourage the young ones to steer clear of cult related activities. It is however surprising how cult clashes happen in Edo every month. The youths can do better.

### Community elders absolve policeman of arms transfer, demand investigation

The elders and people of Ugbogiobo village in Ovia North-East Local Government Area along the Benin-Akure road have appealed to relevant authorities to wade into an alleged false allegation made against their son, ASP Festus Ediae, for allegedly providing guns and ammunitions to youths in the community to cause crisis.

The elders in a statement jointly signed by the Acting

Peter Orumwense and Augustine Osakpamwan, who are both third and fifth in command in the community, said these allegations were made by one Owen Igbinovia said to be at large and an alleged impostor as Okaighele (Youth Leader) in the community.

Igbinovia had earlier this year reported ASP Festus Ediae to the Police authority, but it was gathered that investigation by the Police high command in Benin City, exonerated Ediae

Igbinovia was subsequently arrested.

The elders said the latest allegation in a viral video where one Friday Imasekha, an indigene of Ugbogiobo, who was allegedly shot on October 19, 2024, in Ugbogiobo by Igbinovia led youths made the confessions but claimed to have done it under duress.

Part of the statement reads, "We, the elders view these spurious allegations weighty and capable of denting the

Ugbogiobo. Our son has been serving the Federal Government as a law enforcement agent with utmost diligence and respect for constituted au-

"We believe these allegations are meant to malign and bring to disrepute the personality of our sons, particularly ASP Festus Ediae, our son who they consider as their stumbling block in their criminal quest to further unleash may-

### People of Ekoken village celebrate boundary dispute victory at Appeal Court

**↑**he people of Ekoken in Uhunmwode Local Government Area of Edo State, weekend, gathered in celebration of a Court of Appeal judgement that gave them

say it's an affirmation of Oba Ewuare's resolution victory in a lingering boundary dispute between them and

their neighbour - the people of Igueosagie village. In their celebration, they assert that the Appeal Court victory was only an affirmation of earlier resolution of the dispute in favour of the people of Ekoken by the Benin Monarch. HRM Oba Ewuare II.

According to the most el-

derly man in Ekoken, David Eguasa Uhunwangho, the two neighbours have been bound by the natural features of a moat from time immemorial as traditionally recognised in

Benin Kingdom.

But suddenly, Igueosagie people crossed the boundary deliberately, encroached on the land of Ekoken, and were illegally selling to unsuspecting developers unrestrained.

In the narration of the Okaighele of Ekoken, Billy Aimuavbosa Ugiagbe, "it has been a long walk, since 2005, when the Palace of the Oba of Benin first gave judgement in favour of the people of Ekoken.

"Again in 2018, after the withdrawal of the suit that was in the court in compliance to the directive of the Palace. HRM Oba Ewuare II resolved the dispute in favour of the people of Ekoken, stating that the natural features of the moat remain the boundary.

"Surprisingly, our neighbours, the people of Igueosagie refused to abide by the Palace resolution, and continued their unrestricted encroachment on our land.

"Even at that they again took us to court, where Justice Eboriemen based on the verifiable evidence presented, also gave judgement in our favour that according to the resolution of the authority of the Palace of the Benin Monarch, the traditional boundary of 'Ivanuwu' (boundary moat) should remain and be adopted by all the disputing parties.

"As usual, the people of Igueosagie in concerted efforts to illegally take over our land, took an appeal for about two years now.

"Probably sensing that the appeal may likely not be in their favour, they went back to the Palace of Oba Ewuare II seeking intervention. So, as customary, the authority of the Oba asked all the disputing parties to return to the court, especially when it was the same people of Igueosagie who instituted the appeal case.

"But fortunately, the Appeal Court has given judgement in the favour of the people of Ekoken; upholding the judgement of the lower court, and the earlier resolution of the Palace of the Oba of Benin."

Also speaking, one of the leaders of Ekoken, Nestor Amayo, corroborated the narrative of the earlier speakers.

The obviously elated people

of Ekoken said they have again been vindicated, urging that their neighbour should embrace the peace its groundwork has been laid.

They consequently sent a warning to developers and prospective buyers in the hitherto area in dispute; from 'Iyanuwu' (boundary moat) downward' to take note of the latest development.

The people of Ekoken also felicitated the Benin Monarch, HRM Oba Ewuare II in celebration of the feast of 'Emorho' (new yam festival), and on the occasion of his eighth anniversary on the throne.

Counsel to the people of Ekoken in the boundary dispute, Olayiwola Afolabi, SAN, gave a brief story of the case.

In the year 2005, HRM Oba Erediauwa first resolved the dispute in favour of his clients; the people of Ekoken, saying the Iyanuwu (boundary moat) a natural feature remains the boundary between the two villages. But Igueosagie people disobeyed.

Again, in the year 2018, HRM Oba Ewuare II adopted the earlier resolution of Oba Erediauwa in 2005 that the Ivanuwu (boundary moat) should be retained as the boundary between Ekoken and Igueosagie people.

"They again refused, they didn't want to obey the Monarch's resolution; they went to court.

"In 2021, Justice Eboriemen granted the court injunction order we filed; restraining the people of Igueosagie from trespassing the land of Ekoken people beyond the 'Iyanuwu' which serves as the natural boundary.

"In their usual character, Igueosagie people filed an appeal against that court restraining order.

"But they didn't come to court, and eventually, the appeal was struck out.

"So, the judgement of the Oba still remains; that the 'Iyanuwu' (boundary moat) is the natural boundary between the people of Ekoken and Igueosagie Villages.

"I want to use this opportunity to warn would-be buyers not to buy any inch of land in the area from the people of Igueosagie. If you do, you will be buying litigation," Afolabi warned.

According to Rev. Ugolor, who was represented by ANEEJ Programme Manager, Innocent Edemhanria, corruption remains a significant challenge to Nigeria's growth and development, its effects are far reaching, hindering economic progress, public service delivery and citizens' trust in governance.

Today's gathering represents a pivotal step in our joint mission to combat these obil society advocacy, strategic partnerships and supporting institutional reforms.

"Nigeria is consistently being ranked as one of the most corrupt countries or territories in the world as evidenced by several transparency international corruption perception index reports in 2023 which indicate that Nigeria ranked 145 out of 180 countries and scored 25 out of 100 points.

"The situation in Nigeria is particularly worrisome as it appears that some powerful individuals can undermine the system and escape justice.

"Today, we see former governors resisting or evading arrest, some current governors have even challenged the constitutionality of the law that sets up EFCC, NFIU and others in court.

"We have also observed that some powerful politicians seem to have captured the judiciary, a good example of "State Capture. We have therefore reached the conclusion that it is better to prevent corruption than to allow it to flourish before fighting the scourge," he noted

# Oko-Jumbo calls for bye-election for vacant position in Rivers' assembly

Tpeaker of the Rivers State House of Assembly, Rt. Hon. Victor Oko-Jumbo, has called on the Independent National Electoral Commission (INEC) to conduct the requisite bye-election to fill the 27 vacant seats of defected members in the state House of Assembly.

The speaker said the renewed call became pertinent since the legal impediment stopping INEC hitherto from conducting the bye-election has been removed.

Rt. Hon. Oko-Jumbo made the call on Friday when he addressed a press conference in Port Harcourt.

It is common public knowledge that Martin Chike Amaewhule and 26 other lawmakers of the Rivers State House of Assembly, on their own accord, defected on the 11th day of December, 2023, from the Peoples Democratic Party (PDP) to the All Progressives Congress (APC), without any justifiable cause, he said.

The speaker stated that their defection from the PDP, which sponsored their election, followed the former lawmakers' failed attempt to impeach Sir Siminalayi Fubara, as the Executive Governor of Rivers State, on the 30th day of October, 2023.

He emphasised: "To frustrate the Independent National Electoral Commission (INEC) from conducting a bye-election to fill the vacated seats in the Rivers State House of Assembly, Martin Chike Amaewhule & 26 others filed Suit No. FHC/ABJ/CS/1681/2023 13th day of December, 2023.

"Subsequently, an order of Interlocutory Injunction was secured, restraining INEC from conducting a bye-election to fill the 27 vacant seats in the Rivers State House of Assembly.

"After filing the said suit and securing the order of Interlocutory Injunction, Martin Chike Amaewhule and 26 others began to foot-drag, and did not do anything to diligently prosecute their suit at the Federal High Court, Abuja."

Rt. Hon. Oko-Jumbo pointed to the futility of that legal suit that Martin Chike Amaewhule and the 26 others pursued, which they used, invariably, as a cover to delay what must necessarily be done.

Specifically, Rt. Oko-Jumbo said that on tober, 2024, Martin Chike Amaewhule and 26 others, without any reason, discontinued Suit No. FHC/ABJ/CS/1681/2023, and it was struck out accordingly.

He declared: "The only impediment to INEC conducting a bye-election to fill the 27 vacant seats in the Rivers State House of Assembly was the order of Interlocutory Injunction restraining INEC from conducting a bye-election.

'Now that Suit No. FHC/ ABJ/CS/1681/2023 has been struck out, the order of Interlocutory Injunction is also issued.

"Accordingly, as the Rt. Honourable Speaker of the Rivers State House of Assembly, I call on INEC to forthwith conduct a bye- election to fill the 27 vacant seats in the Rivers State House of Assembly," he said.

Governor Douve Diri of Bayelsa State presented last week to the Bayelsa State House of Assembly, christened 'Budget of Assured Prosperity, will focus on completion of major projects initiated in his first tenure as well as boosting the economy of the state.

Diri, who presented the budget during the plenary of the Bayelsa State House of Assembly on Thursday, said implementation of the 2025

budget would require some level of efficiency and synerments and agencies (MDAs).

Giving the expenditure breakdown of the budget in some of the sectors, Governor Diri said N178, 761,880,407.32 was for works and infrastructure; education N47,111,696,198.40 and N37,850,000,000,00 for sports.

sum N13,680,000,000.00 was budgeted for urban and housing development; energy and power got N14,450,000,000.00;

agriculture received N16,650,000,000.00; while sebudget gy in government activities curity had N19,000,000,000.00; (N689,440,348,916.30) across ministries, depart- health N19,194,188,466.00 N10,200,000,000.00.

The governor also noted that the overall outcome of the 2025 budget will significantly depend on the level of fiscal and recurrent policy coordination, adding that the government would pursue robust development as enunciated in the budget.

He said: "We have consciously crafted this 2025 budget in such a manner that

### Funding critical for amnesty programme success —Gov Diri

overnor of Bayelsa State, Senator Douye Diri, has called for adequate funding of the Presidential Amnesty Programme (PAP) for it to function effectively.

Senator Diri made the call on Friday when he received the PAP administrator, Dr Dennis Otuaro and his delegation in Government House, Yenagoa.

Daniel Alabrah, Chief Press Secretary to Governor of Bayelsa State, in a press statement, said the governor, who stressed that funding was critical for the survival of the programme, advocated the need for state governments and National Assembly members from the Niger Delta to collaborate towards addressing its funding challenges.

He said: "There is no place that will survive without funds. These are some of the issues that we as governors can also support you in ensuring that our National Assembly members make the contacts and synergise so that these issues will not be left for you alone to handle."

He advised Dr Otuaro to build linkages across relevant state governments within the region to ensure that the programme made meaningful impact, noting that the Niger Delta Development Commission (NDDC) also faces similar challenges, which had affected its activities.

The Bayelsa governor ad-

monished those calling for the scrapping of the programme, saying the issues that led to its establishment were still prevalent.

According to him, despite the transition to renewable energy, crude oil production still plays a vital role in the nation's economy and advocated for continuation of the programme.

Giving a brief history of the armed struggle of the Ijaw people from the days of Jasper Adaka Boro, Diri said: "The ljaws, for long, have been suffocated in a structure that they had given their all in terms of human and natural resources. Over the years, there has been a long cry of neglect and underdevelopment.

"The initial armed struggle in Ijawland basically fought for justice and development. The community called Oloibiri in Bayelsa State, where crude oil was first struck in commercial quantity in 1956, is now a shadow of itself. Nothing was ploughed back into Oloibiri that brought out all the trillions of naira for Nigeria.

"I like my brothers from other states to recognise that amnesty was not a gift to the Niger Delta but to bring succour to a people that had been abandoned."

While commending the previous administrators of

the programme for creating training centres across the region, the governor decried the vandalism at the training centre in Kaiama in Kolokuma/ Opokuma Local Government Area of the state and urged

Otuaro to revamp it.

In his remarks, the PAP Administrator requested the support of the state government in the area of funding for its training programmes.

Otuaro said the programme was at the rehabilitation and reintegration stage and there was need to consult with all relevant stakeholders to ensure its success.

He noted that from 2014, funding for the programme reduced by half while its scope was expanding, particularly when it has about 1,681 students in tertiary institutions in the country and 38 students studying abroad.

Otuaro also disclosed that 98 maritime cadets have just been deployed within the country, stressing that there was a need to expand the programme to accommodate women stakeholders that are business-oriented.

### Akwa Ibom PDP officers decry oppression by ward leaders

ard officers of the Peoples Democratic Party (PDP) in Akwa Ibom State have decried what they described as gross marginalization, oppression and usurpation of functions by the forum of PDP ward leaders, a group they described as unconstitutional.

According to a PDP ward chairman from Uyo Federal Constituency, the ward leaders, who are mainly former commissioners, former House of Assembly members and former board members, and those who once aspired, but did not win elections to different political offices, have practically taken over their constitutional and political functions in their wards, leaving them redundant and irrelevant in the eyes of party members.

Sources from the government house said it is the nefarious behaviour of many ward leaders that has caused the delay in constituting and announcing supervisors long after the inauguration of the local governments.

According to one of these sources, most of the ward leaders, who are board members and other political office holders, nominated their children, wives, family members and close relatives, a development that has necessitated the cancellation of the supervisors list for a fresh one by the governor.

It is also gathered that a very few of the ward leaders have preferred to toe the path of integrity and justice, by respecting public opinion and fairness in the process of selecting supervisors at the local government.

Another ward officer confided in this reporter that during the local government electioneering campaigns, the ward leaders were given more prominence than ward officers of the PDP.

He however agreed that the ward leaders' forum was instrumental to the success of the party, but argued that the constitution of the PDP does not recognize such a body.

He however agreed that the group was instrumental to the success of the PDP during the last elections, but should not overwhelm other political groups that contributed to the emergence of the present state and local governments.

Finally, they threatened to defect to another political party if the power and constitutional integrity of the ward leaders is not restored.

### Crude oil management and revenue leakages

As Nigeria struggles to shore up her economy from a very low ebb, attention has been focusing on efficiency and transparency in the management of her major export and revenue earning resource,

Nigeria's crude oil production quota for 2024 is 1.5 million barrels per day (bpd), as set by the Organisation of Petroleum Exporting Countries (OPEC). This is lower than its 2023 quota of 1.78 million bpd.

Nigeria has not met its OPEC supply quota since 2022. In the first five months of 2024, Nigeria fell short of its OPEC quota by about 42 million barrels, which could have resulted in a loss of \$3.57 billion in revenue.

The Nigerian Upstream Petroleum Regulatory Commission (NUPRC) allocates the Federation's share of oil production to either exports or domestic use. The domestic use component is called domestic crude allocation (DCA). Revenue from DCA is received in Naira, while revenue from exports is received in dollars.

In a nutshell, the more crude oil the nation exports, the more foreign exchange she earns and the better the economy, all things being equal.

Not long ago, former President

Olusegun Obasanjo in characteristic manner stirred the hornet's nest with a claim that over 80 per cent of Nigeria's crude oil is lost to

Obasanjo made the claim at the launch of a book, titled book titled 'Court and Politics,' and authored by Dr. Umar Ardo.

The former president said while the crude oil quota is about two million barrels per day, over 1.7 million are stolen.

While the figures reeled out by Obasanjo may appear farfetched, there is surely a great deal of theft of the country's crude oil going on.

In a similar vein, the Federal Government in November last year, revealed that more than N4.3tn worth of crude oil was stolen in 7,143 pipeline vandalism cases within a period of five years.

It disclosed this at the Nigeria International Pipeline Technology and Security Conference in Abuja, with the theme, 'Bolstering Regulations, Technology and Security for Growth.' The conference was organised by the Pipeline Professionals Association of Nigeria.

In a presentation at the conference by the Nigeria Extractive Industries Transparency Initiative, (NEITI) a Federal Government agency, the organisation revealed that oil theft and losses in Nigeria

had become a national emergency.

The Executive Secretary, NEITI, Ogbonnaya Orji, said oil theft was an emergency that posed serious threat to oil exploration and exploitation with huge negative consequences on economic growth, business prospects and profit earnings by oil companies.

Providing data from the agency's reports to back his claims, he said: "NEITI disclosed that in the five years, 2017 to 2021, Nigeria recorded 7,143 cases of pipeline breakages and deliberate vandalism resulting in crude theft and product losses of 208.639 million barrels valued at \$12.74m or N4.325tn.

"NEITI reports also disclosed that during the same period Nigeria spent N471.493bn to either repair or maintain pipelines."

Orji pointed out that from NEITI's 2021 Oil and Gas Industry Report released in September, the sector accounted for 72.26 per cent of Nigeria's total export and government's foreign exchange, 40.55 per cent of government revenue, and provided 19,171 jobs.

"From NEITI's reports over the years, and recently insights from our membership of the Special Investigative Panel on Oil Theft and Losses, we are aware that oil theft is perpetrated mainly through pipeline clamping, illegal connections on major pipelines, exploitation of abandoned oil wellheads, pipeline breakages and vandalism of key national assets to illegally siphon crude into waiting vessels stationed in strategic terminals.

"These criminal exploits take place most times in atmosphere of communities' complicity and conspiracy of silence," the NEITI boss stated.

"As you are aware, illegal connections, pipeline clamping, etc, cannot be done by just anybody. And so, your association is largely complicit by failing to put in place stringent regulation and appropriate sanctions to check involvement of your members.

"For instance, NEITI has put in the public domain, empirical data of oil theft and losses at 619.7 million barrels of crude, valued at \$46.16bn or N16.25tn between 2009 and 2020.

"In addition, Nigeria lost 4.2 billion litres of petroleum products from refineries, valued at \$1.84bn at the rate of 140,000 barrels per day, from 2009 to 2018.

Thus, the total value of crude losses between 2009 and 2020 is higher than the size of the country's foreign reserves and almost 10 times Nigeria's oil savings in Excess Crude Account," Orji stated.

### Avoid blowback effects of vulnerability with braving



e must have heard statements like these countless times: "Fake it till you make it' or "Not looking like what we've been through." These interesting expressions are just a few responses to the shame or retribution that comes with vulnerability.

As the concept of vulnerability continues to gain significant attention globally, it is essential to acknowledge the potential risks and challenges associated with it, especially in the workplace. Several psychology and human development forerunners, such as Carl Rogers, Harry Stack Sullivan, Erik Erikson, James Pennebaker, Dan Goleman, and Shelley Taylor, were well ahead of Brene Brown. However, her extensive work from 2000 to date, which focused on shame, vulnerability, wholeheartedness, daring greatly, embracing uncertainty, and living with vulnerability, has been pivotal to reawakening this aspect of human connection. Regardless of the amount of attention with well-intended attendant effects it hoped to achieve, the concept has become the foundation of some people's undoing. This is why there is a need to be aware of its dark side, which I would like to refer to as vulnerability blowback. It may interest you that these blowback effects have been explored in Harvard Business Review, Forbes, and The Journal of Applied Psychology, which testifies to its actual existence, hence the need to tread with caution whenever you feel like being vulnerable.

To those wondering what this concept is all about, let me start by defining it. Vulnerability is the willingness to take emotional risks, be open, and be willing to surrender control despite uncertainty, potential harm, or rejection to build meaningful connections, foster growth, and cultivate authenticity. This control may be over our emotions, keeping certain things to ourselves, or revealing hard truths about our circumstances. The intriguing thing about this concept is that it reveals what may never be out there in the open if you never shared it, which brings us to the intention or rationale behind being vulnerable.

Why would anyone want to be vulnerable with deep and personal stuff, especially in this social media world where millions of people can easily judge you? After all, we all practice one form of vulnerability or the other daily, either by quick personal checkin with ourselves or family members. Here is why. Therefore, vulnerability

should be a tool for brokenness or humility, encouragement, and inspiration. This means that if you are not there yet, continue to wake up, make up, and show up until your time to truly shine comes. Vulnerability is delicate, and its intricacies can make it rather technical in the workplace.

I've heard stories of people confiding in someone at work becoming a clog in the wheel of progress of such individuals. As much as I don't want to discourage practicing this form of openness, let me re-use Brene Brown's BRAVING acronym to give tips on how to forge ahead with it.

Boundaries: Establish clear limits and expectations to protect yourself from exploitation, lack, or harm. Being open or sharing personal stories without setting boundaries is a recipe for disaster, especially at work or on social media. Take time to think through the limits to which you can share without giving an opportunity for resentment, condemnation, undue exposure, or outright exploitation.

Retrospect: Reflect on past experiences, including reactions from loved ones, to inform and improve future vulnerability. Take a breather and reflect on past experiences after sharing personal thoughts, stories, or insights to recall the other party's reactions days, months, or years later. If you suffered retribution even from a loved one, then you may want to reassess what is to be shared or simply let it pass.

Aim: Clarify your intentions, goals

and target to ensure this form of openness is purposeful and directed to the right audience or person. Aimless sharing just for the sake of sharing is utterly worthless to the recipient and more costly to you.

Value: Recognize and honour your worth and the value they bring to relationships and interactions. Vulnerability should be humbling, which means you must have attained a certain level of overcoming yet helping others see that we are all humans after all, and things do happen. So, it's better from a place of authority and value addition than flagrant disclosure.

Intention: Be mindful of your own motivations and ensure they align with your values and goals. Intention is critical because openness for all the wrong reasons or no reason at all is bound to backfire. Be sure to have good and pure intentions of value addition.

Necessity: Assess whether vulnerability is necessary and proportionate to the situation. Certain situations may warrant something other than sharing personal struggle et al. Your experience may be better deployed as a guiding or leading tool instead of full disclosure, which may become a distraction.

Goal: Focus on the desired outcome and ensure that vulnerability is a means to achieve it. Identifying the goal(s) to be achieved and staying the course without deviating until it's done is paramount.

### Tinubu's perplexing aloofness to the real sector

s grim as the report by the Manufacturers Association of Nigeria (MAN) on the state of the real sector is, it did not come as a surprise. The red light had been there for a long time. While the shut down of many manufacturing companies had been going on in the absence of a discernible strategy to prop up the fortunes of the real sector, all systems came off after the May 29, 2023, unilateral proclamation of President Bola Tinubu that upturned all projections and plans of the business community.

In its recent report, the MAN revealed that over 767 manufacturers had shut down operations and 335 became distressed in 2023 alone. In addition, unsold inventories amounted to N350 billion during the same period.

It's not rocket science to understand why manufacturers that have been operating under 35 percent capacity still have their warehouses filled up. Despite having a huge population which the government touts in the refrain that Nigeria is a huge market for investors, the over 200 million population is impoverished with very low purchasing power.

What the Chief Executive Officer of the Centre for the Promotion of Private Enterprise, Muda Yusuf, called "disturbing tendencies of overbearing regulatory dispositions, disproportionate sanctions, obstructionist actions, outrageous

fines and penalties, intimidation and high-handedness" encapsulate the tough operational environment manufacturers have had to contend with since the removal of petrol subsidy.

In the midst of crippling energy scarcity, the controversial Band A imposed on manufacturers has seen electricity tariff despite being grossly inadequate rise by 250 percent. This has seen energy cost rise to between 40 and 50 percent of the cost of production. This is the only country where such a single item takes up half of the cost of production.

Against the backdrop of the sustained complaint of manufacturers who are even threatening to get their members shut down operations, there has been no response from the federal government. Rather, the slew of tax increases continue with the latest being the proposal to increase Value Added Tax (VAT) to 10 percent from the prevailing 7.5 percent. If the debilitating factors against manufacturers continue unheeded, what are the parameters for the Federal Government's claim that its 'reforms' are already yielding fruits and turning the economy around?

Last week, The Guardian newspaper carried a front page report where the desperate state of Nigerians was showcased. Reflecting the pervading sentiments of the people, it warned that as abhorrent as the thought is, more people are harbouring the wish that the military would intervene. Just two years ago, even the man would not have entertained such a thought. Despite the scathing and disingenuous response from the presidency's Bayo Onanuga, the situation is dire for Nigerians.

High exchange rate, high and multiple taxes, an impoverished population as poor infrastructure and logistic challenges make up the perfect storm for things to go wrong.

The tax hawks having a say and a way in Tinubu's economic team should be made to take a back stage. Development economists should step up to the dire situation on hand. Tinnubu should not allow himself to be lulled into lethargy and a false sense that things are turning around. It's getting worse, Mr. President.

### Lessons from Ebie's reaction to court judgement affirming his NDDC position

't is no longer news that Justice Joyce Abdulmalik of the Federal High LCourt, Abuja, on Thursday, October 31, 2024, dismissed the lawsuit filed by some members of oil-producing communities in Bayelsa and Delta states seeking to nullify Mr. Chiedu Ebie's appointment as chairman, Governing Board of Niger Delta Development Commission (NDDC), on the grounds that his emergence violated the NDDC Act.

The plaintiffs claimed in their suit that Ebie is not from an oil-producing area with the highest production quantum in the Niger Delta.

However, delivering her judgement, Justice Abdulmalki held that given section 24(2) of the NDDC Act, the plaintiffs had no locus standi. The section read, "Notwithstanding anything contained in any other law or enactment, no suit shall lie against any member of the Board, the Managing Director, or any other officer or employee of the Commission for any act done in pursuance or execution of this Act or any other law or enactment, or of any public duty or authority or in respect of any alleged neglect or default in the execution of this Act or such law or enactment, duty or authority, shall lie or be instituted in any court." It was on this premise that the court dismissed the suit in its entirety".

Indeed, while the judgement in the suit marked: FHC/ABJ/CS/28/2024, filed January 11, 2024, which saw no illegality in the appointment of Chiedu Ebie as the NDDC chairman and confirmed that Mr. President and the National Assembly acted within the ambit of the law, may have come and gone, the dust and excitement the outcome elicited among Niger Deltans continue to resonate.

Essentially, Mr. Chiedu's reaction to the judgement added fillip to the excitement.

Aside portraying him as noble and a man of peace and with unalloyed respect for President Tinubu and the judiciary as an uncompromising dispenser of truth and justice, Ebie's reaction to the verdict, more than anything else cast him as someone that has no enemies to fight.

Ebie's reaction to the court judgement also portraved him, in the estimation of right-thinking Nigerians, as a public officer not given to narrow mindedness or possessing divisive tendencies.

Beginning with respect for Mr. President and the judiciary, Ebie described the ruling as well-considered, intelligently delivered and courageously sound, noting, "The judiciary has once again proved that justice is never lacking in the Temple of Justice".

He expressed delight that the ruling has finally laid to rest every ambiguity, innuendo, half-truth and misrepresentation of facts surrounding the provisions of NDDC Act on appointments.

Ebie added that the judgement was a resounding watershed and underscored President Tinubu as a foresighted leader reputed for acting in total compliance with extant laws when it comes to appointments into public office.

As a people oriented leader, Ebie displayed uncanny sportsmanship and magnanimity in the face of victory. As wont many in his shoes, Ebie was not magisterial or triumphal; he never cast aspersions or draws more battle lines via inflammatory statements or taunt his adversaries.

Rather than do all those, he dedicated the legal victory to God Almighty and all Niger Deltans of goodwill, and extended a hand of fellowship, calling on all critical stakeholders to join hands with NDDC governing board and management to consolidate the significant shift in the region's infrastructural and socio-economic developmental trajectory.

Ebie further stressed the need for a holistic and sustainable development of the Niger Delta region becoming overwhelmingly urgent, and urged all stakeholders to shun divisiveness and rally round the present management in sustaining the peace and harmony within the Commission.

"Looking at the level of peace and harmony that have existed among members of the governing board and management, I am confident that we will continue to excel and reach new heights of excellent quality service delivery to the region and its people," he stated.

"I call on all Niger Deltans to shun all forms of distractions through frivolous litigations that distract the Commission's governing board and management and, in its place, imbibe the virtues of commitment and other positive attributes needed for fostering peace and unity, promoting innovation for impactful strides for advancing development of the region", he said.

Ebie's people-centred and youth friendly leadership did not escape the attention of the Niger Delta Youth Council (NDYC) as the group, shortly after the judgement, rolled out the



drums to celebrate his legal victory.

The youth group, whose membership cuts across all ethnic nationalities that make up the Niger Delta region, had earlier petitioned the Abuja Division of the Federal High Court, urging the learned justices to dismiss the suit for lacking in merit as the motive behind was a deliberate attempt to disrupt the progress and development of the region.

Addressing journalists shortly after the verdict, the National Coordinator of NDYC, Engr. Jator Abido in the company of other Comrades hailed the judgement as a win for the good people of Niger Delta who are in dire need of development following years of maladministration and neglect of the oil rich region, especially as it grapples with environmental degradation, pollution and loss of livelihoods.

On his part, Comrade Adodo described the judgement as "historic", adding that, "today, we celebrate the triumph of unity, fairness and justice. It is our earnest appeal to stakeholders in the Niger Delta region to desist from distracting our leaders. Dragging them from one court to another cannot help our region as all hands must be on deck to salvage our region from the many challenges besieging it"

And according to Comrade Apere, "the judiciary is indeed the last hope

of the common man. Today, our enemies have failed and those who seek to divide us are once again put to shame. The Niger Delta region cannot afford to be hijacked by a few selfish elements. It is now time to join hands and uplift our dear region".

In his brief remarks, Comrade Udoh Victor thanked Mr. President, the Senate President, the Attorney-General of the Federal for standing up against those he described as "the bullies that sought to hijack the people's common good". He assured President Tinubu of the support and loyalty of the Nigerian youths to his administration, as he pledged to work with NDYC and other youth groups to mobilise massively come 2027 in appreciation for the determination and courage shown towards delivering on the Renewed Hope Agenda"

### Arrogance of power: Hon. Ikwechegh in the firing line

ower can be seen as the ability to make that which should not have happened happen. Excessive use of power could be disastrous. This seems to exemplify the character of a former Council Chairman of Aba North Local Government Area of Abia State, now a parliamentarian.

On Sunday, October 27, 2024, a Bolt driver, Stephen Abuwatseya, was contacted by a vendor to deliver some food items to Hon. Alex Ifeanyi Mascot Ikwechegh in his Maitama, Abuja house. Hon. Ikwechegh is a member of the House of Representatives on the platform of the All Progressives Grand Alliance (APGA), representing Aba North and South of Abia State. In a viral video, the following ensued between Hon. Ikwechegh and Stephen.

Hon.: So you think I will give you my money with the way you have spoken to me?

Stephen: I did a job for you and you have to pay me, Sir.

Hon.: With this level of disrespect, you are very stupid, very very stupid. Hon.: Madam, who is this stupid

boy that you sent to this my house? Hon.: Who is this foolish boy that you sent to my house?

Vendor: He is a bolt driver o.

Hon.: How can this stupid idiot come to my house and tell me that I

am supposed to come and meet him in his car and pick up snail that I am buying from you?

Vendor: He is a Bolt driver. How can he say a thing like that?

Vendor: I am so sorry. He doesn't know who you are.

Hon.: Can you imagine this rat? Hon.: I can make this man disappear in the whole Nigeria and nothing

would happen. Vendor: Sorry, Sir.

Hon.: I am not going to give this boy one naira of my money.

Vendor: Please Sir, I am so sorry.

Hon.: No, no, no, no. I am not going to give this silly boy one naira of my money.

Stephen: You have been insulting me and I have been quiet.

Hon.: I pray that you do. I pray that you insult me.

Hon.: Can you please insult me. Hon.: I am not going to call my po-

licemen to beat you up. Hon.: I will beat you up.

Hon.: I will show you that I am a big brother to you.

Hon.: I will slap the hell out of you and I will lie you down, lock you in my generator house.

Hon.: How dare you.

Stephen: Why should you do that? Hon.: Who the hell; do you know who you are talking to?

Hon.: Do you know where you are? Hon.: Because you saw me sitting outside here?

Stephen: It doesn't matter. Stephen: Pay me, let me go. Hon.: Look at this monkey, o! Stephen: I don't care what I am.

Hon.: Are you looking at me, that you can beat me?

Hon.: Who the hell do you think you are talking to? (Hon. donates a slap to the Bolt driver).

Hon.: Do you know who I am? I am a Senator of this Republic.

Hon.: Do you know who the fuck I am? (Hon. generously distributes another slap to the Bolt driver, Stephen).

Hon.: How dare you.

Stephen: Are you slapping me, Sir? Hon.: You see this place? You will suffer; I will deal with you.

Stephen: Are you slapping me, Sir? Hon.: I just did. Slap me back.

Hon.: How dare you. How dare you. How dare you.

Hon.: Do you know who I am? How dare you.

Stephen: That is fine.

Stephen: Did you just slap me three times, Sir?

Hon.: Twice.

Hon.: The third one, you will soon receive it.

Hon.: How dare you.

Hon.: Come on, get out of this place. Stephen: I need my payment, Sir. Hon.: Come and collect it.

Stephen: Alright, this is where I am. I just got three slaps from this man here, just because I told him to come and get his stuffs and pay me my money. He is claiming that he is (Hon. interrupts).

Hon.: Tell them. My name is Hon. Alex Ikwechegh. I am a member of the House of Representatives. Tell them I slapped you.

Hon.: Call the Inspector General of Police. Call him. Let him come.

Stephen: Ok, Sir.

Hon.: Record me very well. Record me very well.

Stephen: Ok. Ok, Sir. That's nice. Hon .: You came to my house to disrespect me.

Štephen: I didn't disrespect you. I said pay me my money and let me

Hon.: Come on, keep that phone. (Hon. dashed at Stephen's phone).

Conclusion: Despite Hon. Ikwechegh's vituperations and bullying, there did not seem any iota of disrespect from Mr. Stephen against the legislator. Yet, after the assault by Hon. Ikwechegh, his policemen seized Stephen's car, bundled and detained him at a police station. This is a display of power.

However, a lawless society, especially where law enforcers or lawmakers turn lawbreakers, will sooner or later head towards anarchy. As Fidel Castro said, it is illegal to be law abiding in a state of lawlessness. Hon. Ikwechegh's Mike Tyson-like behaviour seems to be common among Nigeria's parliamentarians. Recall that in 2019, the youngest lawmaker then in the Upper Legislative Chamber, Senator Elisha Abbo, who represented Adamawa North Senatorial District, was caught on camera assaulting a woman at a sex toy shop in Abuja.

Unlike Abbo who, after the incident, returned to the shop in an attempt to cease the video footage, not sure if his show-of-shame was recorded, Hon. Ikwechegh knew Stephen was recording him, yet, he went on with his arrogance and assault and even belittling the office of the In-

spector General of Police and daring him. If not for his braggadocio, believing he was above the law, therefore, untouchable, Hon. Ikwechegh, seeing Stephen recording him with his phone, ought to be cautious with his actions and utterances.

# Nigeria set January 2025 as launch date for \$5bn Africa Energy Bank

**↑**he Federal Government of Nigeria has scheduled January 28, 2025, as the launch date for the \$5 billion Africa Energy Bank in Abuja, Ambassador Nicholas Ella has disclosed.

Ambassador Nicholas Ella who serves as the Permanent Secretary of the Ministry of Petroleum Resources and as Nigeria's Executive Board Member at the African Petroleum Producers Organization (APPO), made the disclosure during the 19th Executive Board meeting of APPO, which was held in Yaounde, Cameroon, last week.

Ellah reaffirmed Nigeria's determination to APPO's principles and the prompt establishment of the energy bank, which seeks to address funding gaps within Africa's oil and gas sector.

"I am pleased to address the Executive Board (EB) meeting on this very important subject matter - the takeoff of the Africa Energy Bank Headquarters in Abuja, Nigeria," Ella said.

"As you are no doubt aware, the Headquarters building (of the Africa Energy Bank) was inspected by the Technical Team on 24th May 2024, and renovation works for its completion are ongoing. Nigeria is fully committed to delivering the building with furnishing to the bank support and cooperation of Mr ter of Justice to commence with include three classes of share-

President and our National Assembly to actualise this project in Nigeria," he added, according to the Leadership newspaper.

It should be recalled that in July 2024, Nigeria was announced the winner of the hosting rights for the Africa Energy Bank (AEB) headquarters, after a competitive bid which involved Ghana, Algeria, South Africa, and Benin Republic. The bank is being sponsored in collaboration with Afreximbank.

The ambassador went on to elaborate on Nigeria's preparedness for the establishment of the bank, stating the bank's commencement of operations will coincide with the 38th anniversary of the African Petroleum Producers Organization (APPO), an alliance of 18 members aimed at enhancing Africa's energy sector. This new bank is being created through a collaboration between APPO and the African Export-Import Bank (Afreximbank).

While giving further update, Ambassador Ella reminded the attendees that the Federal Executive Council of Nigeria approved the hosting of the Bank on June 25, 2024. He pointed that "ratification of both the Charter and Headquarters Agreement are in an advanced stage. In its decision, the FEC also approved and endorsed the Establishment Document of the AEB and instructed in good time. We have the full the Attorney General and Minis explained that the bank would

According to Ella, the Attorney General has concluded the process in September 2024 and has sent the AEB to the president for assent. "The Attorney General concluded the process on 9th September 2024 and transmitted the AEB Establishment Documents, which are currently with His Excellency, the President for his assent and which will be forwarded to APPO immediately.

"Apart from the earlier payment of \$59,120,000:00, an additional \$10 million was paid into the APPO Account by the FGN (Nigeria) last week. We intend to make full payment before the bank takes off.

"Nigeria wishes to advocate for the establishment and funding of the Africa Energy Bank as part of APPO's budgetary plans. This initiative would not only address the financial needs of the energy sector but also provide a platform for mobilising investments in oil and gas projects, which are vital for Africa's economic growth and development," Ella added.

APPO Secretary-General Dr. Omar Farouk Ibrahim confirmed that 50 percent of the necessary funds for the launch of the AEB have been obtained.

### Stanbic IBTC's profit hits N182.8bn in Q3 2024

tanbic IBTC Holdings Plc has recorded a remarka-Uble 180 per cent rise in net interest income, fueled by the Central Bank of Nigeria's (CBN) aggressive rate hikes in 2024. The bank's financial report for the nine months ending September 2024, filed with the Nigerian Exchange Limited (NGX), shows tiple revenue streams despite a challenging economic environment. The bank's after-tax profit grew by 67.3 per cent, closing at N182.8 billion, compared to N109.2 billion recorded in the same period of 2023.

The surge in profitability was driven by a significant increase in interest income, which rose to N425.7 billion from N184.5

strong performance across mul- billion in the previous year, as Stanbic IBTC capitalized on the high-interest rate environment. However, interest expenses also rose sharply by 171.3per cent, reaching N173.9 billion from N64.1 billion. The CBN's monetary tightening, with a cumulative increase of 850 basis points in 2024, has pushed the Monetary Policy Rate (MPR) to 27.25 per cent as of September 2024.

This has significantly increased the interest charged by banks on loans, boosting Stanbic IBTC's revenue. The bank's trading revenue also saw a boost, growing to N80.2 billion from N59.7 billion, primarily driven by activity in fixed-income securities and currency trading. Fees and commission income surged 58.9per cent to N134.3 billion, up from N84.5 billion in the previous year, with asset management fees accounting for 54 per cent of this total. Notably, brokerage and financial advisory fees grew by 133 per cent, and foreign currency service fees rose by 126 per cent.

However, Stanbic IBTC reported an impairment loss on financial instruments amounting to N59.3 billion, a significant shift from an impairment write-back of N9.95 billion in 2023. The rising cost of doing business in Nigeria, driven by inflation and energy disruptions, also impacted the bank's operating expenses, which increased to N183.5 billion from N123.1 billion. Despite these challenges, Stanbic IBTC's business activities generated substantial cash flow, with net cash from operating activities rising to N1.84 trillion, compared to N406 billion in the same period of 2023.

Net cash flow from investing activities, however, was negative at N405 billion, largely due to capital expenditures and fi-

nancial instrument purchases. The bank also made strides in debt management, repaying N119 billion in borrowings and N44 billion in debt securities, while paying dividends totaling N56 billion. As a result, net cash flow from financing activities amounted to N107 billion, and cash and cash equivalents for the period increased by 129.3per cent to N1.9 trillion from N837 billion.

Stanbic IBTC's total assets grew by 37 percent, reaching N7.2 trillion, driven by a rise in loans and advances to N2.42 trillion from N1.77 trillion. Deposits and current accounts grew to N3.46 trillion from N2.49 trillion, while total shareholders' funds increased by 33.7per cent to N630 billion. Ultimately, the bank declared earnings per share of N1,390 in the first nine months of 2024, up from N825 per share in the corresponding period of 2023, reflecting its strong financial performance amid a tough

### Ghana urges common currency for West Africa to ease fuel imports

hana is asking for a shared currency among West African countries to make it easier to buy fuel from the Dangote Petroleum Refinery and to help with other business

Mustapha Abdul-Hamid, the Chairman of the National Petroleum Authority in Ghana, spoke at the OTL Africa Downstream Energy Week, organized in Lagos. He pointed out that relying too much on the dollar is hurting local currencies and making them lose value.

Abdulhamid explained that Ghana needs dollars to buy fuel from the Dangote refinery, and Nigeria will also need dollars if it wants to buy from Ghana.

He talked about how countries in the petroleum industry need to work together. Even if they have different political views, they should try to agree on a plan that helps everyone trade with each other.

"Fortunately for us, the entire continent now has an Africa Continental Free Trade Agreement that allows us to collaborate among ourselves in terms of trading, not just in petroleum products but in all other products. However, if Ghana is going to import petroleum products from Dangote Refinery, for example, we would still have to pay Dangote refinery in dollars", he said.

He also added that if Nigeria runs low on fuel, it might have to buy from Ghana, but they would still need dollars to do that. He believes it doesn't make much sense.

"It is our demand for dollars to import petroleum products that puts pressure on our various currencies and also drives petroleum product prices upwards. Now that Nigeria has a deregulated petroleum regime, for example, the major factor that is going to be responsible for driving up petroleum prices in Nigeria will be the currency, because importers would need more dollars to import petroleum products", Abdulhamid said.

He said Ghana would require \$400m monthly to import petro-

leum products, adding that "now I can imagine how much Nigeria will need for the importation of its petroleum products. Where are the Nigerian petroleum importers going to find the dollars? You will only put too much pressure on your currency."

He called for countries to work together, not just in the petroleum sector but also at the government level to improve fuel systems and economic policies.

He said Ghana would like to buy fuel from the Dangote Refinery once it reaches a capacity of 650,000 barrels per day because Nigeria wouldn't use it all. He believes this is better than getting fuel from faraway places like Rotterdam in Holland.

### Equity transactions on NGX hit N3.968trn in Q3'24 as domestic investors maintain dominance

The Nigerian Exchange Limited (NGX) has reported a substantial rise in equity trading values, reaching a record-breaking N3.968 trillion in the first nine months of 2024. This impressive figure marks a 46 percent increase compared to the N2.712 trillion traded during the same period in 2023, underscoring the strength of domestic investor participation in Nigeria's financial markets, Arise TV

According to the NGX's latest Domestic and Foreign Portfolio Investment (FPI) report, domestic investors dominated trading activity, contributing N3.271 trillion, or 82.44 percent of the total trading volume, while foreign investors account-

up 17.56 percent. The report also noted that foreign inflows amounted to N310.99 billion. while foreign outflows were higher, reaching N385.89 billion.

The report reveals strong performance among domestic investors, with retail investors leading the charge. Retail investors traded N1.739 trillion worth of stocks, surpassing institutional investors, who contributed N1.531 trillion. The robust participation of retail investors reflects growing confidence in the market and increasing interest from individuals across Nigeria.

In September 2024 alone, total transactions on the NGX surged by nearly 30 percent month-on-month, reaching N493.01 billion (\$307.84 million) compared to N379.52 billion (\$237.70 million) in

ed for N696.88 billion, making August. This surge represented a remarkable 66.67 percent increase year-on-year from September 2023, when transactions totaled N295.80 billion.

A closer analysis of domestic market trends reveals that retail investors played a key In September, retail transactions soared by 59.42 percent, climbing from N180.72 billion in August to N288.10 billion, while institutional transactions rose by a more modest 15.69 percent, from N141.33 billion

The month's data also highlighted a significant shift in foreign and domestic investor dynamics. Domestic transactions increased by 40.23%, from N322.05 billion in August to N451.60 billion in September.

Meanwhile, foreign transactions declined by 27.95%, from N57.47 billion (\$35.99 million) in August to N41.41 billion (\$25.86 million) in September, as foreign investors adopted a more cautious approach amid global economic uncertainty.

He further explained the purpose of the Turbo Fund, noting that it provides an avenue for investors to access markets that may be out of reach for many individuals. "Both funds are top performers in their respective categories. Since we started these funds, they've consistently ranked in the top quarter of performance," he added.

Jude Chiemeka, CEO of NGX, commended Norrenberger for enhancing the market by introducing additional instruments in the realm of Islamic finance. "We have 63 mutual funds listed on our exchange, which reflects our commitment to creating opportunities for retail investors. There are now five Islamic products listed," he noted.

Chiemeka highlighted the importance of Islamic finance, particularly through the issuance of Sukuk, stating, "Islamic finance has helped the federal government through the issuance of Sukuk. ### Why bank fraud is on the rise in Nigeria Part 2

ccording to Aristotle, "Excellence is never an accident. It is always the result of high intention, sincere effort, and intelligent execution." The methodology to be used to curb fraud and fight against fraudulent activities "popularly known as 419" in the bank must be intentional. One must determine to look at so many parameters, such as domain names, IP addresses, currency or phone numbers. This data will then be anonymized by researchers to perform a statistical analysis of their findings.

As of the third quarter of 2023, the Nigeria banking sector has lost over N9.5 billion to electronic fraud underscoring the pressing need for proactive measures in the face of escalating cyber threats. Some cybercrime experts have suggested many ways of reducing the upsurge in e-banking fraud in Nigeria.

The experts said the National Assembly should propose relevant bills such as Cyber Security and Information Protection Bill and Electronic Transactions Protection Bill that could eliminate or reduce electronic fraud to the barest minimum.

They advised the Central

Bank of Nigeria (CBN) should issue operative guidelines to the banks and to be reviewed to regulate e-banking services in such a way that suspicious transactions could be reported seamlessly to its financial intelligence. The banks should be mandated to deploy advanced tools and technology, which could adequately protect customers against falling prey to fraudsters, considering the overreliance on telecoms service providers for basic services. There should be provision of automated analysis tools that could identify and report fraud attempts in a timely manner.

The experts called for deployment of deep learning by management of banks. The expert said "Deep Learning is a new approach to machine learning and artificial intelligence which are good at identifying complex patterns and characteristics of cybercrimes and online fraud."

"There is an urgent need to review the internal audit functions of banks to include fraud risk analysis and management, while the internal control mechanism should be strengthened through adequate investment in training of staff in cyber security, online audit fraud detection and management.

"There should be regular rotation of bank employees to frustrate collaborative fraud. The regulatory institutions and banks should organize workshops, seminars and public lectures for bank customers on how to escape various e-banking frauds. The banking industry should review the existing Bank Verification Number (BVN) framework with the introduction of BVN watch list."

Also, there should be frequent review of customer KYC (Know Your Customer) information. The customer BVN should be link to the National Identification Number (NIN). This will help the bank to track the customer in case his/her account is used to perpetuate fraud in the bank

In the new age of digital services such as online banking and digital payments, the frequent reoccurrence of fraud looms larger over the Nigerian banking sector. Cyber criminals continuously evolve their strategies to exploit various financial services, posing substantial risks to both financial institutions and their clientele. Protecting against fraud is paramount to forestall financial losses, safeguard reputations, and maintain operational efficiency.

"Fraud detection involves the protection of customer and corporate data, assets, accounts, and transactions. It hinges on the real-time analysis of user activities. This sophisticated fraud detection mechanism operates through server-based processes that meticulously examine user actions and behavioural patterns or transactions. The goal is to compare these actions with predefined profiles of expected behaviour," the expert said.

To pre-empt electronic fraud in the financial institutions in Nigeria, attention should be given by the financial institutions to institute regular training programmes aimed at enhancing fraud awareness among their staff. Cyber criminals often target bank employees through insidious techniques such as phishing and social engineering.

"It's paramount to educate the workforce on the art of recognising potential fraudsters and impart the knowledge of what steps to take in the event of suspecting a compromise," he added.

Furthermore, institutions must maintain a vigilant eye on employees with account access, being watchful for irregular activities such as unauthorised access, transactions outside regular working hours, and anom-

alous fund transfers.

The banks must pay attention to internal fraud, reminiscent of insider threats. To mitigate this risk, stringent policies governing individuals, processes, and practices must be put in place, adding "For effective execution, the Chief Information Security Officer (CISO)/Chief Information Security Manager must be well-versed in their roles, wielding both knowledge and practical experiences and benchmarking against industry best practices during policy implementation."

As a financial institution, establishing and maintaining a comprehensive database containing information about known and emerging threats is highly paramount to help facilitate service hardening, noting that "Gathering data on fraud from both internal and external sources allows banks to garner a profound understanding of the ever-shifting fraud landscape." Moreover, such a database can serve as a valuable resource for employee training, enhancing their ability to identify potential fraud or threats.

The emergence of new scams doesn't mean the old ones are gone. Some people will still try to use the tried-and-true methods of stealing from banks. If you haven't already done so, implement fraud prevention for empty-envelope deposit scams, forged and fraudulent documents, forged checks, fraudulent loan applications, and wire transfer fraud.

The bank should form the habit of ATM scans, checks and cash deposited. You can also require a waiting period after an ATM deposit before the customer can withdraw cash from a deposit.

Although it's not new, wire transfer fraud is increasing. Training and education prevented most of these fraud attempts from succeeding.

Preventing wire transfer fraud can be done by training your employees on how to verify the authenticity of wire requests. One way is to make a phone call to the number listed on the account to verify that the account owner made the wire transfer request. For large amounts, it's especially important to use more than one method of verification.

While phishing and social engineering schemes have been around for a few years, they're still a huge problem. In fact, fraud management states that as much as "75% of fraudulent online banking payments activity originates from trusted accounts on trusted devices," which means that customers have been duped into making these payments.

"The best way to prevent phishing attacks from hooking victims is to teach people what to look for and to always be wary before clicking on a link in an email or a text." After the initial training, follow up with frequent reminders. People are often in a hurry when replying to email and need to be warned

all the time. You may also want to include a warning like this one with emails sent from all external email addresses: "CAU-TION: This email originated from outside our organization. Think before you click!"

Social engineering scammers use fear and other emotional tactics to trick people. Again, "education is one key to preventing this kind of fraud. Make sure your employees and customers know they should never give any personal information to a stranger, no matter how they present themselves and no matter how urgent it seems." Legitimate companies won't ask for such information over the phone or by email.

Another way to prevent fraud is to use sophisticated software that monitors transactions such as AI and machine learning to detect unusual activity on accounts and thus possible fraud. Make sure your online and mobile banking provider has such third parties incorporated into their system.

Also, someone at your institution should also be monitoring reports manually, looking for suspicious activity, such as the number of failed attempts when trying to log into the account. The fraud monitoring systems mentioned above only monitor the fraudsters' activity, once they've gotten into the user's account, so manually reviewing reports is a way to stop fraudsters from getting into the account to begin with.

Alert customers when there is suspicious activity involving your customers in fraud prevention by alerting them whenever unusual activity occurs on their account. You can ask them to opt-in or just automatically alert them when, for example, a charge on their credit card originates in a location far from their home. Because electronic fraud is so pervasive now, you may even want to offer an alert for customers any time their card is charged.

Also develop a multi-layered security system that is effective. An effective strategy to prevent and detect bank fraud requires a multi-faceted approach, involving administrative, physical, and technical controls: At the administrative level, financial institutions should devise policies, procedures, and guidelines to minimize risk. These may encompass security education and awareness programs and robust password management policies.

According to Bernard Shaw, progress is impossible without change; and those who cannot change their minds cannot change anything." A well-structured fraud detection strategy should not unduly disrupt a user's experience unless their activities raise legitimate suspicions. The banks need to strengthen their cyber security, educate their employees and customers, and invest in the right technology. These will help them to stay ahead in the race against financial fraud.

### Tinubu's tragic trials of Nigeria's malnourished minors

igeria is doddering on the edge of never-before-seen economic desolation, but President Bola Ahmed Tinubu administration's major preoccupation is not to bring ministration to a badly hurting nation but to prosecute harmless, impoverished, malnourished, and undernourished minors of northern Nigerian origin who, months ago, joined millions of Nigerians to protest for their right to a life without crippling poverty and fear, for which the only reply from the state has been detention and starvation.

On Friday social media platforms were suffused with piteous, nerve-wracking videos and photos of four malnourished minors-kids in their early teens whose bones bear witness to weeks in captivity-who collapsed in a courtroom in Abuja. Their fragile, pity-inducing bodies provide evidence of the brutal conditions they've endured in jail. It was an unmitigated scandal, a total embarrassment, a tear-jerking spectacle.

What intolerably rank insanity is this? What halfway sensible government would arrest, imprison, and then publicly try its underage children just because they stood against the unendurable economic tyranny that has pushed millions of Nigerians into incalculable torment?

These children didn't rise up in protest because they were troublemakers. They rose because they were hungry. They saw, in their communities, a growing tide of desperation and despair brought about by a series of misguided neoliberal policies that have squeezed every last drop of dignity from their lives.

The #EndBadGovernance protest was not an act of rebellion for the sake of anarchy, or for the overthrow of the Tinubu administration. It was a scream for survival in a country that has turned a deaf ear to its poorest, youngest, most vulnerable citizens. The children joined the protest, not because they were instigators, but because they are the victims of policies that have crushed them and their parents.

Now, Tinubu is prosecuting these poor children's audacity to feel hunger, their nerve to protest against it, and



their courage to ask for a better future.

Yes, young Nigerians, weakened by malnutrition, denuded of hope by unceasingly mounting prices, and drained by the unyielding fear that Nigeria's streets are now safer than its government, are being hauled into court as though they were hard-boiled criminals. There is no parallel for this that I can recall in Nigeria in my lifetime.

How hollow must we be, as a society, to accept that the government's solution to rising dissent and desperation is to prosecute the youth it has left to wither? This is not governance; this is a callous persecution masquerading as law and order.

The logic is Kafkaesque: punish the hungry, hush up the desperate, and maybe, just maybe, the problem will go away. But hunger and despair don't disappear when you throw a child in jail. Poverty doesn't vanish when you suppress a protest. The anger and frustration simmer, unaddressed, until they spill over.

I couldn't hold back tears at the sight of four minors, weak from hunger, fainting as they were called to stand trial. It's a sight that would shame even the most despotic regimes.

Here were young Nigerians, hand-

cuffed by a state that refuses to feed, clothe, or educate them, collapsing before their accusers as if in silent protest, their very bodies speaking louder than any courtroom defense ever could.

Even lawyers and court officials, perhaps briefly awakened from the stupor of compliance, rushed to assist them. But as the immediate shock subsided, what remained was an undeniable truth: Nigeria's youth are being starved, punished, and brought to the brink, not for crimes, but for demanding their right to survive in a country that fails them at every turn.

At the heart of this blot on Nigeria's escutcheon is a government that seems more beholden to the dictates of the International Monetary Fund and the World Bank than to the needs of its own people. President Bola Tinubu's administration has followed the familiar playbook of austerity and subsidy removal, but without the slightest regard for the human cost.

Inflation is climbing, prices are soaring, the naira is plunging, hope is walking away, and the nation is dying. Families cannot afford basic sustenance, the middle class is disappearing, the poor are being crushed beyond the bounds of tolerance, and the nation's

In a twist of poetic irony, the administration's heavy-handed tactics reveal a fearful truth: the voices of Nigeria's youth are a threat to the powerful. It is their courage, their unvielding desire for a better future, that sends tremors through the halls of power.

Instead of seeing in these children a spark of hope, a chance for renewal, the government has chosen to crush that spirit. These young people are Nigeria's conscience, and by silencing them, the state only exposes the depths of its own desperation and degeneration.

Where is the humanity, the leadership, the understanding that a nation's youth are its most precious resource? The Tinubu government must immediately end this untenably appalling charade of prosecuting minors who have the misfortune of being born in desperately poor homes.

It should release these children to their families forthwith. What the kids need is food, opportunity, and security, not prosecution. They are the voices of a generation calling out for empathy, action, and understanding, not retribution. Their cries are not a threat; they are a call to conscience, a summons to a government that has seemingly lost its way in the maze of worthless economic jargon and self-created fiscal constraints.

Let the children heal and live free of the fear that their hunger and hardship will be met with chains. The government must prioritize people over inhuman policies dictated by distant, no-good, vampiric financial institutions in Washington. It must recognize that these policies have consequences, consequences borne not by politicians and their cronies but by millions of Nigerians who struggle daily to survive.

For every child in that courtroom, for every young voice silenced by detention, Nigeria loses a part of its soul. Let this be a warning to those in power: the future is watching, and history will remember which leaders chose compassion over cruelty, justice over vengeance.

Because if a nation's children cannot protest peacefully without fear of reprisal, if their hunger is not a call to action but an excuse for punishment, then the government itself stands on trial—and it is failing spectacularly.

moral high ground. The temporary reprieve is nothing more than a bureaucratic sleight of hand, a way to postpone the embarrassment without addressing the real atrocity: the inhumane treatment of minors for daring to stand up against

### Ondo 2024: The candidates and what analysts say

The people of Ondo State will be heading to the polls on November 16, 2024 to elect a governor that will pilot the affairs of the state for the next four years.

According to the Independent National Electoral Commission (INEC), 17 political parties have nominated candidates for the election. The final list of candidates published by INEC on June 14th, 2024 includes incumbent governor, Lucky Aivedatiwa of the All Progressives Congress (APC), former deputy governor, Agboola Ajayi, of the main opposition People's Democratic Party (PDP), and 15 oth-

The commission, through its National Commissioner and Chairman, Information and Voter Education Committee, Sam Olumekun, disclosed that two political parties, the New Nigeria Peoples Party (NNPP) and the Social Democratic Party (SDP), conducted fresh primaries to replace their earlier nominated candidates and their running mates by the deadline of 10 June in line with the provision of Section 33 of the Electoral Act 2022.

Following the conclusion of the nomination process, public campaigns by political parties started on Wednesday, 19 June, and will end by the midnight of 14 November.

"As parties commence this critical phase of the election, the Commission once again reminds candidates, agents and their supporters of the provision of the law and the Commission's guidelines governing such activity. For emphasis, parties shall conduct their campaigns with civility and decorum devoid of inciting language, violence, voter inducement and other infractions in accordance with the provisions of Section 92-97 of the Electoral Act 2022," Olumekun

As the election date draws close, we take a look at the candidates.

### **LUCKY AIYEDAITWA (APC)**

Lucky Aiyedatiwa, the sitting governor of Ondo State, was born on 12 January 1965. He hails from Obe-Nla, an oil-bearing community in Ilaje Local Government Area of Ondo State.

He became an alumnus of Lagos Business School - Pan Atlantic University, Lekki, Lagos where he obtained Post Graduate Certification in Chief Executive Education (CEP) in Business Management in 2009. In 2013, he obtained a Master's Degree in Business Administration (MBA) from University of Liverpool, United

Aiyedatiwa worked as an Inventory/Store Officer at SCOA Assembly Plant Plc. Apapa, Lagos, between 1982 and 1983. In 1987 he was Assistant Head Teacher at Reliance International Schools, Ijokodo, Ibadan. He





worked as Marketing Officer at Universal Pharmaceutical Supply Co. Ltd, Ikeja, Lagos, Assistant Investment Analyst at Global Trust Limited, Lagos, and General Merchandise Manager, Biz Mart Nigeria Limited, Lagos.

He joined active politics in 2011 as a card-carrying member of the Action Congress of Nigeria (ACN) which later merged with other political parties and became APC. He was one of the National Delegates from Ondo State at the APC National Convention at Abuja in 2014. He contested for the federal House of Representative for Ilaje/Ese-Odo Federal Constituency in the 2015 election.

Aivedatiwa served as the federal commissioner who represented Ondo State on the Board of Niger Delta Development Commission from 2018 to 2019. He was selected as Rotimi Akeredolu's running mate in the 2020 Ondo State gubernatorial election. He became acting governor of Ondo State on 13 December 2023, as Akeredolu left for end-stage leukaemia treatment. Following the death of Akeredolu on 27 December 2023, Aiyedatiwa was sworn in as governor of Ondo State.

#### AGBOOLA AJAYI (PDP)

Agboola Ajayi, the candidate of the Peoples Democratic Party (PDP), was born on 24 September 1968 to Chief Newton Aiavi and Mrs Rebecca Ogunjinte (née Olubusade). He hails from Kiribo Town of Western Apoi tribe in the Ese Odo LGA of Ondo State. He attended Community High School in Kiribo Town and later moved to Methodist High School in Okitipupa LGA. Ajayi started his political career under the platform of Social Democratic Party (SDP) and became the chairman of SDP in Old Opoi Ward 1 from 1988 to 1998. He later joined PDP in 1998 and was made the Secretary of PDP in Ilaje/Ese Odo LGA between 1998 and 1999. He was later made the Supervisor for Agriculture for Ese-Odo LGA from 1999 to 2001 and subsequently appointed as Supervisor for Works and Transport for Ese-Odo LGA from 2001 to 2003. He then went on to become the Caretaker Chairman of Ese Odo LGA between 2003 and 2004 before he was finally elected as the chairman of Ese-Odo LGA from

2004 to 2007. He also served as member of the House of Representatives and represented Ilaje/Ese Odo federal constituency under the PDP. During his time in the House, Ajayi served as the chairman House Committee on NDDC from 2007 to 2010.

Ajayi later decamped from PDP to APC and was selected as the running mate to Rotimi Akeredolu (SAN) in the Ondo State Governorship election in November 2016 under the platform of APC. The pair won the election and were sworn in as governor and deputy governor of Ondo State on 24 February 2017. He contested the October 2020 governorship election in Ondo on the platform of the Zenith Labour Party (ZLP) and lost to late governor Akeredolu.

#### WHERE WILL THE PENDULUM SWING?

Stakeholders and political pundits in Ondo State and across the nation have adjudged the upcoming Ondo State governorship election as a twohorse race between the candidate of the ruling APC, Aiyedatiwa, and his main challenger, Agboola Ajayi of the PDP, with the other parties merely completing the list of contenders.

It should be noted that the two main candidates are both former deputies to late former Governor Akeredolu, both had fallen out with the late former governor, and both survived several impeachment attempts.

As the election nears, pundits are studying the body language of the Akeredolu political dynasty and wondering where they will pitch their tent. Though the Akeredolus are members of the ruling APC, they have been at loggerheads with Governor Aiyedaitwa before and after he succeeded late Governor Akeredolu.

Another political equation that pundits are looking at ahead of the November 16th election in Ondo State is which camp the FCT Minister, Nyesom Wike, who is serving in an APC administration, will support. Wike is an ally of former governor of Ondo State, Olusegun Mimiko. Both were part of the Integrity Group spearheaded by the G5 governors that gave full support to Bola Tinubu and rejected the PDP candidate, Atiku Abubakar, in the 2023 election. Will Wike support Agboola Ajayi, a member of his party the PDP, who is a political godson of former Governor Mimiko, or will he support Aiyedatiwa, the candidate of the APC and the ruling party that Wike currently serves under. Unlike the September 21 governorship election in Edo State where the FCT Minister, Wike made it very clear that he was not supporting the candidate of his party, Dr Asue Ighodalo, he has been silent regarding the Ondo State election.

### Atiku, Obi, others slam FG over detention of minors

he Federal Government of Nigeria has come under heavy fire following the detention and arraignment of minors who participated in the #EndBadGovernance protests in August.

The nationwide protests, sparked by acute economic hardship, took place between August 1st and 10th and led to the detention of several demonstrators, including children.

On Friday, November 1st, 76 protesters were arraigned in an Abuja court but, disturbingly, four minors among them collapsed in court due to severe hunger and stress accumulated from prolonged detention.

The collapse of the four minors in court caused chaos in the court-room, prompting Justice Obiora Egwuatu to immediately call for a recess to address the situation. Upon resumption, he ordered the remandment of protesters aged 18 and above at the Kuje Correctional Centre, while minors were sent to the Borstal Home of the Correctional Service. He also granted bail to the protesters the sum of 10 million naira each with two sureties in like sum which must include a civil servant and a parent or sibling of the protesters. The case was adjourned to January 2025.

Reacting to the development, former Vice President and presidential candidate of the Peoples Democratic Party (PDP) in the 2023 election, Atiku Abubakar, condemned this move by the Federal Government.


"I find it reprehensible that a man who claims to have fought for Nigeria's democracy and had led protests now demonises those who decide to demonstrate against the effects of his harsh and draconian policies," Atiku said in a tweet via his official page on X.

Citing the Child Rights Act, he stressed that children have a right to protest peacefully.

"Children who are the most affected by these policies have every right to protest peacefully, as guaranteed by the Constitution and the Child Rights Act. A nation can be assessed by the way it treats its most vulnerable citizens. It is saddening that even underage children are not spared from the wickedness of T-Pain," he wrote.

Also reacting, the Labour Party's

presidential candidate in the 2023 election, Peter Obi, pointed out that government officials have also participated in protests without facing consequences.

"Curiously, most of the people in government today leveraged this aspect of the Constitution standing as champions of good governance while in opposition," he wrote on X.

The Chairman, Senate Committee on Finance, Senator Musa Sani, also strongly condemned the Federal Government's detention of minors linked to the #EndBadGovernance protests. Musa, who represents Niger East Senatorial District, called on the National Judicial Council (NJC) to investigate the judge's decision and urged the Inspector General of Police, Kayode Egbetokun, to investigate the inhumane treatment and arraignment of the minors.

"I strongly condemn the unjust detention of minors following the #End-BadGovernance protests.... It is deeply troubling that, despite the hardships and challenges these young children have endured, there is a push to have them imprisoned rather than afforded compassion and understanding.

"Such actions are not only inhumane but also unjust. I also condemn the judicial stance advocating for the continued detention of these minors, which is entirely unacceptable and contrary to the principles of justice and fairness," he said in a statement.

Amnesty International Nigeria also frowned at the action. In a press release, the Director, Isa Sanusi, called on the government to release the detainees, stating that peaceful protest is not a crime and the government charging protesters for treasonable felony is a disregard for human rights.

"President Bola Ahmed Tinubu must immediately and unconditionally order the release of all #EndBadGovernanceInNigeria protesters still unlawfully detained nationwide solely for exercising their right to peaceful protest. Detaining protesters since August and charging them with bizarre offences, including 'treasonable felony' and 'terrorism-related offences', shows the Nigerian government's utter disregard for the right to freedom of assembly," he said.

Arewa Twitter Connect, a forum representing Hausa interests, also issued a 48-hour ultimatum to the Federal Government to release the detained children, or they would embark in a protest.

"We give the Government and the judiciary 48 hours to release these children and provide them with food, shelter and medical care or we shall come out en masse for a peaceful protest," they threatened.

Earlier, the Deputy Commissioner of Police, Simon Lough, had said the protesters were arrested in Kano, Kaduna, Katsina, Abuja, Gombe, and Sokoto for trying to overthrow President Bola Tinubu and destabilize Nigeria, an offence which, he said, contravenes Section 96 of the Penal Code and punishable under Section 97 of the code.

The police also told the court that the protesters allegedly destroyed some properties including High Court Complex, NCC Complex, Kano Printing Press, Government House Kano, Kaduna Investment and Promotion Agency and NURTW, thereby committing an offence contrary to Section 410 of the Penal Code (Northern States) Federal Provisions Acts CAP, P3, LFN 2004.

The police further alleged in court that the protesters tried to incite mutiny by calling for the removal of the President and saying they wanted the military. He said they were chanting, "Tinubu must go, Soja Musketo". In other words, "Tinubu must go, it is the military we want." This also runs contrary to Section 413 of the Penal Code.

They said the protesters publicly carried Russian flags and displayed it while chanting violent revolutionary songs and calling on the Russian government to overthrow the democratically elected government of Nigeria, which runs contrary to 114 of the Penal Code and punishable under section 111 of the code.

But counsel to the Federal Government, Rimazonite Ezekiel, said the boys standing trial are all adults and not minors.

"These boys we brought to court today, all of them are all adults. Most of them are married men, none of them is a minor. Some of them are university graduates. The small small kids you are seeing here, they came with their parents to come and visit their loved ones," he told newsmen.

Meanwhile, the Attorney General of the Federation, Lateef Fagbemi, has ordered the police to hand over the case file to him, saying he has commenced plans to move the trial date from January 2025 to a closer date.

"It has come to my notice that the police has arraigned those arrested in connection to the #Endbadgovernance violent protests in court for various offenses including treason. There are some issues my office will need to look into regarding the matter to enable me make informed decisions," he said.

Fagbemi pointed out that although it is not within his powers to vary the order of the court to remand the defendants in detention centres and adjourning the case to January, he has however directed the Nigeria Police to transfer the case file to his office and hand over to the Director of Public Prosecution of the Federation (DPPF) on November 2, 2024.

"I have further directed the DPPF to immediately put machinery in motion for consideration of the court to bring the adjournment date forward (an earlier date)," he said.

### #EndBadGovernance: SERAP gives Tinubu 48hrs to release hungry, malnourished children

he Socio-Economic Rights and Accountability Project (SERAP) has urged President Bola Tinubu to use his "leadership position and good offices to direct the Attorney General of the Federation and Minister of Justice Mr Lateef Fagbemi, SAN to take urgent steps to ensure the immediate and unconditional release of all the #EndBadGovernance protesters including the 32 hungry and malnourished children".

SERAP said "these children and other protesters are detained solely for the peaceful exercise of their human rights".

SERAP urged him "to direct Mr Fagbemi and appropriate law enforcement agencies to promptly investigate the circumstances surrounding the grave violations of the human rights of the children and other protesters in detention, and to identify and bring to justice those responsible, and ensure

justice and remedies for the victims".

It also urged him "to direct Mr Fagbemi and appropriate agencies to ensure the immediate access to medical treatment for all the protesters including the 32 hungry malnourished children for their apparently deteriorating health".

In the open letter dated 2 November 2024 and signed by SERAP deputy director Kolawole Oluwadare, the organisation said: "Bringing charges against children and detaining them simply for the peaceful exercise of their human rights is clearly not acting in the 'best interests of the child.

"The detention of the 32 hungry and malnourished children also infringes their right to education. These children ought to be in school, and not languishing in detention.

The apparent ill-treatment of the protesters including the 32 hungry and malnourished children have shined a light on the appalling conditions in Nigeria's prisons which continue to put

lives at risk".

The letter, copied to Dr. Matthew Gillett, the Chair-Rapporteur of the UN Working Group on Arbitrary Detention, read in part: "The continuing arbitrary detention of the protesters creates a climate of fear, discouraging other citizens from freely exercising their human rights, leading to a broader chilling effect.

"We would be grateful if the recommended measures are taken within 48 days of the receipt and/or publication of this letter. If we have not heard from you by then, SERAP shall consider appropriate legal actions to compel your government to comply with our request in the public interest.

"SERAP is concerned that Nigerian authorities are weaponizing the criminal justice system to curtail the rights of the children and other protesters to liberty, freedom of expression and peaceful assembly.

"We are concerned that the rights of the protesters to life, health, and safety are being violated in detention. Bringing charges against the protesters and detaining them is neither necessary nor proportionate.

"The conditions in which these children and other protesters are being detained are utterly inadequate and substantially below international standards.

"Children have the right to express their views freely in matters affecting them. Children's ability to engage in political and public affairs depends largely on the extent to which their rights are respected, protected and fulfilled.

"Your government has the obligations to ensure and uphold the rights of Nigerian children including to life, liberty, education and development, as well as to be treated in a manner consistent with the promotion of the child's sense of dignity and worth.

"Your government also has the obligation to provide a safe, enabling and empowering environment for young people to promote human rights.

"Your government has the obligations to promptly, thoroughly, impartially, independently, transparently and effectively investigate and appropriately punish those responsible for grave human rights abuses against the protesters in custody and to provide the victims with access to justice and effective rem-

"Any decision concerning a child must take full account of the child's best interests including by protecting the children from torture and cruel, inhuman or degrading treatment or punishment, and ensuring that the detention of a child is used only as a measure of last resort and for the shortest appropriate period of time.

"The Convention on the Rights of the Child to which Nigeria is a state party recognizes that children are entitled to a heightened duty of care because of their special status as children, which requires specific measures that take into account their level of development and evolving capacities."

### Nigeria positions for Al leadership with N2.8bn Google grant

igeria is taking a major leap towards becoming a leader in Artificial Intelligence (AI) innovation.

Nigeria's Federal Ministry of Communications, Innovation & Digital Economy (FMCIDE) has announced a collaboration with Google.org which includes a grant of N2.8 billion to support the development of a skilled AI workforce in Nige-

Google.org, founded in October 2005, is the charitable arm of Google, a multinational technology company. The organisation has committed roughly US\$100 million in investments and grants to nonprofits annually.

This initiative with Nigeria directly addresses the need for AI expertise in the country. The Google.org grant will be directed towards Data Science

Nigeria, an organisation working with the FMCIDE on AI talent development programs. Here's a breakdown of these programs:

DeepTech Ready Upskilling Programme: This program aims to equip 20,000 young Nigerians with advanced skills in data science and AI, preparing them for careers in this grow-

Experience AI Programme: This program targets educators, providing them with the tools and resources to introduce AI to 125,000 young people. This initiative aims to inspire the next generation of AI innovators.

Government AI Campus Programme: This program focuses on upskilling policymakers and government officials on AI policymaking. This ensures responsible development and implementation of AI policies in Nigeria.

Building a strong foundation in AI

"Years ago, as the Chairman of the State's Economy Team, we set up the ICTA but we struggled all through but we kept it alive, and set up the law governing it. The agency is principally responsible for providing technology for the government.

All Government jobs have been digitised, and it is not difficult to operate in Edo as files can't go missing again."

### NCC troubled as telcos lose staggering sums to vandalism, theft

The executive vice chairman of the Nigerian Communications Commission (NCC), Dr. Aminu Maida has lamented the hazards that telecommunications operators in Nigeria currently face by way of frequent fibre cuts, vandalism, and theft of equipment which costs them billions of naira.

Maida made this observation in the light of the recent declaration of telecom infra-the challenge.

While noting that the work-Information Infrastructure (CNII) by President Bola Tinubu through an Executive

shop series was to drive the urgent implementation of the CNII Executive Order as a major step towards securing Nigeria's communications and digital infrastructure, the NCC boss said: "The telecom industry faces significant challenges, including frequent fibre cuts, vandalism, and theft, which cost operators billions of naira in revenue and billions of naira in repair expenses.

"Additionally, restricted access to telecom facilities by property owners and government entities hampers network expansion efforts, limiting connectivity and impacting service quality."

Over the years, stakeholders in the Nigerian ICT sector have been calling on the government to designate telecom infrastructure as a critical national asset, to address the persistent attacks on the infrastructure across the country.

### Concerns raised as FG invests \$623m in surveillance tech

paces for Change (S4C), a civil society organisation, says in a new report that Nigeria has invested \$40 million in intercept technology and \$583 million in public surveillance systems.

These technologies allow legally sanctioned official access to private communications, such as telephone calls and e-mail messages, in a bid to enhance national security, prevent crime and aid criminal investigations.

Executive director of S4C, Victoria Ibezim-Ohaeri, says that "The Nigerian government has allocated approximately \$40m for intercept technologies and an estimated \$583m on public surveillance projects with Chinese tech firms.

Ibezim-Ohaeri, spoke at the West Africa Civil Society Week held in Abuja with the theme, "Leveraging Technology for Civic Engagement and Social Change in West Africa"

At the event held in collaboration with Civic Space Resource Hub, West Africa Civil Society Institute and the Ford Foundation, Ibezim-Ohaeri stated that this expenditure prioritised security over essential public services like education and healthcare, raising questions about the government's commitment to human rights.

With lawful interception (LI), law enforcement authorities, in response to a warrant from a judge, can perform interception, simply by applying a 'tap' on the telephone line of the target, making it possible for security agencies in Nigeria to listen to terrorist and criminal cell phone calls and gather communications intelligence on their dark activities.

Ibezim-Ohaeri, however, said her organization's report emphasised the historical context of surveillance in Nigeria, linking colonial practices to modern state surveillance tactics.

Key findings from the report indicated that the military regime significantly intensified state surveillance, enacting laws that curtailed press freedoms and facilitated the harassment of journalists and political activists.

"Just as the U.S. expanded surveillance post-9/11, Nigeria mirrored this response after the 2011 UN building bombing," she remarked, referring to legislation that broadened surveillance powers under the guise of national security.

The report outlined how civic actors and opposition politicians are often the primary targets of these surveillance initiatives.

"Evidence shows that state governors have acquired surveillance technologies to monitor political rivals, demonstrating the pervasive nature of these tactics," Ibezim-Ohaeri explained.

Furthermore, the report highlighted that most surveillance technologies used in Nigeria are imported from countries like Israel, China, and the United States, emphasising the risks posed by dual-use technologies that can be repurposed for oppressive measures.

"The dual-use nature of these technologies significantly contributes to their unchecked proliferation, often leading to abuses by both state and non-state

Despite existing legal frameworks, the report criticised the inadequacy of regulatory controls over surveillance technol-

"While laws exist to govern surveillance, their enforcement is weak, creating a fertile ground for abuse and misuse," Ibezim-Ohaeri cautioned.

In light of these findings, the report called for urgent reforms, including improved regulatory oversight and transparency in the procurement processes for surveillance technologies.

"We need a commitment to human rights that begins at the production stage, ensuring that surveillance technologies do not infringe on civil liberties,"

# NASU, SSANU suspend strike for one month: What next?

he Non-Academic Staff Union of Educational and Associated Institutions (NASU) and the Senior Staff Association of Nigerian Universities (SSANU) have announced suspension of the ongoing nationwide indefinite strike over the four months withheld salaries.

The SSANU and the NASU began an indefinite strike on October 28, protesting non-payment of salaries for over four months. This strike has disrupted school activities, forcing students to stay at home.

The salary dispute between the Federal Government and university non-teaching unions has intensified with the unions insisting on not returning to work until their demands are met. Although the Federal Government has approved payment of 50 percent of the four months' salaries, the strike continues.

During a meeting held last Thursday in Abuja with the unions, the chairman of the Joint Action Committee (JAC), Comrade Hassan Makolo, made it known that the leadership of the unions would call off the strike when members confirmed they had received payments alerts. Makolo emphasized that the unions are not strike-happy but are driven to action by unresolved issues.

Students are bearing the brunt of the strike, with essential services like water and electricity unavaila-

ble in school hostels. A University of Benin student noted that the backup generators are also inactive due to the strike and there is lack of water due to this development, impacting negatively on their learning and academics.

In a phone interview with a member of the non-teaching staff, Mr. Nelson, when asked if they ever intend to call off the strike if their demands are not met sooner?

He said the unions do not intend to back down until their demands are met, stating that they are not happy their salaries have not been paid and their agreement with the government to call off the strike depends on the government meeting their demands.

Asked if the Federal Government happens to come in between

the unions in the future what would be their stance? He answered, "The Union is well known but if the government comes in between the unions, we don't really care. Anyone that tries to break away is at their own expense, but until the government sees to our demands we will not back down".

The former Minister of State Education, Dr. Yusuf Sununu, while speaking at the meeting held last Thursday, pleaded with the unions that the Federal Government was looking into the matter having reached an advancement stage in their discussions.

Meanwhile, 98 percent of the unions' members have complied with the strike, refusing to back down until the government meets their demands.

Professor Amos Agbe Utuama, former Deputy Governor of Delta State, has been described as a university don whose sojourn into government brought phenomenal change to the quality of legislation in states. He was deputy to Dr. Emmanuel Eweta Uduaghan who was Governor from 2007 to 2015.

Extolling the late lecturer, the former Information Commissioner said the level of professionalism and integrity he brought to governance is in stark contrast to the narrative surrounding academics involved in the organisation of elections.

### Revolutionizing education the Montessori way

Por over the century, the Montessori system of teaching has been transforming the way children learn. Developed by a French physician and educator, Maria Montessori, in 1907, it is a unique system of teaching that focuses on self-directed learning instead of the traditional teacher teaching method, empowering the children to take ownership of their educational journey.

Maria Montessori, Italy's first female doctor, pioneered this groundbreaking method by opening her school, Casa dei Bambini, a children learning house in Rome on January 6, 1907 to support underprivileged children with learning difficulties. Maria encouraged the children to take ownership of their learning, bringing about personalised learning, she helped the children learn based on their development strengths and abilities. Her work led to her publication "Il Metodo della Pedagogia Scientifica applicato all'educazione infantile nelle Case dei Bambini," in 1909 gaining international recognition.

#### WHY IS MONTESSORI UNIQUE?

The Montessori method of teaching differs significantly from the traditional teaching method where the teacher has to stand in front of the class and give instructions to the children. It is a unique system because it

focuses on the child's individual learning ability. The Montessori teacher is trained to observe the children and guide them while they learn on their own, like Maria quotes, "The greatest sign of success for a teacher is to be able to say "The children are now working as if I did not exist".

The child becomes independent of themselves in learning. The Montessori method will give the child the freedom of choice to learn either with their peers or on their own, providing practical materials for them to work with. This helps the child to develop social skills and be capable of him/her enhancing also critical thinking, cognitive and social skills needed in this 21st Century.

The Montessori teacher uses practical materials and teaching aids to help make learning better. She/he observes each child's learning ability and helps to put them through. It emphasizes practical life skills teaching the child everyday activities like cooking, cleaning, caring for themselves and their environment.

Montessori also encourages mixed-age learning, the children are grouped into 0-3 years old for infant-toddlers, 3-6 years old for the nursery, 6-12 years old for the elementary, and 12-18 years old for secondary, fostering leadership skills and cooperation. Self correction and assessment is also achieved as they carry out their work inde-

pendently, they learn to correct and help themselves through the guidance of the teacher.

The Montessori classroom is beautifully designed to meet the child's needs and is equipped with practical materials like colouring, plants, movable letters and other teaching aids to help give the child a good learning environment. It is like an open field where the child learns and explores satisfying their curiosity. Research indicates that 75 percent of Montessori students report higher academic achievements according to the Montessori Research Project.

In view of this, some Montessori teachers expressed their opinions on the importance of Montessori learning. A teacher from Diamond Montessori Academy in Benin City, Miss Favour Okechukwu, notes, "Montessori helps the children capture what they are learning. For example, when a Montessori teacher wants to teach a topic on soil or colouring, she has to show the different soils to the child or use colourful things like balloons to show them the colours, and it will help the child remember easily what they taught."

Another teacher, Mrs Favour Isah, who had taught in two different Montessori schools - UPSS and Diamond Montessori School, says, "The method helps to make learning fun for the child using tools and materials that engage the five senses.

### **AFCON 2025 qualifiers: Nigerians in Libya to** face mass arrests, fines amid CAF ruling fallout

eports from Libya indicate a wave of arrests and \$500 fines imposed on Nigerian nationals, following a contentious ruling by the Confederation of African Football (CAF) that awarded Nigeria's Super Eagles three points and three goals.

The decision, made after Nigeria's men's team was detained for over 20 hours at Al-Abraq Airport, was issued by CAF's disciplinary committee after a complaint from the Nigeria Football Federation (NFF).

Libyan Football Federation President Nasser Al-Suwai'I has decried the CAF decision as "unjust and malicious," alleging undue influence from the NFF. The ruling has fueled resentment in Libya, where influential media sources, including Libya News Today, have called for strict measures against Nigerians residing in Libya, especially those lacking official documentation.

A post from Libya News Today, which has a substantial social media following, urged the Libyan government to fine undocumented Nigerian workers \$500 each and ensure deportation for those who fail to pay.

"All Libyan TV channels are

urging the government to arrest the Nigerian workers who are working here in Libya without legal papers. They have to pay \$500 plus taxes," read the post, further inciting tension.

A Libyan TV presenter has echoed these sentiments, labeling the earnings of Nigerians working without paying taxes as "haram," or sinful, and called for enforcing strict penalties and deportations. The popular

day morning and afternoon. He believes it's their way of getting revenge," he said.

Omoregie, who confirmed the story said, "The arrests started on Sunday night in some areas in Tedora. They are arresting innocent people. They don't even care whether you have passports or residence permits. They just don't care, which doesn't happen in other countries."

The situation has left Nigerians in Libya in an anxious state as they brace for intensified scrutiny, arrests, and financial penalties amid rising anti-Nigerian sentiments.

He believes Nigeria must adopt a "Production" model, focusing on sustainable sports development.


He presented a three-pillar strategy for Nigeria's sports sector, beginning with a focus on infrastructure.

orld No. 1 Jannik Sinner has withdrawn from the Paris Masters indoor tournament due to an "intestinal virus," tournament organizers announced.

Sinner, who secured the yearend top ranking in mid-October for the first time in his career at age 23, will be replaced in the draw by French qualifier Arthur Cazaux. Cazaux is set to face either fellow Frenchman Corentin Moutet or American Ben Shelton in the second round on Tuesday.

Organizers noted that Sinner contracted the intestinal virus before arriving in Paris.

The season's main goal for Sin-

ner remains the ATP Finals in Turin, where the year's top eight players will compete from November 10-17. Following this, he is expected to participate in the Davis Cup Finals in Malaga, Spain, where Italy is the defending champion.

Sinner has enjoyed a remarkable 2024 season, claiming his first two Grand Slam titles at the Australian Open and the US Open. Altogether, he has won seven tournaments this season, including three Masters 1000 events in Miami, Cincinnati, and Shanghai.

However, Sinner is facing a potential suspension due to a doping case that emerged a few weeks ago, following an appeal by the World Anti-Doping Agency (WADA).

After a timeout by the Hoopers' head coach Ogoh Odaudu, Okiki was fouled and made one of his two free throws, pushing the Hoopers' lead to 80-78. Koko then secured a key rebound in the final seconds, allowing Rivers Hoopers to hold onto their seventh consecutive win in the Atlantic Conference.


