#### 150m Nigerians 've access to adequate electricity -–FG

The Minister of Power, Adedayo Adelabu, has disclosed that approximately 150 million Nigerians now have access to adequate electricity, while 80 million still lack reliable power.

He made this known on Thursday during the 2025 Ministerial Sectoral Update Conference held in Abuja, where he spoke alongside the Minister of Information and National Orientation, Mohammed Malagi, and other key stakeholders.

Adelabu stated that the progress stems from Nigeria's participation in the "Mission 300" initiative an ambitious joint effort by the World Bank and the African Development Bank (AfDB) aimed at providing electricity access to 300 million Africans by 2030.

"The compact sets ambitious goals to enhance electricity access, increase renewable energy adoption, and improve clean cooking solutions for millions of Nigerians — that is Mission progress on this," he said.

He continued, "I'm happy to tell you that out of the 300 million Africans that the World Bank and AfDB aim to reach, Nigeria is on course to account for no less than 25 per cent, which translates to about 75 million Nigerians. When we presented our compact, they agreed with us."

According to Adelabu, Nigeria, with a population of over 240 million, currently provides adequate electricity access to 300, and we are making good 150 million people. However, he

emphasised that the issue is not merely access but the 'reliability' of that access.

"As it is today, Nigeria—a country with about 240 million people—has access for 150 million people already, while about 80 million lack access to adequate electricity in Nigeria.

The real challenge lies in the stability and affordability of electricity. That's how we measure reliability. We must ensure that those who have access enjoy consistent and affordable power," he said.

The minister urged global financiers to prioritise strengthening Nigeria's power grid alongside off-grid solutions, warning that over-reliance on renewables risks leaving urban areas and industries behind.

"When you're extending access to the 300 million people under this initiative, let's not concentrate solely on renewable energy-which is more appropriate for rural communities.

"Strengthening grid infrastructure is equally crucial so that those connected to the grid can enjoy reliable power. Otherwise, how do we explain the growing number of Nigerian companies opting out of the national grid to generate captive power?"

The minister also highlighted recent improvements in Nigeria's power generation capacity.

We have increased our generation to 6,003 megawatts, up by 1,700 megawatts in one and a half years since President Tinubu as-

## Second Benin flyover gets EXCO approval

The Edo State Government has reaffirmed its commitment to infrastructural transformation under the leadership of Governor Monday Okpebholo, as construction continues on the first-ever flyover bridge in Benin City.

According to the Commissioner for Information and Communication, Hon. Paul Ohonbamu, this project is not merely a physical structure, but a bold testament to the governor's vision for sustainable urban development.

In a statement issued in Benin City, Ohonbamu dismissed circulating rumours suggesting that the flyover project had been halted, describing such claims as politically motivated falsehoods.

He revealed that the State Executive Council, during its most recent meeting on Monday, 14 April 2025, approved the construction of a second flyover bridge at the Adesuwa-Sapele intersection—another Road milestone in the government's ambitious infrastructure agenda.

he ensures that every project, especially those with significant public impact, meets the highest standards. He personally monitors these projects to guarantee quality delivery."

Describing the governor as a leader who prefers action over rhetoric, Ohonbamu said Okpebholo is determined to place Edo State on the path of long-term growth, through the construction of roads, schools, and support for grassroots communities. He urged citizens to remain patient, stressing that the governor's focus is on rebuilding livelihoods and delivering tangible joy to the people.

According to the Commissioner, Okpebholo is already fulfilling key promises made during his campaign, with improved road connectivity serving as a foundation for broader development across the state. "The flyover projects are not isolated efforts," Ohonbamu explained, "they are deliberate steps in the modernisation of Benin City and the integration of rural communities into the state's economic framework."

He also addressed the quality of the ongoing works, noting that the governor is particularly concerned with the durability and structural integrity of all

projects. "The governor insists on reputable contractors and stringent adherence to specifications," Ohonbamu said. "These developments will speak for the administration far more effectively than political slogans."

## Adesina urges end to raw material exports

As Africa seeks economic transformation

**♦** The President of the African Development Bank, Dr. Akinwumi Adesina, has called on African nations to put an end to the export of raw materials if the continent is to overcome poverty and underdevelopment.

According to data from the Office of US Trade Representative and other multilateral institutions, Africa accounts for less than 2 per cent of global manufacturing.

In a post shared on Thursday via his official X handle, Adesina stressed the need for Africa to shift from being a supplier of producer of value-added goods.

"Africa must end the exports of its raw materials. The export of raw materials is the door to poverty. The export of

value-added products is the highway to wealth. And Africa is tired of being poor," he wrote.

Despite Africa being home to the world's most sought-after raw materials, its share of global trade remains under 3%. Efforts to change this narrative have gained momentum in recent years.

Initiatives such as the African Continental Free Trade Area are designed to enhance intra-African trade, boost manufacturing, and encourage value addition across sectors.

Adesina has consistently advocated for policies that proergy expansion, and improved infrastructure as a foundation for transforming Africa's econ-

## **Gunmen ambush NSCDC** operatives in Bayelsa, kill one

Nigeria Security and Civil Defence Corps (NSCDC) officer has been confirmed dead following an ambush by suspected militants in the Igbomotoru community, located in the Southern Ijaw Local Government Area of Bayelsa State.

According to local sources, the NSCDC team was returning from an operation targeting illegal bunkering activities in the area when they were attacked on Friday. The assailants, believed to be armed militants, reportedly opened fire on the operatives, leading to a fierce exchange of gunfire.

During the confrontation, the deceased officer was said to have been shot at close

range. The attackers, who were heavily armed with high-calibre weapons, allegedly overpowered the security team.

Several other operatives sustained injuries in the attack and have since been evacuated to a medical facility in Yenagoa for treatment.

When contacted, spokesperson for the Bayelsa State Police Command, Solomon Ogbere, confirmed awareness of the incident but noted that a full report had yet to be received.

"The information, sincerely speaking, we've gotten it, but I'm still waiting for the OC to give me a comprehensive report. You're not far from the truth, but I can't speak definitively yet because I haven't received all the details," Ogbere stated.

## NAF strikes insurgent camps in Sambisa forest, kills several terrorists

**T**he Nigerian Air Force on Thursday said two conducted insurgent on strongholds in Borno State killed several terrorists.

The service said the coordinated air interdiction missions, executed under the Air Component of Operation HADIN KAI, targeted Kollaram and Arratwo locations long considered havens for terrorist activity in the Sambisa general area and the Southern Tumbuns.

This was contained in a statement by the Director of Public Relations and Information at NAF Headquarters, Air Commodore Ehimen Ejodame, on

Ejodame said the first strike occurred at about 5:30 a.m. in Kollaram after Intelligence and surveillance footage confirmed the presence of high-value terrorist commanders and active operational hubs, including structures fitted with solar panels used by the fighters.

He said, "In a bold display of force and precision, the Nigerian Air Force (NAF), under the Air Component of Operation HA-DIN KAI, executed two highly successful air interdiction missions on April 15, 2025, targeting terrorist strongholds in Borno

State's Sambisa general area and the Southern Tumbuns.

"The first strike occurred at approximately 5:30 a.m. in Kollaram, a known stronghold of insurgents. Intelligence reports, supported by surveillance footage, confirmed the presence of high-value terrorist commanders in the area. Several structures, some equipped with solar panels, were identified as active terrorist hubs.

"Nigerian Air Force assets carried out a precision strike on the location, eliminating several fighters and disabling key infrastructure."

He added that later in the day,

at around 3:55 p.m., NAF assets struck again in Arra, Sambisa.

According to him, real-time visuals gathered from Intelligence, Surveillance and Reconnaissance missions revealed clusters of armed militants.

"Precision-guided munitions were employed, resulting in the effective destruction of targets and disruption of the group's operational capabilities.

"These back-to-back missions are part of a sustained air campaign designed to erode terrorist capabilities, dismantle leadership structures, and eliminate sanctuaries across Nigeria," Ejodame added.

This 230% hike affected roughly 1.9 million consumers.

The government had previously explained that the hike was necessary due to the unsustainability of energy subsidies, which were projected to cost ₹2.9 trillion in 2024. Even with the increase, ₩2.8 trillion was still budgeted for electricity subsidies that year. NERC estimated that the tariff adjustment would reduce subsidy obligations by ₹1.14 trillion.

However, the move has drawn criticism. The Institute of Chartered Accountants of Nigeria (ICAN) called it "an additional burden on already struggling citizens." The Abuja Chamber of Commerce and Industry similarly expressed concerns about the impact on Small and Medium Enterprises (SMEs), citing increased operating costs.

Despite improvements in generation, Nigeria's grid continues to underperform. In 2024 alone, the national grid suffered no fewer than 12 collapses, plunging major cities such as Abuja, Lagos, and Kano into repeated blackouts.

Last week, Adesina criticised the disproportionate allocation of the International Monetary Fund's Special Drawing Rights, revealing that Africa received just \$33 billion, only 4.5 per cent of the \$650 billion issued globally.

### **CBEX:** House empathises with victims, calls for urgent crackdown on perpetrators of fraud

The House of Representatives has expresses deep concern over alarming reports on the collapse of a fraudulent cryptocurrency investment scheme known as "CBEX," which has reportedly trapped funds belonging to thousands of Nigerians, with financial exposure estimated to exceed ₹1.3 trillion.

The House extends heartfelt empathy to citizens currently facing distress and uncertainty due to their involvement in this elaborate scam through a press statement made available to newsmen by Rep. Akin Rotimi, Jr., the Spokesman, House of Representatives on Thursday

Preliminary findings indicate that the platform, which is not registered with the Securities and Exchange Commission (SEC), deceptively adopted the name "CBEX," though it bears no affiliation with the legitimate China Beijing Equity Exchange - a Chinese equity trading institution that has disavowed any involvement in digital asset trading or operations in Nigeria.

This large-scale fraudulent scheme, which promised unrealistic returns and preyed on public trust, highlights the growing risks posed by unregulated digital investment platforms.

The House notes that the Economic and Financial Crimes Commission (EFCC) and the Nigeria Police Force have already commenced coordinated investigations, working in concert with Interpol to track the perpetrators, safeguard investors, and recover withheld funds where possible.

"We urge these agencies to sustain swift and effective action in

identifying, apprehending, and prosecuting the masterminds of this massive financial crime".

The House also underscores the importance of the recently enacted Investment and Securities Act (ISA), 2025, signed into law by His Excellency, President Bola Ahmed Tinubu, GCFR.

This landmark legislation - resulting from sustained legislative efforts across the 8th, 9th, and 10th Assemblies - strengthens the SEC's enforcement powers, criminalises Ponzi schemes and related frauds, and introduces stricter penalties, including up to ten years' imprisonment.

Through these reforms, the investor protection responsibility of the SEC has been enhanced, reinforcing its mandate to shield Nigerians from fraudulent investment activities.

Chairman of the House Committee on Capital Market and Institutions, Rep. Solomon T. Bob (PDP, Rivers), remarked:

"We must continue to confront financial fraud with the full weight of the law. But beyond enforcement, we must invest in public awareness. Financial literacy is not optional; it is essential in building a resilient, inclusive economy. Fraudsters thrive where ignorance prevails."

The House advises Nigerians to exercise utmost caution and verify all investment opportunities with the SEC and other regulators.

Citizens must remain vigilant to the hallmarks of fraud - especially promises of high returns with little or no risk.

Furthermore, public figures, celebrities, and influencers are reminded of their civic and legal

## Delta police nab over 100 crime suspects

**T**he Delta State Police Command has recorded a significant progress in its ongoing battle against insecurity, with the arrest of over 100 crime suspects and the rescue of 13 kidnapped victims.

The suspects were alleged to have been involved in various crimes, including armed robbery, kidnapping, murder, cultism, and sexual offences.

This was made known by the Commissioner of Police, CP Abaniwonda Olufemi, during the Command's first-quarter

press briefing for the year 2025, held in Asaba.

Providing a comprehensive breakdown, CP Abaniwonda stated that during the first quarter of 2025, the Command apprehended 35 suspects linked to armed robbery, 24 suspected kidnappers, 21 murder suspects, 22 cultists, and 4 suspects of rape and defilement cases.

The arrests, he said, were part of the Command's strategic and intelligence-driven approach to policing aimed at rooting out crime and restoring public safety

Besides the arrests, the Com-

mand said it also recovered a significant cache of arms and ammunition. A total of 53 weapons were confiscated, including 11 AK-47 rifles, 1 G-3 rifle, 9 Beretta pistols, 19 single-barrel and cut-to-size guns, and 13 pump-action guns.

The police also seized 5,612 rounds of live ammunition and cartridges of various calibre during various operations.

The Commissioner revealed that 13 victims who had been kidnapped were successfully rescued and reunited with their families, while 14 suspected stolen vehicles were recovered.

The operations equally led to the seizure of assorted illicit drugs and substances, which, he said, posed a threat to youth and community safety.

One of the major breakthroughs highlighted was the neutralization of a notorious kidnap syndicate operating in and around Ogwashi-Uku, Ibusa, Issele-Uku, Ubulu-Uku, and neighbouring communities.

According to CP Abaniwonda, the syndicate, believed to be behind a string of abductions in the region, was eliminated during a gun battle with police operatives.

In a strongly worded letter titled "Severe and Brazen Acts of Lawlessness and Impunity Being Carried Out by the Administrator of Rivers State, Vice Admiral Ibok Ete-Ibas, and the Need to Nip Them in the Bud in the Interest of Mutual Peace and Constitutionalism," the groups urged the Chairman of the Ad Hoc Committee on Rivers State Oversight to take immediate action to halt what they describe as a "drift towards authoritarianism."

The document accused Ibas, who is referred to in the letter as the "Administrator of Rivers

State," of undermining constitutional governance.

It alleged that he has been using federal power and security operatives to intimidate public officers, suppress democratic institutions, and interfere with the proper functioning of government in the state.

The conduct of Vice Admiral Ibok-Ete Ibas is not only reckless and unconstitutional but also a slap in the face of democratic values. His actions have continued to aggravate political instability and institutional breakdown in Rivers State," the coalition said in the letter.

The groups demanded that the National Assembly should immediately:

Call Vice Admiral Ibas to order and investigate the legality of his actions;

Ensure that democratic institutions in Rivers State, particularly the legislature, are allowed

Direct security agencies to cease illegal occupation of the Rivers State House of Assembly Complex.

They warned that if left unchecked, the continued disruption of civil authority could incite public unrest and erode trust in Nigeria's democratic framework.

# **Briggs rallies communities in Edo South to safeguard school projects**

he Executive Chairman of the Edo State Universal Basic Education Board (SUBEB), Barrister Mrs. Onomen Briggs has called for greater community involvement in protecting and maintaining government-funded education projects.

She made the call during a working visit to several school construction sites in Edo South Senatorial District.

Her tour underscored both the pace of ongoing construction and the importance of timely delivery, especially as the new academic term approaches.

At Adolor Primary School in Okabere community, Briggs inspected a major project spearheaded by LaVida Systems Ltd, involving a block of six classrooms, six toilet units, administrative offices, a perimeter fence, borehole installation, and general renovation. With most of the work nearing completion.

The community's traditional head, Mr. Fred Osadolor, lauded the state government for the intervention, pledging that the people of Okabere would ensure the facility remains protected and fully functional.

His assurances were echoed by Mr. David Ogbebor, Chairman of the School-Based Management Committee (SBMC), who reaffirmed the committee's readiness to oversee the ongoing works and support their successful conclusion.

At Umagbae Junior Secondary School, Briggs visited two active construction sites. One

block of six classrooms has been roofed and awaits interior finishing, while another block—currently at the damp-proof course (DPC) stage—will mirror the same structure.

Both projects include perimeter fencing, reinforcing the emphasis on school security and long-term maintenance.

Briggs used the occasion to express concern over the deteriorating condition of classrooms in many parts of the district and commended the Governor of Edo State, Senator Monday Okpebholo for declaring a state of emergency in the education sector.

She noted that the bold step has translated into tangible improvements in basic education infrastructure across the state.

While engaging with site

engineers, she urged them to fast-track their work to ensure all facilities are ready for pupils before schools reopen.

She also restated the critical role of local stakeholders in sustaining these developments, highlighting the SBMC's responsibility to guard against vandalism and neglect.

Commending the leadership of both Mr. Osadolor and Mr. Ogbebor, she encouraged other communities to emulate Okabere's model of grassroots ownership.

Accompanying the SUBEB Chairman on the tour were Martins Amune, Director of Projects and Planning; Mr. Austin Otas, Director of Schools; and Pastor Mrs. Angela Okpamen, the Board member representing Edo South.

## **Uromi killings:** Edo Police Commissioner says no reprisal attacks expected

he newly appointed Commissioner of Police in Edo State, CP Monday Agbonika, has assured residents that no reprisal attacks are anticipated following the recent killing of 16 hunters from Kano State in Uromi, Esan North-East Local Government Area.

Speaking during a visit to the Edo State Council of the Nigeria Union of Journalists (NUJ) on Thursday, Agbonika stated that the state government, under Governor Monday Okpebholo, had taken proactive steps to de-escalate tensions and prevent any outbreak of violence.

"A number of decisive measures have been taken regarding the Uromi incident, and at this point, we do not foresee any reprisal attacks," the police comnissioner said

He praised Governor Okpebholo's swift response, highlighting his outreach to affected communities both within and outside the state.

"The governor has done a lot—when I first resumed duty, we visited Uromi together. Prior to that, he travelled to Kano State to commiserate with the families of the deceased and to appeal for calm. He urged them to speak to their people residing in Edo State to ensure that peace is maintained."

Agbonika further disclosed that the governor's peace mission had prompted a reciprocal visit by the Kano State Government. "As a result of his efforts, the deputy governor of Kano State visited Edo to demonstrate solidarity and support peaceful coexistence."

According to Agbonika, both

the Esan and Hausa communities in Uromi were engaged in dialogue during the visit, which contributed significantly to easing tensions. "We met with stakeholders from both the Hausa and Esan communities. The dialogue, along with other measures taken by the governor, helped to calm nerves and correct misinformation."

He added that his peace-building efforts extended beyond Uromi. "I did not stop at Uromi. I visited neighbouring areas with significant northern populations—places like Igara and Auchi—where I met with community leaders. I made it clear that we must continue to live in peace despite what has happened. And I've received assurances from their leaders that they remain committed to peaceful coexistence."

CP Agbonika emphasised

the importance of community cooperation in sustaining peace and tackling crime.

He said the police command was intensifying operations across the state, particularly targeting criminal hideouts.

"As part of our renewed strategy, all officers have been mobilised to conduct patrols and comb through criminal enclaves. We are taking this fight to every corner of the state. But we cannot do it alone—we need the support of the public. I urge residents to share useful information with us and to give us the benefit of the doubt. Let us see what unfolds in the next three months."

In response, the NUJ Chairman in Edo State, Dr Festus Alenkhe, pledged the union's cooperation with the police in their efforts to tackle crime and maintain order.

## Dr. Osehobo bags award for pioneering telemedicine breakthrough in Edo's rural clinics

been recognised with a distinguished award at the 2025 Association of Nigerian Physicians in the Americas (ANPA) conference, held at the EKO Hotel and Suites in Lagos, for leading a transformative telemedicine project that is reshaping healthcare deliv-

The accolade was awarded in celebration of a year-long study titled "Telemedicine Promise for Tomorrow: The Role of Video Synchronous Medical Consultation in a Primary Health Center (PHC) in a Sub-Saharan Africa Setting."

The project brought togeth-

ical Clinic in Griffin, Georgia, USA, and three co-researchers-Pamela Moye of Mercer University in Atlanta, Dr. Teresa Pounds of Clinipharm Global Health USA and the University of Benin, and Dr. Obehi Akoria of the University of Benin Teaching Hospital.

The research was conducted across three primary healthcare centres located in Oredo, Ukpenu, and Ugbor, where synchronous, two-way video consultations connected local

in the United States.

The initiative focused on individuals with chronic illnessesparticularly hypertension and diabetes-who often face barriers to consistent medical care due to poverty and remoteness.

Findings from the pilot were compelling. Of the 75 participants, two-thirds of whom were women with an average age of 66, notable clinical improvements were recorded. Systolic blood pressure fell significantly—by as much as 22 mmHg at both the abetic patients in Ukpenu also showed marked reductions in fasting glucose levels.

Speaking at the event, Dr. Osehobo hailed the recognition as a victory for both innovation and equity in healthcare, emphasising that the project proved how modern technology and global partnerships can bridge the healthcare divide and reach the most marginalised populations.

Dr. Akoria, representing the research team, described the results as a strong endorsement egy for strengthening Nigeria's struggling primary health sector, urging policy-makers and institutions to adopt and scale such solutions nationwide.

The award not only celebrates individual achievement but also signals a wider shift toward digital health interventions on the continent. It highlights the growing role of diaspora-led collaborations in addressing Africa's longstanding healthcare challenges through innovative, tech-driven models.

## Remi Tinubu urges Ondo monarchs to help end HIV, FGM

he wife of the President, Senator Oluremi Tinubu, has called on traditional rulers in Ondo State to help eradicate female genital mutilation, Hepatitis B, and other diseases affecting women in the state.

Mrs Tinubu also urged them to support her advocacy in tackling pressing health challenges affecting Nigerian women, including the elimination of mother-to-child transmission of HIV/AIDS, Hepatitis B, Syphilis, and Tuberculosis, among others.

She made the call during a meeting with members of the Ondo State Council of Obas in Akure, the state capital, as part of her visit to the state on Thursday.

Tinubu said, "Ending female genital mutilation is also one of our key priorities. It is a harmful and outdated tradition built on myths. It does not stop promiscuity, as some believe. Instead, it destroys the lives of young girls."

The Nigerian First Lady, who also flagged off the South-West leg of the Renewed Hope Initiative as part of efforts to improve the well-being of women and girls across the country, announced plans to distribute no fewer than 10,000 professional kits - comprising Crocs and scrubs - to nurses and midwives in the South-West region.

She also introduced a new menstrual hygiene campaign, tagged Flow with Confidence, through which her office intends to supply 10,000 sanitary pads to young girls in each state, with a focus on rural areas.

In his remarks, the Chairman of the State Council of Obas and Olowo of Owo, Oba Gbadegesin Ogunoye, who was represented by the Deji of Akure, Oba Aladetoyinbo Aladelusi, commended Mrs Tinubu's initiatives and pledged the support and prayers of the traditional institution.

The monarch said, "We may not be able to offer financial help, but our prayers will never cease for the success of President Tinubu's administration."

He also praised the First Lady's loyalty and visible support for her husband, stating that "By the time Asiwaju completes his first term, Nigerians will beg him to go for another."

### World Economy should avoid recession despite tariffs —IMF

The global economy is likely to avoid a recession despite the hit to growth from US President Donald Trump's tariff rollout, the head of the International Monetary Fund said Thursday.

The stop-start US tariff plans have fueled levels of market volatility unseen since the Covid-19 pandemic, and most economists expect the imposition of new import levies will stifle growth and push up inflation, at least in the short term.

Trade disruptions "incur costs," IMF Managing Director Kristalina Georgieva told reporters in Washington on Thursday according to prepared remarks, adding that the Fund now ex-

pects "notable" markdowns to growth but no recession.

"This is a reminder that we live in a world of sudden and sweeping shifts," she said of the recent market volatility during her speech, which came ahead of next week's Spring Meetings — a gathering of global financial leaders co-hosted by the IMF and the World Bank in the US capital.

"And it is a call to respond wisely," she added.

Her comments suggest the IMF will use its upcoming World Economic Report, published Tuesday, to pare back its previous forecast for global growth to hit 3.3 percent in 2025 and 2026.

## The rights and responsibilities in Islamic neighbourhood

raise be to Allah, the Lord of all that exists. We praise Him, seek His help, and ask for His forgiveness. We seek refuge in Allah from the evil of our own souls and from the evil consequences of our deeds. Whomsoever Allah guides, none can lead astray, and whomsoever Allah leaves astray, none can guide. I bear witness that there is no god but Allah, alone, without any partners, and I bear witness that Muhammad is His servant and messenger. May the peace and blessings of Allah be upon him, his family, his companions, and all those who follow him in righteousness until the Day of Judgment.

O servants of Allah! Fear Allah as He should be feared, and do not die except as Muslims

Today, in this blessed congregation, we turn our hearts and minds to a fundamental pillar of our faith, a cornerstone of a thriving and compassionate society, the concept of neighbourhood in Islam. This is not merely a matter of geographical proximity; rather, it is a profound spiritual and social obligation, deeply rooted in the teachings of the Holy Quran and the Sunnah of our beloved Prophet Muhammad (peace and blessings be upon him).

Islam, as a comprehensive way of life, meticulously outlines the rights and responsibilities that individuals hold towards one another, fostering a harmonious and supportive community.

Among these rights, the rights of the neighbour occupy a significant and elevated position. The Quran and Sunnah are replete with injunctions emphasizing the importance of treating neighbours with kindness, respect, and compassion. Neglecting these rights is not merely a social failing; it is a transgression against the very principles of our faith, potentially leading to spiritual deficiency and divine displeasure.

Allah Subhanahu Wa Ta'ala emphasizes the importance of neighbours in the very fabric of our existence, mentioning them alongside the most fundamental relationships in Surah An-Nisa (4:36):

"Worship Allah and associate nothing with Him, and to parents do good, and to relatives, orphans, the needy, the near neighbour, the distant neighbour, the companion at your side, the traveler, and those whom your right hands possess. Indeed, Allah does not like those who are self-deluding and boastful."

In this powerful verse, Allah Almighty enjoins us to treat the neighbour, both near and distant, with ihsan - excellence, goodness, and kindness. This is not a mere suggestion; it is a divine command, placed alongside the fundamental duty of worshipping Allah alone and being good to parents and relatives. The inclusion of both the "near neighbour" (al-jaar dhi al-qurba) and the "distant neighbour" (al-jaar al-junub) highlights the universality of this obligation. It transcends familial ties and geographical closeness, encompassing all those who reside in our vicinity, regardless of their background, faith, or social standing.

The Prophet Muhammad (peace and blessings be upon him) further elaborated on the profound significance of the neighbour's rights through his words and actions. So emphatic were his pronouncements that the companions even began to believe that neighbours would inherit from one another. Imam Bukhari and Muslim narrated from Aisha (may Allah be pleased with her) that the Prophet (peace and blessings be upon him) said:

"Angel Jibril (Gabriel) continued to advise me concerning the neighbour until I thought he would make him an heir."

This powerful statement underscores the immense importance Allah and His Messenger (peace and blessings be upon him) placed on the well-being and rights of the neighbour. The constant reminders from the angel Jibril, the intermediary of divine revelation, highlight that fulfilling the rights of the neighbour is not a peripheral matter but a central tenet of Islamic conduct.

What then are these rights that Islam so strongly emphasizes? They are multifaceted and encompass various aspects of our interactions with those around us.

### KINDNESS AND GOOD TREATMENT (AL-IHSAN):

The cornerstone of neighbourly relations in Islam is kindness and good treatment. This includes speaking to them politely, greeting them warmly, and showing them a friendly disposition. The Prophet (peace and blessings be upon him) said:

"Whoever believes in Allah and the Last Day, let him be good to his neighbour." (Sahih Muslim)

This hadith connects good treatment of the neighbour directly to the very essence of faith. It is a manifestation of one's belief in Allah and the accountability of the Hereafter.

### AVOIDING HARM AND ANNOYANCE (Kaff al-Adha):

Just as important as being kind is refraining from causing any harm or annoyance to our neighbours. This includes physical harm, verbal abuse, spreading rumors, or any action that might disturb their peace and tranquility.

Allah Subhanahu Wa Ta'ala warns against those who harm their believing men and women without any just cause in Surah Al-Ahzab (33:58):

"And those who harm believing men and believing women for [something] other than what they have earned have certainly borne upon themselves a slander and manifest sin."

While this verse specifically mentions harming believers, the principle extends to all neighbours, regardless of their faith. The Prophet (peace and blessings be upon him) said:

"By Allah, he does not believe! By Allah, he does not believe! By Allah, he does not believe!" It was said, "Who, O Messenger of Allah?" He said, "The one whose neighbour is not safe from his evil deeds." (Sahih Bukhari and Muslim)

This stern warning highlights the severity of harming one's neighbour. It negates the very claim of faith if a person's neighbour does not feel secure from their ill-treatment.

## SHOWING COMPASSION AND SUPPORT (Al-Rahmah wal-Mu'awanah):

Islam encourages us to be compassionate and supportive towards our neighbours, especially in times of need.

This includes visiting them when they are sick, offering condolences when they are bereaved, and helping them overcome difficulties.

The Prophet (peace and blessings be upon him) said:

"He is not a believer who eats his fill while his neighbour beside him is hungry and he knows it." (Al-Mu'jam Al-Kabir by At-Tabarani)

This hadith emphasizes the importance of being aware of our neighbours' circumstances and extending a helping hand when they are in need. It is a powerful reminder that our faith is not just about individual piety but also about our responsibility towards the community around us.

### PRESERVING THEIR PRIVACY (Sitruhum):

Islam teaches us the importance of respecting the privacy of our neighbours and not intruding into their personal lives. We should avoid eavesdropping, spying, or spreading information about them that they would not want to be public. Allah Subhanahu Wa Ta'ala says in Surah Al-Hujurat (49:12):

"O you who have believed, avoid much [negative] assumption. Indeed, some assumption is sin. And do not spy or backbite one another. Would one of you like to eat the flesh of his brother when dead? You would detest it. And fear Allah; indeed, Allah is Accepting of repentance and Merciful."

While this verse addresses believers in general, the principle of avoiding suspicion, spying, and backbiting is particularly relevant in the context of neighbourly relations, where proximity can sometimes lead to unwarranted interference.

#### RESPONDING TO THEIR INVITATIONS AND ACCEPTING THEIR GIFTS (Ijabatu Da'watihim wa Qabulu Hadaayaahim):

Islam encourages us to foster positive relationships with our neighbours by responding to their invitations and accepting their gifts, as long as there is nothing contrary to Islamic principles involved. This strengthens the bonds of friendship and goodwill within the community. The Prophet (peace and blessings be upon him) said:

"Respond to the invitation and do not reject the gift." (Sahih Bukhari in Al-Adab Al-Mufrad).

Allah does not forbid you from those who do not fight you because of religion and do not expel you from your homes from being righteous toward them and acting justly toward them. Indeed, Allah loves those who act justly OFFERING CONGRATULATIONS IN TIMES OF JOY AND CONDOLENCES IN TIMES OF SORROW (Tahni'atuhum fil-Afrah wa Ta'ziyatuhum fil-Atrah):

Sharing in the joys and sorrows of our neighbours is an essential aspect of Islamic brotherhood and neighbourly conduct. Offering congratulations on happy occasions and expressing condolences during times of grief strengthens the social fabric and provides emotional support.

## FORBEARING THEIR MISTAKES AND OVERLOOKING THEIR SHORTCOMINGS (AI-Sabru 'ala Akhtaa'ihim wat-Taghaful 'an Zallaatihim):

As human beings, we are all prone to making mistakes. Islam teaches us to be patient with our neighbours, to overlook their minor shortcomings, and to avoid being overly critical or judgmental. This fosters a spirit of tolerance and understanding within the community.

#### MAINTAINING GOOD RELATIONS EVEN IF THEY ARE NON-MUSLIMS (Husnul-Jawar ma'a Ghairil-Muslimeen):

The rights of the neighbour in Islam extend even to those who are not Muslims. We are commanded to treat them with justice, kindness, and respect, and to avoid any form of oppression or discrimination. Allah Subhanahu Wa Ta'ala says in Surah Al-Mumtahanah (60:8):

"Allah does not forbid you from those who do not fight you because of religion and do not expel you from your homes - from being righteous toward them and acting justly toward them. Indeed, Allah loves those who act justly."

This verse clearly establishes the principle of treating non-Muslim neighbours with righteousness (birr) and justice (qist), as long as they do not initiate hostility.

## THE CONSEQUENCES OF NEGLECTING NEIGHBOURLY RIGHTS:

The Prophet (peace and blessings be upon him) warned against the severe consequences of neglecting the rights of the neighbour.

He said:"He will not enter Paradise whose neighbour is not safe from his evil deeds." (Sahih Muslim)

This is a grave warning, highlighting the seriousness with which Islam views the transgression of neighbourly rights. It indicates that neglecting these obligations can have dire consequences in the Hereafter.

Furthermore, strained neighbourly relations can lead to social fragmentation, mistrust, and conflict within the community. A society where neighbours are at odds with each other is a weak and unstable society, lacking the essential bonds of cooperation and mutual support that Islam seeks to cultivate.

## THE IMPORTANCE OF PROACTIVE ENGAGEMENT:

Fulfilling the rights of the neighbour is not merely about avoiding harm; it also involves proactive engagement in fostering positive relationships. This includes taking the initiative to greet them, offering help when needed, and showing genuine interest in their well-being.

The Prophet (peace and blessings be upon him) encouraged visiting the sick, attending funerals, and sharing in the joys and sorrows of our neighbours. These acts of kindness and compassion strengthen the bonds of community and create a supportive environment for all.

PRACTICAL STEPS TOWARDS BETTER NEIGHBOURLY RELA-TIONS: How can we, as individuals and as a community, improve our neighbourly relations and fulfill our Islamic obligations? Here are some practical steps:

**BE MINDFUL OF NOISE LEVELS:** Avoid loud music, excessive construction noise, or any other disturbances that might affect your neighbours, especially during rest hours.

MAINTAIN THE CLEANLINESS OF YOUR SURROUNDINGS: Ensure that your property is clean and does not negatively impact the cleanliness or aesthetics of the neighbourhood.

**BE CONSIDERATE WITH PARK- ING:** Avoid blocking driveways or parking in a way that inconveniences your neighbours.

**OFFER** ASSISTANCE WHEN NEEDED: Be observant of your neighbours' needs, especially the elderly, the sick, or those with young children, and offer help when appropriate.

**RESOLVE DISPUTES PEACEFUL- LY:** If disagreements arise, strive to resolve them amicably through dialogue and understanding, rather than resorting to confrontation or aggression.

Those who once wrote unpalatable stories about him and dismissed him with benign remarks have since eaten their words. His popularity has soared not just because of his title, but because of the visible impact he is making in the lives of the people.

The PDP, lame and decrepit under Godwin Obaseki, continues to nurse its wounds. Lamenting both their electoral and tribunal defeats, they persist in delusion. Their candidate, Asue Ighodalo, is being misled to believe he can still secure what he failed to win at the polls—through the back door.

In a desperate bid to remain relevant, the PDP has assembled a handful of its idle loyalists into a so-called response team, feeding the public propaganda under the slogan "Joy is

coming." But Edo people are already experiencing joy under Okpebholo's administration, not waiting for a distant promise.

Following the tribunal's judgement, Ighodalo appeared deflated, yet tried to maintain a composed facade. But his defeated expression mirrored the loss he had just endured. He longed for a victory he failed to earn at the polls, but Edo voters had already made their choice—Okpebholo, wholly and decisively.

Governor Okpebholo has become the PDP's nightmare. In just a short period, he has embarked on projects that PDP failed to deliver in eight years. From flyovers and school renovations to job creation and road construction, he is rewriting the state's story—one previously tainted by Obaseki's draconian governance.

## US-Somali airstrike as battle rages for key town

carried out an airstrike against Islamist militants during a battle for control of a strategic central town, the government says.

The "well-coordinated" strike on Adan Yabaal, north of the capital Mogadishu, came hours after al-Shabab raided the town which is used as a key launchpad for military operations.

Among the 12 militants

The US and Somalia have killed in the airstrike were several senior fighters from the al-Qaeda-linked group, the Somali information ministry said in a statement on X.

> The latest fighting comes amid fears of a jihadist resurgence in Somalia after growing militant attacks, including one that targeted President Hassan Sheikh Mohamud's convoy last month.

> Al-Shabab, which controls large parts of southern and

central Somalia, has been fighting the government for nearly 20 years. It seeks to overthrow the federal government and establish an Islamist state.

The African Union-led peacekeeping force helped push the jihadists onto the defensive in 2022 and 2023, but the group remains a big threat despite numerous military operations against it.

The Somali government insists the group has been weakened.

The airstrike late on Wednesday by Somali armed forces and the US Africa Command (Africom) "aimed to neutralize the threat posed" by militants, the information ministry said.

"The targeted strike hit a site used by the militants as a gathering and hideout," it said, adding: "Importantly there were no civilian casualties."

Adan Yabaal, in the Middle Shabelle region, was seized by al-Shabab in 2016 before being recaptured by government forces in 2022.

Heavy fighting broke out early on Wednesday after al-Shabab fighters raided the town, using heavy explosives.

Later the group said it had captured the town. Two local residents told AFP news agency that militants had taken control of Adan Yabaal.

The government did not say vho was currently in control of

President Hassan Sheikh Mohamud visited the town last

month and met military commanders, underscoring its strategic significance in the fight against the militants.

In a separate incident, the national army said it killed at least 35 fighters near the city of Baidoa on Thursday, after they attempted to attack an army base there, the ministry said.

President Mohamud has downplayed the al-Shabab advances, saying that occasional battlefield setbacks were inevitable. He has maintained that his government was determined to defeat the militants.

Al-Shabab has in recent months regrouped and launched a series of counter-attacks (file photo).

## Ex-Russian general jailed for seven years over bribes

former top Russian general has been jailed \_for seven years after being accused of taking bribes.

Lt Gen Vadim Shamarin was arrested last year during a crackdown on corruption in the defence ministry launched by the Kremlin, and was accused of taking "a particularly large bribe" from a telecommunications company.

Russia's Investigative Committee said he took bribes worth 36 million roubles (£331,000) between 2019 and 2023 from a factory that produces communications equipment - and, in return, increased the size of state contracts awarded to the company.

Prior to his arrest he had served as deputy chief of the army's general staff overseeing the signals corps and military communications.

Russia's Tass news agency quoted Shamarin's lawyer as saying: "In total, Shamarin was sentenced to seven years in a maximum security penal colony, a seven-year ban on public service, and was stripped of his military rank."

The court also confiscated 36 million roubles from him, the RIA Novosti news agency reported.

Shamarin was among several senior defence ministry figures who were detained last year, which also included deputy defence minister Timur Ivanov and Lt Gen Yuri Kuznetsov,

head of the defence ministry's personnel directorate.

It came after Russian President Vladimir Putin dismissed his long-term Defence Minister Sergei Shoigu in May 2024.

He was replaced by Andrei Belousov, an economist with little military experience.

Experts suggested that the corruption crackdown marked an attempt by the Kremlin to boost efficiency in the Russian military.

### US to hold talks on Ukraine with European allies

onald Trump's special envoy Steve Witkoff and top diplomat Marco Rubio were due to hold talks with European counterparts in Paris later on Thursday to discuss efforts to end the war in Ukraine.

Ukraine's foreign minister and defence minister have arrived in the French capital to take part in the discussions.

The talks, hosted by French President Emmanuel Macron, form the highest level of transatlantic engagement about the war since February.

European diplomats have said they will urge the US to put more pressure on Russia to agree an unconditional ceasefire.

"We want the US to use a bit more stick," one official said.

Ongoing efforts to secure a ceasefire come days after a Russian missile attack killed at least 35 people and injured 117 in the Ukrainian city of Sumy.

Earlier this month, at least 18 people died in a strike on a residential area in Kryvyi Rih.

Overnight on Wednesday, Ukrainian authorities said a Russian drone attack on the city of Dnipro killed three people, including a young girl.

US Secretary of State Mar-

co Rubio and Witkoff will join meetings at the Elysée Palace attended by Macron, the UK's national security advisor Jonathan Powell, as well as other European national security advisers.

There will also be a separate meeting of foreign ministers, which UK Foreign Secretary David Lammy is expected to attend.

The US State Department said the focus would be on how to end the fighting in Ukraine, and that Witkoff would report on his meeting with Russian President Vladimir Putin last week.

Ukrainian President Volodymyr Zelensky's chief of staff Andriy Yermak said "we are working on important issues for the security of Ukraine and the whole of Europe".

When asked about the talks, Kremlin spokesman Dmitry Peskov said European leaders were focussed on "continuing the war".

In May 2023, prior to returning to the White House, Trump said he would be able to settle the war between Russia and Ukraine "in 24 hours".

His administration has taken action to drastically improve relations with Moscow, while seeking to broker a ceasefire between Russia and Ukraine.

## French jails have come under attack are violent drug gangs to blame

fficially, all lines of enquiry are still open into a wave of arson and gun attacks at French prisons.

That means police haven't ruled out the extremist left, or a foreign power such as Russia or Algeria.

But the conviction is growing that the attacks - 12 since Sunday night - can only have been the work of drugs gangs, hitting back at the government's latest crackdown.

That is certainly the belief of the government itself.

Speaking on Thursday morning, Interior Minister Bruno Retailleau said he was "certain that what we're dealing with is the drugs-yobs [in French, narco-racaille]".

"It's not they who have declared war on us. It's we who declared war on them with our new law on drugs trafficking. They know we're going to be hitting their wallets."

In what was obviously a co-ordinated plan over three nights, gangs set fire to cars outside prisons and a prison officer training centre. In two locations, guns were used.

In many attacks, the perpetrators sprayed graffiti bearing the initials DDPF, which stands for Droits des Prisonniers Français - Rights for French Prison Inmates

The group was previously unheard of, but on Tuesday it posted a video on the messaging platform Telegram showing the burning of a prison officer's car.

In French that is full of mistakes, the video's text accuses Justice Minister Gérard Darmanin of declaring "war" on prisoners.

"All we want is that human rights be respected," the text reads. "If in 2025 we can watch TV, smoke and eat our meals without being bothered in our cells, it's only because our elders fought for these fundamental rights."

Presenting themselves as defenders of human rights may not be the usual methodology of drugs gangs.

But nor does the DDPF come across as a classic farleft or anarchist organisation, which might more naturally be fighting for the cause.

For one thing such tend to have intellectual underpinning which means they write grammatical and properly spelled French. Nor have farleft groups till now made prisoners' rights a particular issue.

Investigators have said that perpetrators of the attacks caught on video were dressed more like drugs-gang foot soldiers rather than far-left militants, who tend to come from a different social background.

And in one location they wrote the wrong set of initials -DDFM - suggesting that their attachment to the supposed organisation was not exactly deep.

The theory of foreign manipulation is taken seriously especially after proven cases of Russian interference such as the spraying of Stars of David in Paris after the October 7 attacks.

Relations with Algeria are lso at an all-time low at the moment.

But if the drugs gang theory is the favoured one, it is because means and motivation are both so easy to grasp.

The French government currently includes an unusual tandem: an interior and a justice minister who are not rivals; who are both on the political right; and who have pledged to fight head-on the scourge that they say is the drugs trade.

#### Colombia declares health emergency after dozens die of yellow fever olombia has declared free of charge.

nationwide health emergency after at least 34 people died of yellow fever, according to official figures.

Yellow fever is caused by a virus transmitted to humans by infected mosquitoes. It can be prevented by a vaccine which in most cases provides lifelong protection.

The government has urged people to get vaccinated ahead of the Easter weekend, a time el to warmer areas where the mosquitos that spread the disease are more prevalent.

Health Minister Guillermo Alfonso Jaramillo said those going to high-risk areas would be required to show proof of vaccination.

The health minister said that there had been 74 confirmed cases of yellow fever in Colombia so far during this outbreak and urged people to get the vaccine, which in Colombia is

The number of cases reported is much higher than in recent years.

In 2023, there were only two cases, and there were none from 2019 to 2022, according to figures published by the ministry of health.

Mr Jaramillo told Colombian radio station RCN that the current outbreak had been particularly lethal "with a mortality rate of nearly 50% among those infected".

Many of the yellow fever cases were clustered in the eastern part of Tolima province.

The area is known for its coffee plantations and beautiful landscapes and is popular with both national and international tourists.

Colombian President Gustavo Petro warned on social media that "people who have not been vaccinated should not go to high-risk areas during Easter: for now the coffee area".

## UK bans EU cheese and meat to stop disease spreading

The UK government has brought in a temporary ban on holidaymakers bringing in cheese and meat products from the EU in a bid to prevent the spread of foot and mouth disease (FMD).

Travellers have not been allowed to bring back items such as cured meat and cheese, including in sandwiches, since Saturday due to the growing outbreak on the continent.

The restrictions apply regardless of whether the goods are packed or packaged, or bought from duty free.

It follows an earlier ban of similar products from Germany, Hungary, Slovakia and Austria after rising cases of the cattle disease in those countries.

FMD is a highly infectious virus that causes blisters inside an animal's mouth and under their hooves, and can cause lameness and problems feeding.

It causes no risk to humans and there are currently no cases of footand-mouth disease in the UK.

Any products of animal origin, like meat and dairy, could potentially be contaminated with FMD.

There are concerns that if contaminated products enter the UK, even if they are designed for human consumption, there is a chance that they could be consumed by animals - for instance if they are thrown away in a way that could come into contact with foraging wildlife or domestic livestock.

The restrictions apply to people arriving in Great Britain, not Northern Ireland, Jersey, Guernsey, or the Isle of Man.

Products will be seized and destroyed if people try to bring them in, and in "serious cases" people could be fined up to

£5,000

The list of restricted products includes:

pork, beef, lamb, mutton, goat, venison, other products made from these meats, for example sausages, milk and dairy products like butter, cheese and yoghurt.

People can bring up to 2kg per person of powdered infant milk, infant food, or special food needed for medical reasons.

In 2001, an outbreak of FMD in the UK led to the culling of millions of animals. Although there were only 2,000 confirmed cases, more than six million sheep, cattle and pigs were slaughtered.

This is because each of those cases meant a farm having all of its livestock killed and burned.

The last outbreak of FMD in the UK was in 2007, although this was much smaller with only eight infected premises concentrated in one small area of the country.

Tom Bradshaw, the president of the National Farmers Union (NFU), said the government had been quick to bring in the initial ban and the NFU was glad it was now being extended.

"While the FMD source remains unidentified in parts of Europe, stricter border controls are essential." he said.

"It's imperative we have a comprehensive cross-government biosecurity plan with the necessary investment behind it, and which would place these restrictions on a permanent legislative footing."

The Guild of Fine Food, which represents independent food and drink retailers, said the ban on "holiday treats" had been "hurried", but added it brought UK government policy for holidaymakers more in line with restrictions already placed on small businesses.

### Tesla whistleblower wins latest legal battle in fight against Musk

Tesla whistleblower who has fought Elon Musk and his company through the courts for years has won the latest round of a long-running legal battle.

Engineer Cristina Balan lost her job after she raised a safety concern in 2014 about a design flaw which could affect the cars' braking.

Her defamation claim against the firm seemed to have run out of road when a judge confirmed an arbitration decision dismissing her case - but a panel of appeal judges in California has reversed this decision in her favour.

She told BBC News she now wants to face Elon Musk and Tesla in open court.

Tesla has not responded to a request for comment.

Ms Balan said she believes the case will now in effect go back to square one, and new proceedings can be launched.

"We are hoping we will start a new lawsuit and we will have the chance to take on Elon Musk in front of a jury and judge," she said.

The engineer was once so prominent at Tesla that her initials were engraved on the batteries inside Model S vehicles.

In an interview with BBC News last year, she said she is determined to prove her innocence for the sake of her son.

She also revealed she was in remission from stage-3B breast cancer, and her biggest worry was she may not live to see her final day in court.

Ms Balan claimed she was worried the carpets were curling underneath some pedals in Tesla models, creating a safety hazard.

She said managers rebuffed her concerns, became hostile, and she lost her job.

She then won a wrongful dismissal case - but this turned out to be the start of a long journey through the courts.

Ms Balan was publicly accused by Tesla of using its resources for a "secret project" - accusations which amount to embezzlement, a crime under US law.

She has consistently denied the accusation, and decided to bring a defamation case against the firm in 2019.

"I want to clear my name," she told BBC News last year.

"I wish Elon Musk had the decency to apologise."

A court then decided Ms Balan's case should be subject to arbitration per a contract she signed while working for Tesla.

The arbitrator found in favour of the firm and Musk, dismissing her claims, due to California's statute of limitations - meaning too much time had passed since the alleged defamatory statements were made.

Tesla brought the case back to

a district court in California to have the decision confirmed.

However, Ms Balan appealed this decision, and judges from the US Court of Appeals for the Ninth Circuit found in her favour - in effect deciding the California court did not have the jurisdiction to make its judgement.

They have ordered for the confirmation of the arbitration award to be cancelled, and for the district court to dismiss the action due to its lack of jurisdiction.

What could happen next?

The majority of legal experts the BBC has spoken to believe the case has some way to go before there will be any conclusion.

"Tesla is among the many corporations that force employees and customers into opaque arbitration processes and deploy aggressive strategies to retaliate against employees who voice criticism of corporate practices," said Stanford professor Anat Admati.

And Bill Moran, Ms Balan's attorney, agreed the legal process is far from over.

But he said the case was "revived" by the latest ruling.

"We are confident we can secure her either a new arbitration or alternatively a trial in court so that her case can be heard on the merits after so many years," he said.

## Trump administration threatens Harvard with foreign student ban

The US government has threatened to ban Harvard University from enrolling foreign students - after the institution said it would not bow to demands from President Donald Trump's administration and was hit with a funding freeze.

The White House has demanded the oldest university in the US make changes to hiring, admissions and teaching practices - to help fight antisemitism on campus.

Homeland Security Secretary Kristi Noem has asked for records on what she called the "illegal and violent" activities of its foreign student visa-holders.

Harvard earlier said it had taken many steps to address antisemitism, and that demands were an effort to regulate the university's "intellectual conditions".

"The university will not surrender its independence or relinquish its constitutional rights," Harvard President Alan Garber wrote in a message on Monday to the Harvard community.

The new request from Noem said the institution would lose the "privilege of enrolling foreign students" if it did not com-

ply with the demand for records.

Harvard said it was aware of the new request from Noem, which was made in a letter, the Reuters news agency reported.

International students make up more than 27% of Harvard's enrolment this year. Even before Noem's statement, billions of dollars hung in the balance for the university, after the freeze of some \$2.2 bn (£1.7bn) in federal funding.

Trump has also threatened to also remove Harvard's valuable tax exemption, the loss of which could cost Harvard millions of dollars each year. US media reports suggest the Internal Revenue Service (IRS) has started drawing up plans to enact this.

"Harvard can no longer be considered even a decent place of learning, and should not be considered on any list of the World's Great Universities or Colleges," Trump wrote on his Truth Social platform on Wednesday.

"Harvard is a JOKÉ, teaches Hate and Stupidity, and should no longer receive Federal Funds."

The administration's attacks on Harvard are not isolated. The government's antisemitism task force has identified at least 60 universities for review.

During his presidential campaign, Trump pitched a funding crackdown on universities, painting them as hostile to conservatives. He and Vice-President JD Vance have long railed against higher education institutions.

Polling by Gallup last year suggested that confidence in higher education had been falling over time among Americans of all political backgrounds, particularly Republicans - in part

due to a belief that universities push a political agenda.

Since taking office, Trump has focused particularly on universities where pro-Palestinian protests have taken place. Some Jewish students have said they felt unsafe and faced harassment on campus.

In March, Columbia Ûniversity agreed to several of the administration's demands, after \$400m in federal funding was pulled over accusations the university failed to fight antisemitism.

### What to know as Menendez brothers ask for freedom in resentencing hearing

fter decades spent in prison by Erik and Lyle Menendez - and months of contentious court fights - a judge will hear arguments on whether the brothers should be resentenced, in a murder case that still divides America.

The pair are serving life in prison for killing their parents, Kitty and Jose Menendez, in 1989, when they were 21 and 18. Their case gained renewed attention after a popular Netflix series last year.

Thursday's resentencing hearing will determine whether the pair should be resentenced to a lesser penalty. If approved, the brothers could become eligible for parole - potentially allowing their freedom.

Prosecutors at the time argued Erik and Lyle meticulously planned the killings so they could access their parents' fortune. The current Los Angeles District Attorney says the brothers have continued to cling to lies about the case.

But the brothers' lawyers have long argued the killings were an act of self-defence and claimed their father abused them for years. They have also pointed to court filings detailing their rehabilitation during their years behind bars.

Here is what to expect from

the hearing - and a recap of how we got here.

What did the Menendez brothers do?

The brothers shot and killed their parents with shotguns at their Beverly Hills mansion. There has long been a debate over their motive.

Prosecutors painted them during their trials as spoiled rich kids who wanted to access their parents' \$14m (£10.7m) fortune. They argued that the duo methodically bought shotguns and opened fire on their parents 13 times as the couple watched TV - before going gambling, to parties and on shopping sprees.

The brothers ultimately ad-

mitted to the killings - but argued they acted out of self-defence after years of emotional, physical and sexual abuse by their father Jose, a high-powered record label executive.

The brothers' trial in 1993 was one of the first high-profile murder cases to be shown live on television, gripping audiences in the US and globally.

It ended deadlocked, but in 1996, the brothers were convicted of first-degree murder in a second trial during which the judge barred many of their claims of sexual abuse. They are imprisoned near San Diego.

oncerned by the poor media report of the forthcoming National Sports Festival, the Sports Writers Association of Nigeria (SWAN), Ogun State chapter has warned the state government and the Local Organizing Committee of the festival not to deviate from established standards that place premium value on media involvement in sports development.

The association noted that activities of the National Sports Festival are under reported in the media, thus creating communication gap within the social media space and the general public.

This was contained in a communiqué issued at the end of its congress held on Wednesday, April 16, 2025, at the SWAN Secretariat within the MKO Abiola Stadium, Kuto, Abeokuta.

According to the communiqué jointly signed by SWAN Chairman, Michael-Azeez Ogunsiji, Secretary, Segun Folarin, and members of the communiqué drafting committee — Daud Olatunji (Chairman), Yetunde Fatun-

n a bid to enhance the



gase (Secretary), and Babajide Adewunmi (Member) - the congress emphasized that modern media facilities are crucial to sustaining quality coverage of sporting events beyond the festival.

The congress also commended the recent upgrade of the MKO Abiola International Stadium but expressed concern over critical infrastructural deficit within the stadium that requires urgent attention.

These include dilapidated dressing rooms, the absence of a proper medical bay, and the lack of a designated media gallery.

SWAN also expressed dismay

over the non-inclusion of a media centre in the current upgrade plan for the stadium, stressing that such a facility would benefit journalists and serve as a lasting legacy of the games.

Ogun SWAN equally applauded the state government for its infrastructural contributions towards the successful hosting of the upcoming National Sports Festival.

The association lauded the provision of world-class sporting facilities across the state, singling out the new swimming pool as a notable highlight.

It urged authorities to address outstanding facility gaps, particularly at the MKO Abiola International Stadium.

On the fate of the MKO Abiola Stadium after the festival, the congress advised the state government against plans to concession the facility. Instead. it called for the stadium to remain accessible to the public, noting its role in talent discovery and grassroots sports promotion, urging the government to put in place proper maintenance mechanisms.

While pledging a warm and supportive environment for all journalists covering the festival, the association also appealed to the government to include the SWAN Secretariat, situated within the stadium complex, in the ongoing reconstruction works to improve its standard and functionality.

The congress further urged the government to revisit the abandoned multi-million-dollar FIFA Goal Project located within the stadium premises.

The association noted that the project, fully funded by FIFA and implemented in other states, only requires land allocation by the state to commence.

iego Maradona's death would have been avoided" if the medical team around him had done their job, his daughter Dalma accused on Tuesday at the trial of health professionals of the circumstances of the death of the Argentine football idol

Dalma, 38, the elder of Maradona's two daughters with his ex-wife Claudia Villafañe, was a star witness on the 11th day of the trial in San Isidro (north of Buenos Aires). And like others since the start of the trial, she blamed the caregivers of her father's final weeks and the framework of his convalescence.

"If they had done their job, (his death) would have been avoided," Dalma said, referring to the medical team and in particular to three of the accused: attending physician and neurosurgeon Leopoldo Luque, psychiatrist Agustina Cosachov and psychologist Carlos Diaz.

"They deceived us (the fam-

ily) in the most cruel way (...) They made us believe that the only possible option was to convalesce at home after his operation, in a house that was rented for the occasion in Tigre (north of Buenos Aires)," Dalma said.

According to them, " it would be a serious home hospitalisation," Diego would have everything like in a clinic, but in a house," with 24/7 medical attention, medical equipment, an ambulance at the door permanently, she continued.

"It never happened," she said in a statement often interrupted by tears. In this "disgusting, piss-smelling " house, a doctor only came to see him from time to time."

Maradona died at the age of 60 on November 25, 2020, from a cardiorespiratory crisis complicated by pulmonary oedema, in this private residence, where he had been convalescing for two weeks after neurosurgery for a head hematoma.

### NSC, National Council on sports approves fixed calendar for National Sports Festival, streamlines number of sports to 32

operational effectiveness and overall performance of Nigerian athletes, the National Sports Commission's (NSC) memorandum towards a fixed period for the National Sports Festival (NSF), as well as an affirmation of the Rules to streamline the number of sports at the Festival has been approved by the National Council on Sports.

The both memoranda were presented at the Extraordinary National Council of Sports meeting, that took place on Wednesday in Abeokuta, Ogun State and were approved accordingly.

In a communique signed by the Director General of the NSC, Hon. Bukola Olopade, it noted that the Council gave its approval for the National Sports Festival to be held between November and December of the Festival year.

The decision was reached in order to align with international best practices, as it is essential to maintain a stable and predictable sports calendar for our traditional national competitions such as the National Sports Festival.

A fixed period for the NSF would improve organization, participant engagement, financial and logistical efficiency, and marketing and sponsorship opportunities of the NSF.

The Communique also stated that the Council reaffirmed its decision on Rule 11 (i), (ii), and (iii) of the 2024 National Sports Festival General Rules and Regulations, as reached at the Extraordinary Council Meeting held in Benin City, Edo State on Thursday, March 14, 2019.

The Rule 11(i) stated that a maximum of 32 sports shall feature at the Festival (27 compulsory and 5 optional).

Rule 11(ii) affirmed that the compulsory sports were selected based on their popularity in the 36 states, including the FCT, State entries in the sports in previous Festivals, and the standard of Nigeria's participation in the sport at the international level.



Rule 11(iii) stated that the Host State is at liberty to select a maximum of 5 sports out of the 25 optional sports to make up the 32 sports to feature ag the Festival.

This move will help stabilize the number of sports at the multisports event, to mitigate irregular changes that may affect management and organization of the Games.

### Arsenal knock out Madrid from UEFA Champions League, to face PSG in semi-final





In a frenetic first half, Saka saw a Panenka penalty saved by Thibaut Courtois while VAR intervened at the other end to deny Real Madrid a spot kick of their own.

Arsenal will now face Paris Saint Germain (PSG) in the semi-final, while Inter Milan battle Barcelona in the last four.









## Silencing dissent: The threat of repressive media laws in Nigeria

'n what appears to be yet another attempt to curtail the freedom of expression in Nigeria, the Nigerian Senate is currently considering a bill aimed at regulating the activities of bloggers in the country.

This legislative move has drawn widespread condemnation from various quarters, particularly from the Socio-Economic Rights and Accountability Project (SERAP), a leading civil society organisation known for its dogged pursuit of transparency, accountability, and human rights.

SERAP has openly urged the Senate to withdraw the controversial bill, warning that it poses a grave threat to press freedom and could easily become a tool for muzzling dissenting voices in the country. This intervention is not only timely but necessary, especially in a nation that purports to operate a democratic system of government.

This repressive bill is another attempt to gag the press, akin to the controversial suspension of Twitter (now X) some years ago. In June 2021 precisely, the administration of former Nigerian President Muhammadu Buhari made global headlines by announcing the suspension of Twitter operations in Nigeria. The ban followed the platform's deletion of a tweet by the president that was considered to have violated Twitter's

The government swiftly accused Twitter of allowing content that threatened Nigeria's corporate existence and used national security as justification for its action. However, critics quickly saw through the veil, interpreting the move as a direct assault on freedom of expression and press freedom in Nigeria.

The Twitter ban was not just about a deleted tweet; it symbolised the government's broader discomfort with unfiltered public discourse on social media platforms. By cutting off access to a major platform for political commentary, activism, and journalism, the Buhari administration sent a clear message: dissent would not be tolerated.

The government's high-handedness set a dangerous precedent that emboldened further efforts to control the digital space and silence alternative voices.

This clampdown on digital freedoms mirrors the current attempt by the Nigerian Senate to pass a bill aimed at regulating bloggers. Like the Twitter ban, the bill is couched in the language of national interest and public safety, yet its underlying motive appears to be the suppression of free speech and independent thought. Both instances highlight the Nigerian political elite's growing aversion to accountability and criticism in the pub-

Bloggers, like Twitter (X) users, play a critical role in disseminating information, uncovering corruption, and giving voice to ordinary Nigerians. Attempts to regulate or silence them through vague and punitive legislation constitute a direct attack on press freedom. The proposed blogger regulation bill, if passed, would legitimise state surveillance and censorship of online activities under the guise of

What unites these two events — the Twitter ban and the blogger bill, is the state's desire to monopolise narrative control and limit the influence of non-traditional media. In a democratic society, such authoritarian tendencies are not only unacceptable but dangerous. The rise of citizen journalism and online platforms has decentralised information and put power back in the hands of the people - a reality that some in power find threatening.

The Twitter ban and the anti-blogger's bill reflect a broader strategy of gagging the press and shrinking the civic space in Nigeria. It is vital for civil society, the media, and the general public to resist such repressive moves and demand a governance model that respects and protects freedom of expression in all its forms.

A closer examination of the bill, its possible implications, and the reactions it has elicited, underscores a broader pattern of despotic legislation that seeks to undermine freedom of speech and suppress the media under the guise of regulation.

The proposed bill, while still in its early stages, allegedly seeks to establish guidelines for bloggers, including mandatory registration, licensing, and compliance with undefined standards of practice. Supporters of the bill argue that it is a response to the proliferation of fake news, cyberbullying, and unverified information often published on digital platforms.

However, critics assert that these concerns, though legitimate, are being used as a pretext to clamp down on independent voices and alternative

One of the most alarming features of the bill is its vague and overly broad language, which leaves room for arbitrary interpretation. Terms such as 'offensive content,' 'fake news,' and 'unauthorised information' are left undefined, creating a fertile ground

In a country where critical journalism and whistle-blowing have already put many at risk, this bill represents a veiled threat to those who dare to

SERAP has taken a bold stand against the bill, urging lawmakers to resist the temptation of prioritising political interests over democratic values. According to the organisation, the bill, if passed into law, would erode the gains Nigeria has made in promoting freedom of information and media pluralism. It warns that this bill is an affront to both Section 39 of the 1999 Constitution, which guarantees freedom of expression, and Article 19 of the Universal Declaration of Human Rights, which Nigeria is a signatory to.

In a recent statement, SERAP noted: "Rather than attempting to gag bloggers and online media, the Senate should be focusing on ensuring access to information, promoting transparency, and holding public officers accountable." This encapsulates the crux of the matter.

The government should not be in the business of silencing voices, especially in an era where digital platforms have become vital for civic engagement, journalistic investigation, and public discourse.

If the bill is allowed to pass, the chilling effect on media freedom will be enormous. Nigeria already has a turbulent relationship with press freedom. Journalists and bloggers are frequently harassed, detained, and sometimes charged with trumped-up accusations of sedition, cybercrime, or defamation.

In the developed world, particularly in the United States, former President Thomas Jefferson once echoed a profound sentiment, that he would prefer a nation without a military to one without a free press. This powerful assertion underscores the indispensable role of the press in safeguarding democracy and promoting an informed

Regulating bloggers and gagging the press through a draconian legal framework would further underdevelop Nigeria and entrench fear and self-censorship among digital content

Blogging, for many, is not just a pastime; it is a means of livelihood, a channel for activism, and a way of amplifying the voices of the voiceless. Imposing restrictions, licensing fees, and penalties on bloggers could marginalise critical perspectives and tilt the information ecosystem in favour of state-sponsored narratives.

In a democracy, the role of the media - whether mainstream or digital cannot be overstated. They serve as a watchdog, a platform for citizen engagement, and a mirror reflecting society's ills. Silencing bloggers is tantamount to dimming the torch of truth and weakening the pillar of ac-

This is not the first time Nigeria has flirted with repressive digital legislation. In 2015, the infamous Frivolous Petitions Bill, commonly referred to as the "Anti-Social Media Bill," was introduced but subsequently thrown out following widespread backlash. Again in 2019, there was the Protection from Internet Falsehood and Manipulations Bill, which sought to criminalise the spread of 'false information'. It too met stiff opposition and was eventually shelved.

The recurrence of such proposals suggests a persistent desire by some lawmakers to control the digital space and stifle dissent. This is deeply troubling in a country with an already fragile civic space and where critical voices are often targeted by the state.

One of the defining features of any functional democracy is the freedom of expression. It is the oxygen that sustains vibrant debates, fosters citizen participation, and holds leaders accountable. Curtailing this freedom under the guise of regulation is both disingenuous and dangerous.

While it is true that misinformation and cyber abuse are real concerns, the solution does not lie in blanket restrictions or the criminalisation of digital expression. What Nigeria needs is a balanced approach that encourages responsible online conduct without trampling on constitutionally protected rights.

Digital literacy campaigns, fact-checking initiatives, and transparent self-regulatory frameworks by content creators themselves are more sustainable and democratic means of addressing the challenges of the dig-

A regulation aimed at bloggers today could be extended tomorrow to social media users, influencers, online journalists, podcasters, and even ordinary citizens with strong opinions. This creeping authoritarianism must be checked before it crystallises into law and becomes the norm.

The digital age has democratised information. No longer is the power of the press confined to traditional, regimented newsrooms. Ordinary Nigerians now wield influence through their phones and laptops, using blogs and social media to spotlight issues that would otherwise remain hidden. The digital media (blogs, social media platforms, podcasts) disseminate what the traditional or conventional media (newspaper, radio, television) forbid to do owing to supervisory and regulatory constraints. This empowerment must not be taken away under

Nigerians must not remain silent in the face of such legislative overreach.

Civil society organisations, professional bodies, the media, and indeed all lovers of democracy should rise up to demand the withdrawal of this bill.

Already, the Nigerian Union of Journalists (NUJ), the Nigerian Guild of Editors (NGE), and numerous legal professionals have voiced their concerns. Public opinion, when galvanised, has the power to reverse harmful policies. The same way the Anti-Social Media Bill was defeated through public resistance, so too can this current attempt be thwarted.

Rather than attempting to regulate bloggers through punitive laws, the Nigerian Senate should focus on legislation that improves digital infrastructure, protects journalists, enhances access to information, and promotes ethical standards in media practice. These are the building blocks of a truly democratic society.

The government must also invest in media literacy programmes to equip citizens with the skills needed to discern fact from fiction online. Empowering the public to think critically is far more effective than censorship in combating the spread of misinforma-

Additionally, laws like the Freedom of Information Act should be strengthened and fully implemented to ensure transparency in governance. A society where public information is easily accessible leaves less room for speculation, conspiracy, or misinfor-

The attempt to regulate bloggers is not just about legislation; it is about the soul of Nigerian democracy. If this bill passes, it will open the floodgates to more authoritarian laws, and the consequences could be dire for press freedom, civic space, and democratic development.

In times like these, silence is not neutrality; it is complicity. We must speak out, stand up, and push back against any law that seeks to gag the media. As SERAP has rightly pointed out, "A free press is not a threat to democracy; it is its lifeblood."

Let the Senate be reminded that democracy thrives where voices are heard, not hushed.
